

TERMS AND CONDITIONS OF THE UOB JCB DOUBLE SMART\$ REBATE PROGRAMME

1. DEFINITIONS AND INTERPRETATIONS

In these Terms and Conditions, unless the context otherwise requires, the following expressions shall have the following meaning:

- 1.1. **“Bank”** means United Overseas Bank Limited.
- 1.2. **“Card Transaction”** means a payment for goods or services made using a UOB JCB Platinum Card.
- 1.3. **“UOB JCB Cardmember”** means the person whose name is printed on any of the UOB JCB Platinum Cards.
- 1.4. **“SMART\$ Merchant”** means an establishment participating in the UOB SMART\$ Rebates Programme.
- 1.5. **“UOB JCB Double SMART\$ Terms and Conditions”** means these terms and conditions governing the UOB JCB Double SMART\$ Rebate Programme.
- 1.6. **“UOB JCB Programme”** means this UOB JCB Double SMART\$ Rebate Programme.
- 1.7. **“UOB SMART\$ Rebate Programme”** is the Programme offered pursuant to the Terms and Conditions Governing the UOB SMART\$ Rebate Programme.

2. ELIGIBILITY

UOB JCB Programme is applicable to the principal and supplementary cardholders of UOB JCB Platinum Card issued in Singapore which are valid and subsisting (**“Eligible Cardmembers”**). For the avoidance of doubt, the UOB JCB Programme is not applicable to any other cards issued by the Bank.

3. ISSUE OF UOB JCB Double SMART\$

- 3.1 Eligible Cardmembers will earn double the amount of SMART\$ usually offered under the UOB SMART\$ Rebate Programme for every retail purchase charged to their UOB JCB Platinum Cards at SMART\$ Merchants that accept UOB JCB Platinum Cards.
- 3.2 UNI\$/Cash Rebate will not be awarded on Card Transactions at SMART\$ merchants where SMART\$ are issued.

4. GENERAL CONDITIONS

- 4.1 The UOB JCB Double SMART\$ Terms and Conditions shall be read in conjunction with the Terms and Conditions Governing the UOB SMART\$ Rebate Programme.
- 4.2 In the event of any inconsistency between the UOB JCB Double SMART\$ Terms and Conditions and any advertising, promotional, publicity, brochure, marketing or other materials relating to or in connection with the UOB JCB Programme, the UOB JCB Double SMART\$ Terms and Conditions shall prevail.
- 4.3 The Bank reserves the right at any time, and from time to time in its sole and absolute discretion to amend, vary, add or delete these terms and conditions or even terminating this UOB JCB Double SMART\$ Rebate Programme without giving any reason or prior notice or assuming any liability to any UOB Cardmember and all UOB Cardmembers shall be bound by these amendments.
