UOB "Additional 2% Cash Rebate" Promotion Terms and Conditions



- The United Overseas Bank Limited's ("UOB") "Additional 2% Cash Rebate" promotion (the "Promotion") is open to all Cardmember(s) (as defined under paragraph 2 below) during the Promotional Period (as defined under paragraph 3 below). Without limiting the generality of Paragraph 1, the following Cardmember(s) shall not be eligible for the Promotion:
 - (a) Cardmember(s) whose Eligible Card account(s) is/are voluntarily or involuntarily suspended, cancelled, closed or terminated anytime during the Promotional Period and for the avoidance of doubt, termination of a supplementary Cardmember(s)'s Eligible Card account(s) will not by itself disqualify the applicable principal Cardmember(s) from the Promotion.
 - (b) Cardmember(s) whose Eligible Card account(s) is/are not active, valid, subsisting or in good standing or which are otherwise determined by UOB as being delinquent or unsatisfactorily conducted for any reasons as may be determined by UOB at its discretion;
 - (c) those who are mentally unsound, facing legal incapacity or is incapable of handling their affairs, deceased, insolvent, bankrupt or have any legal proceedings (or any threat) of any nature instituted against them; or
 - (d) who UOB may decide to exclude, at its discretion, without prior notice at any time during the Promotional Period.
- 2. The following terms shall have the following meanings:
 - (a) "Cardmember(s)" shall mean any existing and new principal and supplementary holders of the Eligible Card, whose card account(s) is/are valid, subsisting, in good standing and satisfactorily conducted as determined by UOB in its discretion.
 - (b) "Eliqible Card" shall mean UOB One Card Visa Credit Card issued by UOB in Singapore.
 - (c) "Excluded Transactions" shall mean cash advances, annual fees, cash advance fees, late fees, reversals, interest and any finance charges made by the Cardmember(s) using the Eligible Cards and UOB reserves the right, at any time at its discretion, to amend or vary this list without prior notification and all Cardmember(s) shall be bound by these amendments or variations.
 - (d) "Overseas Spend" shall mean overseas credit card transaction(s) (excluding card-not-present transactions such as online transactions, mall/phone order and overseas transactions effected in Singapore dollars) which are successfully carried out on and charged to the Eligible Card of the Cardmember(s) during the Promotional Period and which are successfully captured/posted on UOB's systems during the Promotional Period BUT shall exclude the Excluded Transactions and any other transactions excluded pursuant to the UOB One Visa Credit Card Terms and Conditions ("Main Terms") For the avoidance of doubt, the benefit of all Overseas Spend incurred by a supplementary Cardmember(s) in respect of the Promotion shall accrue to the applicable principal Cardmember(s) only.
- The Promotion shall be for a period ("Promotional Period") commencing from 25 March 2013 onwards until such time UOB notifies otherwise.
- 4. In addition to the quarterly cash rebate presently offered to each Cardmember(s) under the Main Terms, each Cardmember(s) shall be entitled to earn additional two per cent (2%) cash rebate ("Bonus Rebates") on any Overseas Spend made during the Promotional Period using the Eligible Card. For the avoidance of doubt, the benefit of all Overseas Spend incurred by a supplementary Cardmember(s) in respect of the Promotion shall accrue to the applicable principal Cardmember(s) only. For the purpose of the Promotion, Overseas Spend shall be capped to a maximum total sum of an equivalent of SGD5,000.00 in foreign currency per calendar year
- 5. UOB shall not be responsible or liable:
 - (a) for any failure or delay in the transmission or receipt of evidence of sale transactions by MasterCard/visa/Unionpay/JCB/CUP/American Express acquiring merchants, merchant establishments, VISA International Incorporated, postal or telecommunication authorities or any other parties which may result in a charge incurred or made by the Cardmember(s) being omitted from being posted to the Cardmember(s)'s account and/or captured in UOB's system during the Promotional Period:
 - (b) for any late posting of the Overseas Spend or for any failure in the Overseas Spend being transacted by the Eligible Cards or being captured in UOB's system;
 - (c) for any notice or communication which gets lost, misplaced, defaced, tampered with, stolen, damaged or misdirected in the post; or
 - (d) for any breakdown or malfunction in any computer system or equipment.

- 6. (a) Participation in the Promotion is subject to the terms and conditions of the Promotion. For the purposes of the Promotion and with the exception of Paragraphs 2.4, 2.6 and 2.7 of the Main Terms, the terms under the Main Terms which apply to the "Quarterly Cash Rebate" (as set out in the Main Terms) shall similarly apply to the Bonus Rebate.
 - (b) The terms and conditions of the Promotion herein are supplemental to the Main Terms (with the exception of Paragraphs 2.4, 2.6 and 2.7 of the Main Terms and to the UOB Cardmembers Agreement (the Main Terms and the UOB Cardmembers Agreement shall be referred to collectively as the "Standard Terms"). Please visit uob.com.sg for the Standard Terms. In the event of any inconsistency between the terms and conditions of the Promotion and any of the Standard Terms, the terms and conditions of the Promotion shall prevail to the extent of such inconsistency.

In the event of any inconsistency or discrepancies:-

 - (b) the English version of these terms and conditions and the Chinese version of these terms and conditions, the English version of these terms and conditions shall prevail.
- 8. The Bonus Rebate (round off to the nearest 2 decimal places) earned will be credited to the relevant Eligible Card account on a monthly basis on the applicable statement date. The applicable Cardmember(s) shall earn the Bonus Rebate notwithstanding that such Cardmember(s) may not have earned any Quarterly Cash Rebate.
- UOB's decision on all matters relating to the Promotion shall be final, conclusive and binding
 on the Cardmember(s). UOB shall not be obliged to enter into any correspondence with any
 persons and no appeal, correspondence or claims will be entertained.

Notwithstanding anything in the terms and conditions of the Promotion, UOB reserves the right at any time and from time to time to amend, vary, revoke or terminate the Bonus Rebate or what amounts to being "Overseas Spend" or any of the governing terms in its absolute discretion with notice or to determine and/or amend, by adding to, subtracting from or varying of, any of the terms and conditions of the Promotion, including but not limited to, varying the Promotional Period, the eligibility terms and criteria, and the timing of any act to be done, without giving any prior notice or assuming any liability to any Cardmember(s), and all Cardmember(s) shall be bound by these amendments.
