**Terms and Conditions**

**1. Eligibility**

- 1.1 Subject to Clause 1.2, the Promotion is open to all eligible UOB VISA and MasterCard credit card ("Credit Card") Principal Cardmembers whose cards are issued in Singapore and whose accounts are valid, subsisting and in good standing as may be determined by United Overseas Bank Limited ("UOB") at its sole and absolute discretion (collectively "Eligible Cardmembers" or each an "Eligible Cardmember").
- 1.2 The followings are not eligible to take part in the Promotion:
- 1.2.1 Directors and employees of UOB and their respective immediate family members;
  - 1.2.2 Employees or staff of UOB's partners, advertising, promotion agencies and any other persons involved in organizing, promoting and/or conducting the Promotion;

  - 1.2.8 Persons below the age of 16 years as at the relevant Draw Date.
- 1.3 For the avoidance of doubt:
- 1.3.1 The benefit of all charges incurred by a Supplementary Cardmember in respect of the Promotion shall accrue to the Eligible Cardmember; and
  - 1.3.2 Termination of a Supplementary Cardmember's account will not by itself disqualify the Eligible Cardmember from the Promotion.

**2. Promotion Period**

**3. The mechanics of the Promotion and the Prizes**

- 7.3 In the event of any inconsistency between these Terms and Conditions and any advertising, promotional, publicity and other materials relating to or in connection with the Promotion, these Terms and Conditions shall prevail.
- 7.4 Eligible Cardmembers' will be subject accordingly to the terms and conditions of UOB Cardmember Agreement.
- 7.5 All information is correct at the time of publishing and UOB makes no representation or warranty whether express or implied, and accepts no responsibility or liability for its completeness or accuracy.

- 7.6 A person who is not a party to any agreement governed by these Terms and Conditions shall have no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B) of Singapore to enforce or enjoy the benefit any term herein.
- 7.7 These Terms and Conditions shall be governed by the laws of the Republic of Singapore, and all Eligible Cardmembers who participate in the Promotion shall be deemed to have agreed to submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
