

## Terms and Conditions Governing Top-Up at General Ticketing Machines with UOB Cards 2016 Promotion (“Terms and Conditions”)

1. This “Top-Up at General Ticketing Machines with UOB Cards 2016” Promotion (the “**Promotion**”) is only valid between 1 July 2016 and 31 December 2016, both dates inclusive (“**Promotion Period**”).

2. This Promotion is only applicable to all principal and supplementary holders of United Overseas Bank Limited (“**UOB**”) personal Visa or MasterCard credit or debit card issued in Singapore (“**Eligible Card**”), and whose Eligible Card account(s) is/are valid, subsisting, in good standing and satisfactorily conducted as determined by UOB in its sole and absolute discretion (“**Cardmembers**”). For the avoidance of doubt, “Eligible Card” excludes all UOB Corporate Card, UOB Empire World Business Card, UOB Gold Business Card, UOB Platinum Business Card, UOB Business Debit Card, UOB purchasing card and cards issued under UOB Central Travel accounts.

3. The first 20,000 UOB Visa Cardmembers and the first 20,000 UOB MasterCard Cardmembers (“**Eligible Cardmembers**”) to make/perform an Eligible Transaction (as defined below) at a General Ticketing Machine (“**GTM**”) at any Mass Rapid Transit (“**MRT**”) station with their Eligible Card during the Promotion Period will be eligible for the following one-time payment of cash rebate (“**Cash Rebate**”):-

- (i) S\$2.00 in respect of Eligible Transaction made/performed using Eligible Card via UOB Mighty Pay or Apple Pay; or
- (ii) S\$1.00 in respect of Eligible Transaction made/performed using Eligible Card in any other manner.

4. For the purposes of this Promotion, “**Eligible Transaction**” means transaction amounting to S\$40 per transaction made/performed at GTM at any MRT station and which are successfully charged to the Eligible Card account and captured/posted on UOB’s systems during the Promotion Period, and **excludes** (i) any transaction where payment is/was made via NETS; and/or (ii) fees, interests, other financial charges, and any transaction that was subsequently cancelled, voided or reversed for any reason.

5. The Cash Rebate is limited to **one (1)** per month per Eligible Cardmember, regardless of the number of Eligible Cards he/she has and the number of Eligible Transactions made/performed per month during the Promotion Period. For the avoidance of doubt, if Eligible Cardmember entitled to the Cash Rebate is a supplementary cardholder, the principal cardholder will not be entitled to any Cash Rebate for that same month notwithstanding that he/she has made/performed an Eligible Transaction and vice versa.

6. Cash Rebate earned by supplementary cardholder will be credited to the relevant qualifying Eligible Card account of the principal cardholder. The Cash Rebate will be credited to the Eligible Cardmember’s qualifying Eligible Card account within three (3) months after the end of the qualifying month or on such other date as UOB may decide on from time to time.

7. Where the qualifying Eligible Card is a credit card with outstanding debit balance, the Cash Rebate will be utilized at the next card statement of that qualifying Eligible Card of the Eligible Cardmember to offset any outstanding debit balance by a corresponding amount of the Cash Rebate.

8. UOB shall not be liable or responsible for (i) any failure or delay in transmission of Eligible Transaction by postal or telecommunication authorities which may result in a transaction being omitted during the Promotion Period; (ii) any late transaction postings affecting any Cardmember’s eligibility to qualify for this Promotion/the Cash Rebate; or (iii) for any breakdown or malfunction in any computer system or equipment.

9. UOB assumes no liability or responsibility and shall not be liable or responsible for any failure or delay in the Eligible Cardmember’s receipt of the Cash Rebate.

10. The Cash Rebate awarded shall be forfeited if the Eligible Cardmember's Card account is closed, terminated, cancelled or suspended prior to the credit of the Cash Rebate in the said account and the Eligible Cardmember shall not be entitled to any compensation or payment whatsoever.

11. If any Eligible Cardmember is subsequently discovered to be ineligible or not entitled to participate in the Promotion, UOB reserves the right to forfeit/reclaim the Cash Rebate and award or dispose of it in such manner and to such persons as UOB deems fit without any liability on the part of UOB to any persons. No payment or compensation whether in cash, credit or in kind shall be made by UOB for the forfeited/reclaimed Cash Rebate.

12. The Cash Rebate is not transferable or exchangeable in full or in part for credit, in kind or other goods and services. UOB reserves the right, at its discretion, at any time, without notice or assigning any reason thereof, to replace or substitute the Cash Rebate with any other gift of equal or similar value selected by UOB.

13. UOB's decisions on all matters relating to the Promotion shall be final, conclusive and binding on all parties. UOB shall not be obliged to give any reason or prior notice or enter into any correspondence with any person on any matter concerning the Promotion and no appeal, correspondence or claims will be entertained.

14. UOB reserves the right at any time and from time to time in its absolute discretion to vary, add, modify, delete any of these terms and conditions without prior notification or giving any reason, including but not limited to the discontinuation of the Promotion, the eligibility criteria, and all persons shall be bound by these amendments.

15. All the information provided herein is believed to be correct and reliable as the date of printing, UOB makes no representation or warranty whether express or implied, and accepts no responsibility or liability for its completeness or accuracy.

16. The prevailing terms and conditions under the UOB Cardmember Agreement ("Standard Terms") will continue to apply and be binding on Cardmembers. Cardmembers are deemed to have accepted the terms and conditions herein when they participate in the Promotion. In the event of any inconsistency between the terms and conditions herein and the Standard Terms, the terms and conditions shall prevail to the extent of such inconsistency.

17. These terms and conditions shall be governed by and construed in accordance with the laws of Singapore.

18. A person who is not a party to the terms and conditions herein and/or any agreement governed by the terms and conditions herein shall have no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any term of such agreement or any of the terms and conditions herein.
