

### **Terms and Conditions**

## For Uber Rides

- 1. "Uber Ride" refers to any vehicle or service type currently offered on the Uber mobile app in Singapore, which may include uberX, uberXL, UberExec, ExecLarge, VIP, UberPool and UberTaxi.
- 2. The discount only applies to the first two (2) Uber Rides completed by an Eligible Cardmember (as defined below) in Singapore ("Eligible Rides").
- 3. The maximum discount amount is capped at SGD\$10 per Eligible Ride ("Maximum Discount Per Ride").

### For UberEATs

- 4. "UberEATs Order" refers to any order of food and/or beverage in Singapore via the UberEATs mobile app.
- 5. The discount only applies to the first three (3) UberEATs Orders completed by an Eligible Cardmember (as defined below) in Singapore ("Eligible Orders").
- 6. The maximum discount amount is capped at SGD\$10 per Eligible Order ("Maximum Discount Per Order").

#### General

- 7. The discount is available to cardmembers of a UOB PRVI Miles American Express Credit Card issued in Singapore, whom have never previously completed an Uber Ride (as defined above) in any country (in the case of the discount on Uber Rides), or an UberEATs Order (as defined above) in any country (in the case of the discount on UberEATs Orders). The cards mentioned in the foregoing sentence shall be referred to as "Eligible Cards" and the holders of Eligible Cards shall be referred to as the "Eligible Cardmembers".
- 8. The promotion period is from 12:00 a.m. on 1 May 2017 to 11:59 p.m. on 31 October 2017 ("**Promotion Period**").
- 9. The promotion code, once entered into the Uber mobile app or the UberEATS mobile app, shall be valid for use from 12:00 a.m. on 1 May 2017 to 11:59 p.m. on 30 November 2017.
- 10. The promotion code will only be valid on the Uber mobile app, the UberEATs mobile app and Uber's website at www.uber.com. Promotion codes may not be supported on older versions of Uber's mobile apps.
- 11. The promotion code will not be valid on any third party applications that may enable users to book Uber Rides or place UberEATs Orders in Singapore.
- 12. Unless otherwise stated: (i) the discount for Uber Rides may not be used together with any other discount for Uber Rides that may be available in Singapore; and (ii) the discount for UberEATs may not be used together with any other discount for UberEATS that may be available in Singapore.
- 13. In the event that: (i) the fare of an Eligible Ride is less than the Maximum Discount Per Ride, or (ii) the amount of an Eligible Order is less than the Maximum Discount Per Order, there will be no refund or carrying over of the unused amount.
- 14. In the event that: (i) the fare of an Eligible Ride is more than the Maximum Discount Per Ride, or (ii) the amount of an Eligible Order is more than the Maximum Discount Per Order, the Eligible Cardmember shall bear the additional amount and pay with the Eligible Card that is registered in the Uber App or the UberEATs App, as the case may be.
- 15. The discount will be deemed fully redeemed once an Eligible Ride or Eligible Order has been completed.
- 16. In the event of cancellation of an Eligible Ride, cancellation fees and/or other applicable charges may apply. The Eligible Ride may be deemed completed and the discount may be applied against such fees and/or charges.
