Terms and Conditions for Metro Double Rebates April 2024 Campaign

1. Promotion

- 1.1. This Metro Double Rebates April 2024 Campaign (the "**Promotion**") is only valid from 24 April 2024 to 28 April 2024, both dates inclusive (the "**Promotion Period**").
- 1.2. By participating in this Promotion, you are deemed to agree to be bound by the terms and conditions of this Promotion (the "**Terms**").
- 1.3. This Promotion is open to individuals who are cardholders of a Metro-UOB Credit Card issued by United Overseas Bank Limited in Singapore (the "Eligible Card"), and whose Eligible Card account is valid, subsisting, in a good standing and satisfactorily conducted in the opinion of UOB at all times (each, an "Eligible Cardmember" or "you").
- 1.4. To participate in this Promotion, you must successfully charge a minimum spend of S\$350 nett to your Eligible Card in a single receipt in-store at Metro Paragon and/or Metro Causeway Point during the Promotion Period (the "In-Store Spend").
- 1.5. If you satisfy all of the requirements in Clause 1.4 of these Terms, you shall be eligible to earn a bonus 5% Metro\$ Rebate on you In-Store Spend (the "Bonus Metro\$ Rebate"), provided always that the maximum Bonus Metro\$ Rebate that you are eligible to earn shall be capped at 50 Metro\$ per Eligible Cardmember per day during the Promotion Period.
- 1.6. Bonus Metro\$ Rebates earned are reflected on Metro's charge slip. You can check your Metro\$ Rebates balance and expiry date via UOB Personal Internet Banking.

1.7. For the avoidance of doubt:

- 1.7.1. The supplementary cardholder's spending on the Eligible Card will not accrue to the principal holder of the Eligible Card, and vice versa. In other words, spending on the Eligible Card by the supplementary cardholder cannot be combined with spending by the principal cardholder of the Eligible Card for the purposes of qualifying for the In-Store Spend amount or computation of the Bonus Metro\$ Rebate.
- 1.7.2. This Promotion is not valid for purchase of Metro (Private) Limited ("**Metro**") Gift Vouchers, Metro Gift Cards and Metro Shoppers Cheques.
- 1.7.3. This Promotion is not valid for online spending via metro.com.sg.
- 1.7.4. This Promotion is not valid in conjunction with any other loyalty programmes or offers.
- 1.7.5. This Promotion may be subject to Metro's further terms and conditions, which shall be determined by Metro in its sole discretion.
- 1.7.6. The Bonus Metro\$ Rebate is in addition to the Metro\$ Rebates that an Eligible Cardmember may earn under the prevailing Terms and Conditions Governing Metro-UOB Card (the "Metro-UOB Card Terms") for Metro Transactions (as defined under the Metro-UOB Card Terms).
- 1.7.7. The In-Store Spend amount will be determined based on the amount posted onto UOB's systems, and will be rounded down to the nearest two decimal places.

2. Bonus Metro\$ Rebate

- 2.1. The Bonus Metro\$ Rebate is neither transferable nor exchangeable for cash, reward points, credit, goods and services, products or privileges or other kind, in full or in part, and is not refundable or replaceable.
- 2.2. UOB has the right, at any time in its discretion and without prior notice, to substitute or replace the Bonus Metro\$ Rebate with another item of similar value without giving any reason or assuming any liability or payment of compensation to any person. UOB's determination of such variation, substitution or replacement shall be final, conclusive and binding.
- 2.3. In the event that your Eligible Card account is terminated for whatever reason before the Bonus Metro\$ Rebate is credited into your Eligible Card account, your Bonus Metro\$ Rebate will be automatically forfeited without prior notice to you and you shall not be entitled to any compensation or payment whatsoever.
- 2.4. UOB is not an agent of Metro. Accordingly, UOB makes no warranty or representation as to the quality, value, merchantability or fitness of the Metro\$ Rebate and/or the goods and services provided by Metro in connection with this Promotion and UOB assumes no liability or responsibility for the acts or omissions of Metro or any non-performance or defects in the goods and services provided by Metro in connection with this Promotion. Any dispute regarding the utilisation of your Metro\$ Rebate and/or the goods and services provided by Metro in connection with this Promotion is to be resolved directly with Metro and UOB shall not be required to assist or act on your behalf in communicating Metro.

3. General

- 3.1. The following persons shall not be eligible to participate in the Promotion:
 - (a) individuals whose Eligible Card account(s) is/are voluntarily or involuntarily suspended, cancelled, closed or terminated anytime during the Promotion Period;
 - (b) individuals whose Eligible Card account(s) is/are not active, valid, subsisting or in good standing or which are otherwise determined by UOB in its sole discretion as being delinquent or unsatisfactorily conducted for any reason;
 - (c) individuals whose UOB account(s) is/are voluntarily or involuntarily suspended, cancelled, closed or terminated at any time;
 - individuals whose UOB account(s) is/are not active, valid, subsisting or in good standing or delinquent or unsatisfactorily conducted as may be determined by UOB at its sole discretion;
 - (e) individuals who are mentally unsound, without legal capacity, deceased, insolvent, bankrupt or who have any legal proceedings (actual or threatened) of any nature instituted against them; or
 - (f) anyone whom UOB may decide to exclude, in its sole discretion, without any reason or prior notice at any time.
- 3.2. UOB will not be liable or responsible for any injury, loss or damage whatsoever or for any charge, cost or expense of any kind whatsoever suffered or incurred as a result of or in connection with the redemption or usage of the Metro\$ Rebate or participation in this Promotion. Without limiting the foregoing, UOB will not be liable or responsible for any undelivered, misdirected, corrupted, lost or delayed text, transmission or transaction or any delay or failure in posting any transaction or accessing any of UOB's online banking services or mobile banking services or third-party applications, howsoever caused.

The Terms shall be read in conjunction with the prevailing UOB Cardmember Agreement, the Metro-UOB Card Terms and any other terms that may be relevant in connection with this Promotion (collectively the "Standard Terms"). In the event of any inconsistency between (i) the Terms and the Standard Terms, the Terms shall prevail to the extent of such inconsistency; and (ii) the Terms and any advertising, promotional, publicity, brochure, marketing or other materials relating to or in connection with the Promotion, the Terms shall prevail to the extent that such discrepancy relates to this Promotion.
- 3.5. UOB may, at any time and at its discretion terminate the Promotion and/or amend any of the Terms, and all persons shall be bound by such amendments.
- 3.6. Unless otherwise stated, this Promotion is not valid with other offers, privileges or promotions.
- 3.7. By participating in this Promotion and in addition to any other consent you have already provided to UOB and any right of UOB under applicable laws, you consent to UOB and the necessary third parties collecting, using and disclosing your information (including your personal data) for the purposes of this Promotion and to contact you, including by voice call or text message.
