# TERMS AND CONDITIONS FOR UNITED OVERSEAS BANK LIMITED ("UOB") VISA INFINITE METAL CARD ("CARD") ADD-ON ACQUISITION CAMPAIGN 2018 ("PROMOTION")

The principal UOB Visa Infinite Metal Card ("**Card**") requires payment of a joining fee of S\$642 (inclusive of GST). A renewal fee of S\$642 (inclusive of GST) will be charged on the Card anniversary date every year thereafter.

For the avoidance of doubt, the joining fee and the subsequent yearly renewal fee cannot be waived.

The UNI\$12,500 will be credited to you two (2) months after your renewal fee payment due date. This is upon receipt of your annual membership/renewal fee payment. Advance crediting of UNI\$ is not permissible and will not be entertained. If a Cardmember selects the TUMI Gift Set by successful registration via SMS as detailed under Paragraph 1(iv) below, the Cardmember will not be eligible to receive UNI\$12,500.

#### A. TUMI Luggage and Packing Cube ("TUMI Gift Set")

- 1. This Promotion is open to principal Cardmembers ("Cardmembers") who fulfill <u>ALL</u> of the following conditions ("Eligible Cardmember"). Cardmembers:
  - (i) who have applied for and been issued a Card by UOB in Singapore between 5 July 2018 to 31 October 2018 (both dates inclusive);
  - (ii) whose Card account is in good standing and is satisfactorily conducted (as determined by UOB in its discretion);
  - (iii) whose Card account is not voluntarily or involuntarily cancelled, terminated, closed or suspended at any time:
  - (iv) who successfully registers himself/herself for this Promotion, within the Promotion Period, by sending a SMS, to 77862 from his/her last known registered mobile number with UOB in this format: "yesvctumi<space>last 4 digits of existing UOB credit card<space>NRIC number" ("SMS Registration")\*;
  - (v) who charges Eligible Transactions amounting to at least S\$12,000 ("Qualifying Amount") to their principal Card within the first two (2) months of the issuance of the Card ("Promotion Period"); AND
  - (vi) is amongst the **top 500 individuals with the highest accumulated amount of Eligible Transactions** charged to their principal Card during the Promotion Period.

- 2. For the avoidance of doubt, Eligible Transactions incurred on a supplementary Card will **NOT** accrue to the respective principal Card.

- 4. The Qualifying Amount will be determined in Singapore Dollar Currency and based on UOB's prevailing foreign exchange rates as at the relevant transaction dates of each Eligible Transaction as reflected on the Card statement.
- 5. Redemption of a complimentary TUMI Gift Set is limited to one (1) per Eligible Cardmember. Selection of the TUMI Gift Set colour is limited to the existing stock availability at the point of redemption, and whilst stocks last.
- 6. The TUMI Gift Set is not transferrable, exchangeable for cash (whether in full or partial), credit, other gifts or benefit of any kind. This Promotion is not valid with any other privileges or promotions unless otherwise stated.
- 7. UOB reserves the right, at its discretion, at any time, without notice or assigning any reason thereof, replace or substitute the TUMI Gift Set with any other gift of equal or similar value selected by UOB.

- 11. If any TUMI Gift Set is not redeemed within the stipulated timeframe or if any Eligible Cardmember is subsequently discovered to be ineligible or not entitled to participate in the Promotion, UOB reserves the right



to forfeit/reclaim the TUMI Gift Set and award or dispose of it in such manner and to such persons as UOB deems fit without any liability on the part of UOB to any persons.   - (i) who have applied for and been issued a UOB Visa Infinite Metal Card (the "Card") by United Overseas Bank Limited ("UOB") in Singapore between 5 July 2018 to 31 October 2018 (both dates inclusive);
  - (ii) whose Card account is in good standing and is satisfactorily conducted (as determined by UOB in its discretion);
  - (iii) whose Card account is not voluntarily or involuntarily cancelled, terminated, closed or suspended at any time;
  - (iv) who successfully registers himself/herself for this Promotion, within the Promotion Period, by sending a SMS, to 77862 from his/her last known registered mobile number with UOB in this format: "yesvcmiles<space>last 4 digits of existing UOB credit card<space>NRIC number" ("SMS Registration"); AND
  - (v) who have charged any transaction for the purchase of goods and/or services successfully charged to their principal Card and which are captured and posted on UOB's systems within the first two (2) months of the Card Open Date ("**Promotion Period**").
- 13. For the avoidance of doubt, eligible transactions as detailed under Paragraph 12(v) incurred on a supplementary Card will **NOT** accrue to the respective principal Card.
- 14. The Eligible Cardmember is eligible for a one-time lump credit of UNI\$12,500 ("Welcome UNI\$") to his/her Card account. The Welcome UNI\$ will be credited into the Eligible Card account by 31 January 2019 or by such other mode or on such other date that UOB may decide on from time to time.
- 15. Advance crediting of the Welcome UNI\$ is not permissible and will not be entertained.
- 16. The Welcome UNI\$ is not transferrable, exchangeable for cash (whether in full or partial), credit, other gifts or benefit of any kind. This Promotion is not valid with any other privileges or promotions unless otherwise stated.
- 17. UOB reserves the right, at its discretion, at any time, without notice or assigning any reason thereof, replace or substitute the Welcome UNI\$ with any other gift of equal or similar value selected by UOB.

## **General**

- 18. Cardmembers who did not send in any SMS Registration within the Promotion Period as detailed under Paragraph 1 (iv) above will not be eligible for the TUMI Gift Set. Cardmembers who did not select the TUMI Gift Set will receive the Welcome UNI\$ with the payment of the Card joining fee of S\$642 (inclusive of GST). The Welcome UNI\$ will be credited into their Card account by 31 January 2019, or by such other mode or on such other date that UOB may decide on from time to time.
- 19. UOB reserves the right, at its sole and absolute discretion and at any time and without giving prior notice or any reason, to vary, amend, add or delete any of the terms and conditions herein without assuming any liability to any person, and the Cardmembers shall be bound by these variations, amendments, additions or deletions.



- 20. In the event that any Eligible Cardmember is subsequently discovered to be ineligible or not entitled to participate in this Promotion to receive the TUMI Gift Set or Welcome UNI\$, UOB reserves the right to forfeit / reclaim the TUMI Gift Set or Welcome UNI\$ or the value of the TUMI Gift Set or Welcome UNI\$ from Cardmember, and dispose of the same in such manner as UOB deems fit without any liability on the part of UOB to any persons.
- 21. UOB shall not be responsible for any failure or delay in the transmission of sale transactions by Visa acquiring merchants, merchant establishments, Visa International Incorporated, postal or telecommunication authorities or any other parties which may result in a charge incurred by the Principal Cardmember and/or his/her Supplementary Cardmember(s) being omitted from the Promotion Period.
- 22. Eligible Cardmembers shall continue to be bound by the terms and conditions governing UOB Cardmember Agreement. In the event of any inconsistency between UOB Cardmember Agreement and these Terms and Conditions, these Terms and Conditions shall prevail to the extent that any such inconsistency pertains to the Promotion.
- 23. UOB assumes no liability or responsibility for the acts or defaults of the merchant or defaults in the goods and services offered in this promotion. UOB is not an agent of the merchant. Any dispute about the quality or service standard must be resolved directly with the respective merchant(s). The merchant(s) may apply conditions to the redemption of the goods and services. UOB will not be responsible for any injury, loss or damage suffered as a result of the redemption or usage of the goods and services.
- 24. While the information provided herein is believed to be reliable as at the date of printing, UOB makes no representation or warranty, whether express or implied, and accepts no responsibility or reliability for its completeness or accuracy. All information is accurate at the time of printing.
- 25. These Terms and Conditions shall be governed by the laws of the Republic of Singapore and the Cardmembers hereby agree to submit to the exclusive jurisdiction of the courts of Singapore.
- 26. Unless otherwise provided herein, a person who is not a party to these Terms and Conditions and/or agreement governed by the Standard Terms shall have no rights under the Contracts (Rights of Third Parties) Act (Cap.53B) to enforce any term of such agreement or any of these Terms and Conditions.

### **SMS** Registration

- 27. The Eligible Cardmember will receive a confirmation Electronic Short Message Service ("SMS") from UOB once he/she successfully completes the SMS Registration.
- 28. The Eligible Cardmember must perform the SMS Registration using his/her last known registered mobile number with UOB. Only SMS Registrations received by UOB will be considered for the Promotion. Any incomplete or inaccurate SMS Registration will not be considered and consequently be disqualified. For the avoidance of doubt, each Eligible Cardmember is only allowed to register once to participate in the Promotion. Should Cardmembers send in more than one (1) SMS Registration, UOB will take the first SMS Registration as good and intended, and Cardmembers will hence only be eligible for the first Promotion that is registered for.
- 29. SMS Registration starts from 0000 hours on 5 July 2018 and ends on 2359 hours on 31 October 2018 (Singapore time). SMS entries received by UOB after 2359 hours on 31 October 2018 will not be eligible for the Promotion and will be considered invalid and void.



- 30. Sending and receiving SMS is dependent on a SMS vendor, an independent telecommunication authority or service provider or such other third party which is engaged by UOB for the Promotion and UOB shall not be responsible for any undelivered, lost or delayed SMS sent and/or received by the Eligible Cardmembers. The Eligible Cardmembers shall pay and be solely responsible for all fees and charges imposed by such service providers for the sending and/or receipt of any SMS in connection with this the Promotion.
- 31. The SMS vendor, independent telecommunication authorities or service provider or such other third party is a third party and is independent and beyond the control of UOB. UOB shall not be responsible in any manner whatsoever for their acts or defaults.
