TERMS AND CONDITIONS GOVERNING THE "UOB-SPC SEPTEMBER – OCTOBER 2021 PUMP AND SAVE" PROMOTION

1 Definitions

- 1.1 "Bank" or "UOB" means United Overseas Bank Limited.
- "Eligible Cardmembers" means all Principal Cardmembers and Supplementary Cardmembers holding a personal UOB debit or credit card issued in Singapore (collectively referred to as "Cards" and each a "Card") which is valid, subsisting, in good standing and satisfactorily conducted, as determined by UOB at its discretion. For avoidance of doubt, all commercial and business debit and credit cards are excluded from this Promotion.
- "Eligible Transaction" means a retail transaction for the purchase of goods and/or services at SPC service stations in Singapore which is successfully carried out and charged in Singapore Dollars to Eligible Cardmember's Card account during the Promotion Period and is successfully captured/ posted in UOB's systems under the merchant category code 5541 during the Promotion Period. Eligible Transactions exclude transactions for payments under Instalment Payment Plans, interests, late charges, annual fees, cash advance, balance transfers, fund transfers, instalment loans, fees and other financial charges imposed by UOB, transactions which were subsequently cancelled, voided or reversed for any reason and such other transactions as may be excluded from UOB time to time.
- 1.4 "Promotion" refers to this UOB-SPC Sept Oct 2021 Pump and Save up to 28.3% Promotion.
- 1.5 "Promotion Period" means the period commencing from 0000hrs on 1 Sept 2021 to 2359hrs on 15 October 2021 (both dates inclusive).
- 1.6 "SPC" means Singapore Petroleum Company Limited.

2 Promotion

- 2.1 The Promotion is open to all Eligible Cardmembers subject to the terms and conditions herein.
- 2.2 Subject to the fulfilment of the conditions set out below, Eligible Cardmembers shall be entitled a S\$5 SPC e-voucher ("SPC e-Voucher"). This e-Voucher may be used for purchase of SPC petrol, diesel or Choices products (except cigarettes, parking coupons & phone cards) at any SPC Service Station in Singapore subject to prevailing conditions of the sale and/or any other terms of redemption as determined by SPC from time to time. The e-Voucher is valid for one-time use in a single transaction and is not exchangeable for cash or in-kind. Any value not fully redeemed is not refundable. Any balance after the redemption with the e-Voucher must be paid with a UOB Card.

3 Eligibility

3.1 The following persons are not eligible for the Promotion:





- (a) Eligible Cardmembers whose UOB credit and/or debit accounts is/are voluntarily or involuntarily cancelled, terminated, closed or suspended anytime during the Promotion Period:
- (b) Persons who are or become mentally incapacitated, deceased, insolvent or have legal proceedings of any nature instituted against them; and
- (c) Persons whose UOB credit and/or debit card accounts are not active, valid, subsisting or in good standing or which are otherwise determined by UOB in its absolute discretion as being delinquent or unsatisfactorily conducted for any reason as may be determined by UOB at its discretion.
- 3.2 UOB reserves the right to determine at its discretion the eligibility of Cardmembers and/or persons for this Promotion. The decisions of UOB on all such matters relating to the eligibility of any such Cardmembers and/or persons are final, conclusive and binding, and UOB is not obliged to give any reason or prior notice.

4 S\$5 SPC e-voucher Eligibility

- During this Promotion Period, the top 5,000 spenders in SPC (as determined by UOB at its sole discretion) shall be awarded One (1) SPC e-Voucher. To qualify for this Promotion, the Eligible Cardmember will need to accumulate a total of at least \$\$250.00 nett spend at SPC with his/her UOB Card, is eligible to be awarded one (1) SPC e-Voucher during the Promotion Period.
- 4.2 Each Eligible Cardmember is entitled to only one (1) SPC e-Voucher under this Promotion.
- 4.3 The SPC e-Voucher will be sent to each eligible Cardmember's valid handphone number with the Bank via SMS within 6 weeks from the end of the Promotion Period. The SPC e-Voucher will be valid for 6 months from the date of the SMS and is strictly non-extendable.
- 4.4 UOB reserves the right to vary or substitute the cash rebate with other items of similar or equal value at any time without having to give any notice or provide any explanation.

5 General

- 5.1 The prevailing terms and conditions under the prevailing UOB Cardmember Agreement and UOB Debit Cardmember Agreement (the "Standard Terms") will continue to apply and be binding on the Eligible Cardmembers. In the event of any inconsistency between these terms and conditions and the Standard Terms, these terms and conditions shall prevail insofar as it relates to the Promotion.
- 5.2 In the event of any inconsistency or discrepancies between these terms and conditions and any advertising, promotional, publicity, brochure, marketing or promotional material relating to or in connection with the Promotion, these terms and conditions will prevail.
- If any person is subsequently discovered to be ineligible or not entitled to participate in the Promotion or ineligible to receive the cash rebate, UOB reserves the right to forfeit/reclaim the cash rebate at UOB's discretion and confer the same on any other person as may be selected by UOB in any manner as UOB may deem fit at its absolute discretion.
