

UOB PRVI Miles American Express® Card - Up to S\$10 Cash Rebate Contactless Spend Campaign (the “Promotion”) Terms and Conditions (the “Terms and Conditions”)

1. Eligibility

This Promotion is only open to all principal and supplementary cardmembers of a UOB PRVI Miles American Express® Card (“**Card**”) that is issued by United Overseas Bank Limited (“**UOB**”) in Singapore; and who have registered online at <https://merchantgeo.secure.force.com/enroll/EnrollmentSitePage?offer=339764UOBContactlessCampaign&language=en-gb> for the Promotion during the Spend Period (collectively referred to as “**Cardmembers**”).

The Card that is registered for this Promotion will be deemed the “**Eligible Card**”. For the avoidance of doubt, each Cardmember may only register once for this Promotion. Each of the Principal and supplementary Eligible Cards are included in this Promotion.

2. Spend Period

All Eligible Transactions (as defined in Paragraph 3.4 below) successfully charged to the Eligible Card(s) which are posted and captured on UOB’s systems between **11 June to 30 November 2019** (both dates inclusive) (the “**Spend Period**”) will be taken into account for this Promotion.

3. Award

3.1 The first 15,000 Cardmembers who successfully registered and charge to their Eligible Card via contactless payment (“**Qualifying Spend**”) during the Spend Period will be deemed “**Eligible Cardmembers**”.

3.2 Each Eligible Cardmember is entitled to S\$1 cash rebate for every contactless card spend, up to 10 transactions (i.e total of S\$10 cash rebate) (the “**Award**”) on Eligible Transactions during the Spend Period.

3.3 The Award is capped at S\$10 cash rebate for each Eligible Cardmember.

3.4 For the purposes of the Promotion, the following terms are defined as follows:-

(a) “**Eligible Transactions**” shall mean all posted eligible contactless payments made in-person at merchants which accept American Express. For the avoidance of doubt, Eligible Transactions do not include Excluded Transactions.

(b) “**Excluded Transactions**” shall mean:-

- i. Purchases where spending is not performed using contactless payment - for instance, payment made via swiping or inserting the Card;
- ii. Purchases charged before the Card was registered in accordance with clause 1;
- iii. Refunded or cancelled charges under the Card.

UOB reserves the right, at any time and at its discretion, to amend or vary this list the definition of Excluded Transactions without any reasons, prior notification and/or assuming any liability to any party and shall not be liable to pay any compensation or enter into any correspondence in connection with the same.

3.5 The Award will be credited to the Eligible Cardmember’s Eligible Card account within 90 days from 30 November 2019. No advance crediting request will be entertained.

3.6 In the event that:-

(a) there are any errors or mistakes in the calculation or crediting of the Award;

- (b) if any Eligible Cardmember or the Eligible Card account is subsequently discovered to be ineligible, not entitled to or disqualified from participation in the Promotion;
- (c) there are credit balances in the Eligible Card account of any Eligible Cardmember and/or in the applicable account of a supplemental holder of the Eligible Card arising out of (but not limited to) the failure of the Eligible Transaction, returned goods or services under that transaction, billings disputes;
- (d) any person is subsequently discovered to be ineligible or not entitled to participate in the Promotion or ineligible to receive the Award;
- (e) the Eligible Cardmember is subsequently found not have incurred the Qualifying Spend; or
- (f) any other situation that UOB deems fit,

UOB is entitled at its sole and absolute discretion, and at any time without liability or prior notice or having to give any reason:-

- i. to amend, correct or adjust the calculation of the Award;
- ii. to suspend, revoke, or forfeit the crediting of Award (or any part thereof); or
- iii. where the Award has been credited, to reclaim the Award (or any part thereof) without any liability on the part of UOB.

No person shall be entitled to and UOB shall not be liable for any payment or compensation (whether in cash, credit or kind) whatsoever arising from the above and no person shall be entitled to such payment.

- 3.7 In the event that the Eligible Card account is delinquent, voluntarily or involuntarily closed or terminated or suspended for any reasons whatsoever before the Award is awarded into such Eligible Card account, such Award earned shall be forfeited and the Cardmember shall not be entitled to any compensation or payment whatsoever.
- 3.8 UOB reserves the right, at its sole and absolute discretion and at any time and without giving prior notice or any reason, to vary, amend, add or delete any of the terms and conditions herein without assuming any liability to any person, and the Eligible Cardmembers shall be bound by these amendments.
- 3.9 UOB's decision on all matters relating to the Promotion shall be final, conclusive and binding on the Eligible Cardmember.
- 3.10 UOB shall not be obliged to give any reason or enter into any correspondence with the Eligible Cardmember or any persons on any matter concerning the Promotion.
- 3.11 UOB shall not be responsible for (i) any failure or delay in the transmission of card transactions by Mastercard/Visa/Unionpay/JCB/CUP/American Express, acquiring merchants for the foregoing, merchant establishments, postal or telecommunication authorities or any other parties which may result in an overseas transaction made by the Eligible Cardmember being omitted during the Spend Period; (ii) any late posting of the transactions and thereby affecting the Eligible Cardmember's eligibility for this Promotion; (iii) any notice or communication which gets lost, misplaced, defaced, tampered with, stolen, damaged or misdirected in the post; or (iv) any breakdown or malfunction in any computer system or equipment.
- 3.12 All information is correct at the time of publishing and UOB makes no representation or warranty whether express or implied, and accepts no responsibility or liability for its completeness or accuracy.
- 3.13 These Terms and Conditions are supplemental to the prevailing terms and conditions under the UOB Cardmember Agreement and UOB Rewards Programme ("Standard Terms"). Cardmembers are deemed to have accepted these Terms and Conditions when they participate in the Promotion. In the event of any inconsistency between these Terms and Conditions and the Standard Terms, these Terms and Conditions shall prevail to the extent of such inconsistency.

3.14 These Terms and Conditions shall be governed by the laws of the Republic of Singapore and Cardmembers hereby agree to submit to the exclusive jurisdiction of the courts of Singapore.

3.15 A person who is not a party to the terms and conditions herein and/or any agreement governed by the terms and conditions herein shall have no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any term of such agreement or any of the terms and conditions herein.
