

Terms & Conditions for S\$100 worth of Sheng Siong Discount Vouchers with UOB Absolute Cashback Card or UOB PRVI Miles American Express® Card 'Scan & Redeem' Approval Promotion

1. Promotion

- 1.1. This S\$100 worth of Sheng Siong Discount Vouchers with with UOB Absolute Cashback Card or UOB PRVI Miles **American Express®** Card 'Scan & Redeem' Approval Promotion (the "**Promotion**") is only valid from 30 June 2023 to 30 September 2023, both dates inclusive (the "**Promotion Period**").
- 1.2. By participating in this Promotion, you are deemed to have agreed to be bound by the terms and conditions of this Promotion (the "**Terms**").
- 1.3. This Promotion is only open to individuals who are not an existing holder of a credit card issued by United Overseas Bank ("**UOB**") in Singapore.
- 1.4. For this Promotion, you are eligible to receive a booklet containing \$100 worth of Sheng Siong Discount Vouchers (the "**Voucher Booklet**") if you satisfy all of the following conditions:
 - (a) you must duly complete and successfully submit your application for a new UOB Absolute Cashback Card or UOB PRVI Miles **American Express®** Card as a principal cardholder during the Promotion Period via 'Scan & Redeem' with MyInfo by following the application instructions on the advertisement for this Promotion at any one of the retail outlets, web portals, electronic or direct mailers and/or social media platforms of Sheng Siong Supermarket Pte Ltd (the "**Application**");
 - (b) you must not be an existing principal cardholder of any credit card issued by UOB in Singapore at the time when your Application is approved and you must not have cancelled any UOB credit card as a principal cardholder within the six (6) months' period prior to the approval date of your Application;
 - (c) your Application must be approved by UOB within Promotion Period; and
 - (d) you must activate your new UOB Absolute Cashback Card or UOB PRVI Miles **American Express®** Card issued pursuant to your Application approved by UOB under this Promotion and successfully charge at least S\$100 worth of Eligible Transactions (as defined below) to your new UOB Absolute Cashback Card or UOB PRVI Miles **American Express®** Card within thirty (30) days from the approval date of your Application (the "**Minimum Spend**").
- 1.5. UOB has the right at its discretion to approve or decline any Application for any reason whatsoever and is neither obliged to give any reason or prior notice on any matter concerning the Application nor be liable to any person.
- 1.6. For the purposes of this Promotion:
 - (a) "**Eligible Transactions**" shall mean any retail transactions for the purchase of goods and/or services successfully charged to your new UOB Credit Card and which are posted on UOB's systems but excluding the Excluded Transactions (as defined below).
 - (b) "**Excluded Transactions**" shall mean:
 - (i) cash advances;
 - (ii) balance and/or fund transfers;
 - (iii) NETS and NETS-related transactions;
 - (iv) monthly instalments under 0% Instalment Payment Plan and SmartPay;
 - (v) any transactions at UOB\$ merchants where UOB\$ are issued (previously known as SMART\$);

- (vi) any interest, fees and charges (including without limitation, late payment charges or interest charges, annual or monthly fees or charges) imposed by the Bank;
- (vii) any credit card transaction that is subsequently cancelled, voided, refunded or reversed for any reason;

- (x) Any transaction consisting of/containing the following references:

(xi) any other transactions which the Bank may exclude from time to time without prior notice to you.

1.7. For the avoidance of doubt:

- (a) If you submit an application for a UOB Absolute Cashback Card or UOB PRVI Miles **American Express**® Card via any channel other than following the application instructions in the advertisement at any one of the retail outlets, web portals, electronic or direct mailers and/or social media platforms of Sheng Siong Supermarket Pte Ltd for this Promotion, you shall not be eligible to participate in this Promotion.
- (b) All overseas card transactions effected in foreign currencies will be converted into Singapore dollars based on UOB's prevailing exchange rate and the Singapore dollar amount posted on UOB's system will be used for the purposes of computing the Minimum Spend under this Promotion.
- (c) A merchant's registered MCC may not always correspond with its nature of business. The MCCs are assigned by the merchant's acquiring bank. UOB does not determine the merchants' MCC. UOB shall not be liable in any way whatsoever relating to the categorisation of a merchant's MCC.
- (d) UOB reserves the right at any time to amend the list of Eligible Transactions and the list of Excluded Transactions in its sole discretion and without any prior notice or giving any reasons.

2. Voucher Booklet

- 2.1. If you satisfy all of the conditions in Clause 1.4 above, you are eligible to receive the Voucher Booklet.
- 2.2. You are only eligible to receive a maximum of one (1) Voucher Booklet under this Promotion, regardless of the number of credit cards you applied under this Promotion.
- 2.3. If you are eligible to receive the Voucher Booklet, the Voucher Booklet will be mailed to your Singapore mailing address in UOB's records via registered post within three (3) months from the approval date of your Application (or such other date as may be determined by UOB from time to time) (the "**Notification**").

- 2.4. The Voucher Booklet will consist of a set of discount vouchers of varying denominations and validity periods issued by Sheng Siong Supermarket Pte Ltd (the “**Voucher Merchant**”) to be used and/or applied towards various participating brands / stores in Singapore under the Voucher Merchant. You are required to follow the instructions set out in Voucher Booklet in order to redeem and utilise the individual vouchers contained therein. UOB shall not be responsible or liable in any way to any person arising from your inability to redeem and/or utilise the same.
- 2.5. Strictly no extension of the validity periods stated in the respective vouchers comprised in the Vouchers Booklet is allowed. If you do not redeem your vouchers in the Voucher Booklet by the applicable expiry dates, the respective vouchers will be forfeited.
- 2.6. Each voucher in the Voucher Booklet must be presented in its physical form at the time of redemption / utilisation and can only be used once to offset your bill at the relevant participating brand / store of the Voucher Merchant in Singapore for that voucher. Use of each voucher remains subject to any terms and conditions as may be imposed by the Voucher Merchant in its sole discretion. Payment of any balance after utilising a voucher must be paid with a valid UOB credit card issued in Singapore. The vouchers are not valid in conjunction with other discounts, promotions or vouchers, unless otherwise stated.
- 2.7. The relevant participating brand / store in Singapore under the Voucher Merchant shall be entitled to decline the redemption of a voucher if (in its opinion) the voucher appears to be a counterfeit or altered, defaced, damaged, or tampered with (as applicable).
- 2.8. Voucher Booklets are on a first-come-first-served basis, whilst stocks last and subject to availability. UOB shall not be required to notify and/or update on the stock availability of the Voucher Booklets.
- 2.9. The Voucher Booklet and the vouchers contained therein are not exchangeable for cash, credit or kind, in full or in part, and are not replaceable if lost, damaged or stolen. No reservation, refund or exchange of the Voucher Booklet and the vouchers contained therein are allowed.
- 2.10. UOB may substitute the Voucher Booklet with any item of equivalent or similar value, without prior notice or reason or being liable to any person.
- 2.11. The Voucher Booklet and the vouchers contained therein are supplied by third party merchants and UOB is not an agent of the merchants and/or suppliers of the Voucher Booklet and the vouchers contained therein. Accordingly, UOB makes no warranty or representation as to the quality, value, merchantability or fitness for purpose of any products and/or services provided by third party merchants in connection with the use and/or redemption of the vouchers in the Voucher Booklet and UOB assumes no liability or responsibility for the acts or omissions of the merchants or any non-performance or defects in any products and/or services provided by third party merchants in connection with the use and/or redemption of the vouchers in the Vouchers Booklet. Any dispute regarding the use and/or redemption of any products and/or services provided by third party merchants in connection with the use and/or redemption of the vouchers in the Vouchers Booklet is to be resolved directly with the relevant merchant and/or supplier. UOB shall not be required to assist or act on your behalf in communicating with the relevant merchant and/or supplier.
- (a) For the avoidance of doubt, your UOB Credit Card opened under this Promotion must be in good standing as determined by UOB in its absolute discretion. In the event that your UOB Credit Card is delinquent, voluntarily or involuntarily suspended, cancelled, closed or terminated for any reason whatsoever before you receive the Voucher Booklet, the Voucher Booklet shall be forfeited and you shall not be entitled any compensation or payment whatsoever.

3. General

- 3.1. The following persons shall not be eligible to participate in the Promotion:

- (a) individuals whose UOB account(s) is/are voluntarily or involuntarily suspended, cancelled, closed or terminated at any time;
 - (b) individuals whose UOB account(s) is/are not active, valid, subsisting or in good standing or delinquent or unsatisfactorily conducted as may be determined by UOB at its sole discretion;
 - (c) individuals who are mentally unsound, facing legal incapacity or are incapable of handling their affairs, deceased, insolvent, bankrupt or have any legal proceedings (or any threat) of any nature instituted against them; or
 - (d) anyone whom UOB may decide to exclude, at its sole discretion, without any reason or prior notice at any time.
- 3.2. UOB will not be liable or responsible for any injury, loss or damage whatsoever or for any charge, cost or expense of any kind whatsoever suffered or incurred as a result of or in connection with the redemption or usage of any reward under this Promotion or participation in this Promotion. Without limiting the foregoing, UOB will not be liable or responsible for any undelivered, misdirected, corrupted, lost or delayed text, transmission or transaction or any delay or failure in posting any transaction or accessing any of UOB's online banking services or mobile banking services or any third party applications, howsoever caused.
- 3.3. Sending and receiving the Redemption Letter is dependent on Singapore Post, an independent postage authority or service provider or such other third party which is engaged by UOB for the Promotion and UOB shall not be responsible or liable for any undelivered, lost or delayed Redemption Letter sent and/or received. You shall pay and be solely responsible for all fees and charges imposed by such service providers for the sending and/or receipt of any Redemption Letter in connection with the Promotion.
- 3.4. UOB has the absolute right and unfettered discretion to make decisions on all matters relating to or in connection with the Promotion, including but not limited to the determination of whether you have met all the requirements of the Promotion. UOB's decisions shall be final, conclusive and binding and no payment or compensation will be given. UOB shall not be obliged to give any reason or prior notice or enter into any correspondence with any person on any matter or decision relating to the Promotion.
- 3.5. If UOB determines that you are ineligible to participate in this Promotion or to receive any reward under this Promotion, UOB may in its sole discretion forfeit such reward, reclaim the reward or charge to and debit an amount equal to the value of the reward from any of your accounts with UOB without prior notice to you. If the monies standing to the credit of your accounts are insufficient to reimburse UOB, you shall immediately reimburse UOB for the value of the reward through such means as UOB may determine in its sole discretion.
- 3.6. The Terms shall be read in conjunction with the prevailing UOB Cardmember Agreement and any other terms that may be relevant in connection with this Promotion (collectively the "**Standard Terms**"). In the event of any inconsistency between (i) the Terms and the Standard Terms, the Terms shall prevail to the extent of such inconsistency; and (ii) the Terms and any advertising, promotional, publicity, brochure, marketing or other materials relating to or in connection with the Promotion, the Terms shall prevail to the extent that such discrepancy relates to this Promotion.
- 3.7. UOB may, at any time and at its discretion terminate the Promotion and/or amend any of the Terms, and all persons shall be bound by such amendments.
- 3.8. Unless otherwise stated, this Promotion is not valid with other offers, privileges or promotions.
- 3.9. By participating in this Promotion and in addition to any other consent you have already provided to UOB and any right of UOB under applicable laws, you consent to UOB and the necessary third parties collecting, using and disclosing your information (including your personal data) for the purposes of this Promotion and to contact you, including by voice call or text message.

- 3.10. A person who is not a party to the Terms shall have no rights under the Contracts (Rights of Third Parties) Act 2001 of Singapore to enforce the Terms.
- 3.11. The Terms shall be governed by the laws of the Republic of Singapore and you shall be deemed to have agreed to submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
