

TERMS & CONDITIONS FOR UOB INFINITY ECAPITAVOUCHER PROMOTION ("PROMOTION")

- 1. The Promotion is valid from 15 October 2020 to 30 November 2020 (both dates inclusive) ("Promotion Period").
- 2. This Promotion is only open to customers ("Customer") who are UOB Business Internet Banking ("BIB") or UOB Infinity customers during the Promotion Period . By participating in this Promotion, the Customer is deemed to agree to be bound by the terms and conditions of this Promotion (the "Terms").
 - "UOB Infinity" means the Business Internet Banking Platform that can be accessed through the desktop web browser (https://infinity.uobgroup.com/) or through mobile app – "UOB Infinity Singapore" downloaded on Apple App Store or Google Play Store.
- 4. "Eligible Transactions" refer to cash management transactions initiated and approved by the Customer in Singapore on UOB Infinity during the Promotion Period. Specifically, the types of Eligible Transaction refer to:
 - Single Transactions Transfer to UOB Accounts, Transfer to Other Local Banks, PayNow, Cashier's Orders, Demand Drafts, Bill Payments, Telegraphic Transfers / MEPS, Request for Transfer (MT101);
 - Bulk Transactions Transfer to Local Accounts, Payroll, Collections, Cashier's Orders / Cheques, Telegraphic Transfer / MEPS, Upload Bulk File; and
 - c. Financial Institution Transactions Bank To Bank Transfers (MT103), Bank to Bank Transfers (MT202).

For avoidance of doubt, 1 Bulk Transaction consisting of 1 or more single transactions is counted as 1 Eligible Transaction.

- 5. For the purpose of this Promotion, "Customer" means a BIB customer or UOB Infinity customer, or a group of BIB customers or UOB Infinity Customers, whose users access UOB Infinity using the same Organisation ID.
- 6. The first 1000 customers to submit **20** or more Eligible Transactions during the Promotion Period will be given \$50 worth of eCapitaVouchers each. ("Gift")
- 7. The Gift is will be issued to eligible customers by 31 March 2021 through the eligible customer's registered email address as per the Bank's record.
- 8. Every customer is entitled only to one Gift under this Promotion, regardless the number of eligible transactions submitted during this Promotion Period.
- 9. The Gift is not exchangeable for cash, credit or in kind, in full or in part, and is not replaceable if lost or stolen. No exchange of the Gift is allowed.
- 10. UOB may substitute the Gift with any item of equivalent or similar value, without prior notice or reason or being liable to any person.
- 11. UOB may at its absolute discretion forfeit the Gift, or, if already awarded, reclaim the Gift at your expense (whether by deducting any of your UOB account(s) or otherwise) without payment, compensation, or having to give any reason whatsoever if your UOB Infinity account applied for under this Promotion is closed or terminated within nine (9) months from the date such account was opened.
- 12. UOB will not be liable or responsible for any injury, loss or damage whatsoever or for any charge, cost or expense of any kind whatsoever suffered or incurred as a result of or in



connection with the redemption or usage of the Gift or participation in this Promotion. Without limiting the foregoing, UOB will not be liable or responsible for any undelivered, misdirected, corrupted, lost or delayed text, transmission or transaction or any delay or failure in posting any transaction, howsoever caused.

- 13. UOB has the absolute right and unfettered discretion to make decisions on all matters relating to or in connection with the Promotion, including but not limited to the determination of whether you have met all the requirements of the Promotion. UOB's decisions shall be final, conclusive and binding and no payment or compensation will be given. UOB shall not be obliged to give any reason or prior notice or enter into any correspondence with any person on any matter or decision relating to the Promotion.
- 14. Without prejudice to any of the other provisions in these Terms, if UOB determines that you are ineligible to participate in this Promotion or to receive the Gift, UOB may in its sole discretion forfeit the Gift, reclaim the Gift or charge to and debit an amount equal to the value of the Gift from any of your accounts with UOB without prior notice to you. If the monies standing to the credit of your accounts are insufficient to reimburse UOB, you shall immediately reimburse UOB for the value of the Gift through such means as UOB may determine in its sole discretion.
- 15. The Terms shall be read in conjunction with the prevailing UOB Business Internet Banking Service Agreement and any other terms that may be relevant in connection with this Promotion (collectively the "Standard Terms"). In the event of any inconsistency between (i) the Terms and the Standard Terms, the Terms shall prevail to the extent of such inconsistency; and (ii) the Terms and any advertising, promotional, publicity, brochure, marketing or other materials relating to or in connection with the Promotion, the Terms shall prevail.
- 16. UOB may, at any time and at its discretion terminate the Promotion and/or amend any of the Terms, and all persons shall be bound by such amendments.
- 17. Unless otherwise stated, this Promotion is not valid with other offers, privileges or promotions.
- 18. A person who is not a party to the Terms shall have no rights under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce the Terms.
- 19. The Terms shall be governed by the laws of the Republic of Singapore and you shall be deemed to have agreed to submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
