KrisFlyer UOB Credit/Debit Card - S\$50 off with min. spend of S\$500 on Dyson Products (1 to 7 July 2025) Terms and Conditions

- 1. This KrisFlyer UOB Credit/Debit Card S\$50 Off Dyson Promotion ("Promotion") is organised by United Overseas Bank Limited ("UOB") and KrisShop Pte. Ltd. ("KrisShop").
- 2. This Promotion is open to all KrisFlyer UOB Credit and/or Debit Cardmembers (each, a "Cardmember").
- 3. This Promotion is valid from 1 July to 7 July 2025, both dates inclusive (the "**Promotion Period**"). By participating in this Promotion, you agree to be bound by the terms and conditions of this Promotion (the "**Terms**").
- 4. This Promotion will be carried out on KrisShop.com in accordance with clause 5 below during the Promotion Period from 1 July 2025 (0000hrs Singapore time) to 7 July 2025 (2359hrs Singapore time).
