

KrisFlyer UOB Credit Card -4D3N Priceless® Bali Package ("Promotion") Terms and Conditions ("Terms and Conditions")

1. Eligibility

- 1.1 This promotion is valid from **7 October 2019** to **31 December 2019** (both dates inclusive) ("**Promotion Period**") and is open to all principal KrisFlyer UOB Credit Cardmembers ("**Eligible Cardmembers**"), excluding those described below.
- 1.2 The following persons shall not be eligible for the Promotion:
 - (a) Directors or employees of UOB
 - (b) Employees of UOB's partners including advertising and promotion agencies and any other persons involved in organizing, promoting and/or conducting the Promotion:
 - (c) Cardmembers whose KrisFlyer UOB Credit Card ("**Eligible Card**") account(s) is voluntarily or involuntarily suspended, cancelled, closed or terminated anytime during the Promotion Period or as at the Prize Redemption Date stated below and for the avoidance of doubt, termination of a supplementary cardholder's Eligible Card account will not by itself disqualify the principal cardholder of the Eligible Card from participating in the Promotion;
 - (d) Cardmembers whose Eligible Card account(s) is/are not active, valid, subsisting or in good standing or which are otherwise determined by UOB as being delinquent or unsatisfactorily conducted for any reasons as may be determined by UOB at its discretion:
 - (e) Cardmembers who are mentally unsound, facing legal incapacity or are incapable of handling their affairs, deceased, insolvent, bankrupt or have any legal proceedings (or any threat) of any nature instituted against them; or
 - (f) Anyone whom UOB may decide to exclude, at its discretion, without any reason or prior notice at any time.
- 1.3 The lucky draw period is as follows:

2. Allocation of Chances

- 2.1 Lucky draw chances are awarded on the following basis each Eligible Cardmember will be awarded:
 - (a) one (1) lucky draw chance for every S\$100 accumulated worth of Local Eligible Transactions successfully posted to his/her Eligible Card during the Promotion Period; and



(b) three (3) lucky draw chances for every S\$100 accumulated worth of Overseas Eligible Transactions successfully posted to his/her Eligible Card during the Promotion Period

2.2 For the purpose of this Promotion:

- (a) "Local Eligible Transactions" shall mean all retail transaction(s), transacted in Singapore dollars, successfully posted to the Eligible Card account during the Promotion Period **BUT** shall exclude the Excluded Transactions.
- (b) "Overseas Eligible Transactions" shall mean all retail transaction(s), transacted in non-Singapore dollars, successfully posted to the Eligible Card account during the Promotion Period <u>BUT</u> shall exclude the Excluded Transactions.

For the avoidance of doubt, the benefit of all transactions incurred by a supplementary holder of the Eligible Card ("**Supplementary Cardmember**") in respect of the Promotion shall accrue to the applicable Eligible Cardmember and form part of that Eligible Cardmember's Eligible Transactions.

- (c) "Excluded Transactions" shall mean transactions that are listed in the Exclusion section in the Terms and Conditions Governing KrisFlyer UOB Credit Card (available at www.uob.com.sg/KrisFlyerUOB/Credit) and
 - (i) balances owing on the Eligible Card accounts accruing from months that do not fall within the Promotion Period:
 - (ii) any transaction that was subsequently cancelled, voided or reversed for any reason.

UOB reserves the right, at any time at its discretion, to amend or vary this list of Excluded Transactions without any reason or, prior notification, and without liability to any party.

- 2.3 For the purposes of calculating the lucky draw chances, Eligible Transactions made in non-Singapore dollars will be converted into Singapore dollars based on UOB's then prevailing exchange rate applicable at the time of exchange.
- 2.4 Limited to one (1) Prize per Winner under the Promotion
- 2.5 Unless otherwise stated, the Promotion is not valid with other offers, discounts, rebates, vouchers, privileges or promotions.

3. Conduct of Draw

- 3.1 Unless UOB notifies otherwise, the draw will be conducted on the Draw Date stipulated in the table in clause 1.3.
- 3.2 The lucky draw will be conducted at 480 Toa Payoh Lorong 6, #25-01, HDB Hub East Wing, Singapore 310480 or such other venue/(s) as may be determined by UOB.



3.3 The lucky draw will be conducted in the presence of an external auditor appointed by UOB.

4. Prize

- 4.1 Three (3) winners will be picked in the lucky draw for this Promotion (the "Winners").
- 4.2 Each Winner will receive one 4D3N Priceless® Bali Package for two persons worth USD 5,000 ("Prize").
- 4.3 Winners will be sent a redemption notice notifying them of their eligibility to redeem the Prize by 30 April 2020 (or such other date as UOB may in its discretion decide) (the "Redemption Notice"). The Redemption Notice will be sent by letter to the mailing address based on UOB's records. Details for the redemption of the Prize will be stated in the Redemption Notice. Conditions may be imposed for the redemption of the Prize and the use of the goods and services offered. UOB, Mastercard and/or the merchant or supplier each reserve the right to decline redemption of the Prize or any part thereof if any of these conditions are not met.

All forfeited Prizes (or the equivalent value thereof) shall be donated to such charitable organisation as shall be decided at the sole and absolute discretion of UOB.

- 5.2 By participating in the Promotion, an Eligible Cardmembers is deemed to have consented to the collection, use and disclosure of his/her personal data by UOB, the organizers, sponsors, promoters and/or their respective contractors for verifying the eligibility of the participant, conducting the lucky draw, announcing/publicity of the winners of the lucky draw (including having the participant's photo taken/published), contacting the participant regarding the foregoing, and all purposes and promotions incidental to the Promotion.
