UOB PRVI Miles World Mastercard – Up to UNI\$11 per S\$5 (equivalent to 4.4 miles per S\$1) on online shopping and online entertainment Campaign (the "Promotion") Terms and Conditions (the "Terms")

1. Eligibility

- 1.1 This Promotion is valid from 21 June 2021 to 31 August 2021, both dates inclusive (the "**Promotion Period**"). By participating in this Promotion, you agree to be bound by these Terms.
- 1.2 This Promotion is open to all principal holders of a UOB PRVI Miles World Mastercard ("Card") that is issued by United Overseas Bank Limited ("UOB") in Singapore.
- 1.3 To participate in this Promotion, you must successfully register to participate in this Promotion by sending in an SMS to 77862 using your Singapore mobile number registered with UOB during the Promotion Period in the following format (the "SMS Registration"):

BONUSMC<space>Last 4 alphanumeric digits of your NRIC or Passport Number

Example: If your NRIC is \$1234567A, you will need to send "BONUSMC 567A" to 77862.

- 1.4 All SMS Registrations for this Promotion which are not in the format prescribed in these Terms and Conditions, sent to an incorrect number, sent from a mobile number which is not registered in Singapore with UOB, or sent outside of the Promotion Period will be null and void.
- 1.5 For the avoidance of doubt, you will only need to register once for this Promotion within the Promotion Period to participate in the Promotion.

2. Promotion

- 2.1 During the Promotion Period, you shall be eligible to earn up to UNI\$11 per S\$5 spend (equivalent to up to 4.4 miles per S\$1 spend) on Eligible Transactions (as defined below) on your Card. The breakdown is set out below:
 - the existing UNI\$ earn rate of UNI\$3.5 per S\$5 spend locally (equivalent to 1.4 miles per S\$1 spend) (the "Base Local Award"); and
 - a bonus UNI\$ earn rate under this Promotion of UNI\$7.5 per S\$5 spend on Eligible Transactions (equivalent to 3 miles per S\$1 spend) ("Bonus Award").

The Bonus Award and Bonus Overseas award shall collectively be referred to as the "Bonus Awards". For the purposes of this Promotion, "Overseas Spend" shall refer to any Eligible Transactions effected in a foreign currency and subsequently converted to Singapore Dollars at our prevailing rates in accordance with the UOB Cardmembers Agreement.

- 2.2 The maximum Bonus Awards that you may earn under this Promotion on your Eligible Transactions charged to your Card is capped at UNI\$750 (equivalent to 1,500 miles or \$\$500 worth of Eligible Transactions) for the entire duration of the Promotion Period, regardless of the total amount of Eligible Transactions successfully charged to your Card during the Promotion Period.
- 2.3 If you are one of the top 6 spenders on online shopping and/or entertainment on your UOB PRVI Miles Mastercard during the Promotion period (as determined by us at our sole discretion), you shall be eligible for one (1) Mastercard 2D1N Staycation in The Barracks Hotel Sentosa Premier Room including breakfast and lounge access with evening cocktail & canapes for 2 pax (worth S\$885) ("Gift").
- 2.4 If you are eligible for the Gift, you will receive an SMS from UOB, sent to your local mobile number that is registered with UOB, informing you of the redemption process as well as the Terms & Conditions for the redemption and use of the Gift.

- (b) "Excluded Transactions" shall mean funds to prepaid accounts (including top-ups for any prepaid card or mobile wallet such as Revolut, YouTrip, GrabPay, WeChat Pay or Alipay), NETS and NETS-related transactions, 0% Instalment Payment Plans, SimplyGo (ABT) transactions for payment of local public train and bus rides in Singapore, SmartPay, personal loan, balance/funds transfers, cash advances, fees, interests, finance charges, late payment charges, annual fee charges, reversals, other financial charges and shall further exclude:

- 2.6 Eligible Transactions incurred by the supplementary holder of your Card under this Promotion shall accrue to your Card for the purposes of this Promotion.
- 2.7 If you are eligible to earn any Bonus Awards, the relevant Bonus Awards will be credited to your Card account and reflected in your monthly UOB Credit Card statement by 31 October 2021. No advance crediting of any UNI\$ will be entertained.

3. General

3.1 Sending and receiving SMS is dependent on an SMS vendor, an independent telecommunication authority or service provider or such other third party which is engaged by UOB for the Promotion and UOB shall not be responsible or liable for any undelivered, lost or delayed SMS sent to and/or received by any person. The SMS vendor, independent telecommunication authority or service provider or such other third party is a third party and is independent and beyond the control of UOB. UOB shall not

be responsible or liable in any manner whatsoever for the delay in the transmission or receipt of any SMS or for any lost SMS.

- In the event the UNI\$ awarded is in decimal points, the final UNI\$ awarded for each transaction will be rounded down to the nearest whole figure.
- 3.3 UOB may substitute any gift(s) or awards under the Promotion with any item of equivalent or similar value, without prior notice of reason or being liable to any person.
- 3.4 The following persons shall not be eligible to participate in the Promotion:
 - (a) individuals whose UOB account(s) is/are voluntarily or involuntarily suspended, cancelled, closed or terminated at any time;
 - (b) individuals whose UOB account(s) is/are not active, valid, subsisting or in good standing or delinquent or unsatisfactorily conducted as may be determined by UOB at its sole discretion;
 - (c) individuals who are mentally unsound, facing legal incapacity or are incapable of handling their affairs, deceased, insolvent, bankrupt or have any legal proceedings (or any threat) of any nature instituted against them; or
 - (d) anyone whom UOB may decide to exclude, at its sole discretion, without any reason or prior notice at any time.
- 3.5 If you are discovered to be ineligible to participate in this Promotion or to receive the any gift or award under this Promotion, UOB may at its sole discretion forfeit the gift or award, reverse or cancel any UNI\$ already credited to your Card account.
- 3.6 UOB will not be liable or responsible for any injury, loss or damage whatsoever or for any charge, cost or expense of any kind whatsoever suffered or incurred as a result of your participation in this Promotion. Without limiting the foregoing, UOB will not be liable or responsible for any undelivered, misdirected, corrupted, lost or delayed text, transmission or transaction or any delay or failure in posting any transaction, howsoever caused.
- 3.7 UOB has the absolute right and unfettered discretion to make decisions on all matters relating to or in connection with the Promotion, including but not limited to the determination of whether you have met all the requirements of the Promotion. UOB's decisions shall be final, conclusive and binding and no payment or compensation will be given. UOB shall not be obliged to give any reason or prior notice or enter into any correspondence with any person on any matter or decision relating to the Promotion.
- 3.8 If UOB determines that you are ineligible to participate in this Promotion or to receive any UNI\$ under this Promotion, UOB may in its sole discretion forfeit the UNI\$, reclaim the UNI\$ or charge to and debit an amount equal to the value of the UN\$ from any of your accounts with UOB without prior notice to you. If the monies standing to the credit of your accounts are insufficient to

reimburse UOB, you shall immediately reimburse through such means as UOB may determine in its sole discretion.

- 3.9 The Terms shall be read in conjunction with the prevailing UOB Cardmember Agreement and any other terms that may be relevant in connection with this Promotion (collectively the "**Standard Terms**"). In the event of any inconsistency between (i) the Terms and the Standard Terms, the Terms shall prevail to the extent of such inconsistency; and (ii) the Terms and any advertising, promotional, publicity, brochure, marketing or other materials relating to or in connection with the Promotion, the Terms shall prevail to the extent that such discrepancy relates to this Promotion.
- 3.10 UOB may, at any time and at its discretion terminate the Promotion and/or amend any of the Terms, and all persons shall be bound by such amendments.
- 3.11 Unless otherwise stated, this Promotion is not valid with other offers, privileges or promotions.
- 3.12 By participating in this Promotion and in addition to any other consent you have already provided to UOB and any right of UOB under applicable laws, you consent to UOB and the necessary third parties collecting, using and disclosing your personal data for the purposes of this Promotion and to contact you, including by voice call or text message.
- 3.13 While all the information provided herein is believed to be reliable at the time and date of printing, the Bank makes no representation or warranty whether express or implied, and accepts no responsibility or liability for its completeness or accuracy.
- 3.14 A person who is not a party to the Terms shall have no rights under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce the Terms.
- 3.15 The Terms shall be governed by the laws of the Republic of Singapore and you shall be deemed to have agreed to submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
