Terms and Conditions Governing UOB "S\$10 Cash Rebate for Taobao" 2017 Promotion ("Terms and Conditions")

- 1. This "S\$10 Cash Rebate for Taobao" 2017 Promotion (the "**Promotion**") is only valid between 5 January 2017 00:00 SGT and 18 January 2017 23:59 SGT ("**Promotion Period**").
- 2. This Promotion is only applicable to holders of United Overseas Bank Limited ("UOB") consumer/personal credit and/or debit cards issued by UOB in Singapore ("Eligible Card"), and whose Eligible Card account(s) is/are valid, subsisting, in good standing and satisfactorily conducted as determined by UOB in its sole and absolute discretion ("Cardmembers"). - 5. Spending incurred on the supplementary Eligible Card shall not accrue to the principal Eligible Card.
- Each Eligible Cardmember is eligible to receive the Cash Rebate once, regardless of the number of Eligible Cards he/she has and the number of Eligible Transactions made via the Platforms, during the Promotion Period.

 - (ii) any late posting of the Eligible Transactions or for any failure in the Eligible Transactions being transacted by the Eligible Cards or being captured in UOB's system; or
