

TERMS AND CONDITIONS FOR UOB PRVI MILES AMERICAN EXPRESS[®] CARD – S\$100 CASH CREDIT FOR ONLINE AFFILIATE SITES ACQUISITION CAMPAIGN

- 1. Promotion
- 1.1 This "UOB PRVI Miles American Express[®] Card S\$100 Cash Credit for Online Affiliate Sites Acquisition Campaign" ("Promotion") is valid as per Promotion Period as stated below. By participating in this Promotion, you agree to be bound by the terms and conditions of this Promotion (the "Terms").
- 1.2 To participate in this Promotion, you must:
 - (a) submit an online application to apply for a new UOB PRVI Miles American Express[®] ("Eligible Card") with United Overseas Bank Limited ("UOB") issued in Singapore, as the principal cardholder during the Promotion Period (the "Application") strictly via the dedicated application form online links on:
 - i. **MoneySmart.sg** between 12 May 2020 to 31 May 2020, both dates inclusive (the "**MS Promotion Period**"); and
 - ii. **SingSaver PTE LTD** between 1 May 2020 to 1 June 2020, both dates inclusive (the "**SS Promotion Period**").
 - (b) have your Application approved by UOB by 30 June 2020; and
 - (c) activate your card and successfully charge a minimum of five (5) Eligible Transactions (as defined below) (the "Minimum Spend") on your Eligible Card within the first 30 calendar days from your Eligible Card approval date (the "Qualifying Spend Period").
- 1.3 You shall not be eligible to participate in the Promotion if:
 - (a) you hold an Eligible Card as at the date of your Application;
 - (b) your Application is not approved by UOB during the Promotion Period;
 - (c) you have terminated or cancelled any Eligible Card within 6 months prior to the commencement of the Promotion Period; or
 - (d) you are eligible for the promotion "UOB CREDIT CARDS UP TOS\$300 REBATE ON RECURRING BILL SPEND CAMPAIGN FOR NEW TO UOB CARD CUSTOMERS" from 26 May 2020 to 1 June 2020 via SingSaver PTE LTD.
- 1.4 UOB has the right at its discretion to approve or decline any Application and UOB shall not be required to give any reason or prior notice on any matter concerning such Application or be liable to any person.
- 1.5 Without limiting the generality of the above, the following persons shall not be eligible to participate in this Promotion:-
 - (a) individuals whose UOB card account(s) is/are voluntarily or involuntarily suspended, cancelled, closed or terminated at any time;
 - (b) individuals whose UOB card account(s) is/are not active, valid, subsisting or in good standing or which are otherwise determined by UOB as being delinquent or unsatisfactorily conducted for any reasons as may be determined by UOB at its discretion;

- (c) individuals who are mentally unsound, facing legal incapacity or is incapable of handling their affairs, deceased, insolvent, bankrupt or have any legal proceedings (or any threat) of any nature instituted against them; or
- (d) anyone whom UOB may decide to exclude, at its discretion, without any reason or prior notice at any time.
- 1.6 For the purposes of this Promotion:
 - (a) "Eligible Transactions" means collectively, the Local Card Transactions and Overseas Card Transactions.
 - (b) "Local Card Transactions" refers to transactions for the purchase of goods and/or services which are successfully charged to your UOB Card and posted on UOB's systems, and which are effected in Singapore dollars and/or at merchants with a payment gateway in Singapore, but shall exclude the Excluded Transactions. For the avoidance of doubt, online transactions effected in Singapore dollars or in foreign currencies at merchants with payment gateways in Singapore will also be treated as Local Card Transactions.
 - (c) "Overseas Card Transactions" refers to transactions for the purchase of goods and/or services which are processed outside Singapore and successfully charged to your UOB Card in a foreign currency, but shall exclude the Excluded Transactions. For the avoidance of doubt, transactions for the purchase of goods and/or services which are processed outside Singapore but which are charged or effected in Singapore dollars at the time of the transaction will be treated as a Local Card Transaction.
 - (d) "Excluded Transactions" means bill payment transactions, funds to prepaid accounts (including topups for any pre-paid card or mobile wallet such as GrabPay, WeChat Pay or Alipay), Instalment Payment Plan, NETS transactions, online money transfers, balance/funds transfers, cash advances, personal loans, fees, interests, finance charges, late payment charges, annual fee charges, reversals, other financial charges, International Processing Fee, SMART\$ transactions, gambling-related transactions, payments made to government institutions and services, member financial institutions, securities brokers and dealers, insurance companies, educational institutes, PayPal, AXS, charities or religious or political organisations, recurring bill payments, utilities bill payments, UOB PRVI Payment Facility, transactions that are unposted, subsequently cancelled, voided or reversed for any reason, and/or any other transactions as may be prescribed by UOB from time to time. - (iii) balances owing on the Eligible Card accounts accruing from months that do not fall within the Promotion Period.
- 1.7 For the avoidance of doubt:
 - (a) All Overseas Card Transactions effected in foreign currencies will be converted into Singapore dollars based on UOB's prevailing exchange rate and the Singapore dollar amount posted on UOB's system will be used for the purposes of computing the Minimum Spend under this Promotion.
 - (b) The Eligible Transactions charged by a principal holder of a UOB Card may be aggregated with the Eligible Transactions charged by the supplementary holder of that UOB Card for the purposes of computing the Minimum Spend under this Promotion.



2. Gift

- 2.1 If you have satisfied all of the conditions in Clause 1.2 above (each, an "Eligible Customer"), you shall be eligible to receive a one-time crediting of S\$100.00 cash credit into your Eligible Card (the "Gift") by 30 September 2020 and reflected in your monthly UOB Credit Card statement. No advance crediting of any Gift will be allowed.
- 2.2 You shall only be eligible to receive the Gift once, regardless of the total amount successfully charged to your Eligible Card account during the Spend Period and whether the Qualifying Spend has been satisfied on more than one Eligible Card approved pursuant to this Promotion.
- 2.3 UOB may substitute the Gift with any item of equivalent or similar value, without prior notice or reason or being liable to any person.
- 2.4 No advance or expedited crediting of the Gift will be allowed. The Gift is strictly non-transferable, nonassignable and non-exchangeable.
- 2.5 If, at any time, UOB determines at its sole and absolute discretion that any of the eligibility criteria in this Promotion was not or has not been complied with, UOB reserves the right to recover, revoke or forfeit all or any part of the Gift.
- 2.6 If you close or terminate the Eligible Card account within 9 months from the date of approval of your Application, UOB reserves right to recover, revoke or forfeit all or any part of the Gift.
- 2.7 In the event that your Eligible Card account is delinquent, voluntarily or involuntarily closed or terminated or suspended for any reason whatsoever before the Gift is credited to the Eligible Card account, the Gift shall be forfeited and you shall not be entitled to any compensation or payment whatsoever.
- 2.8 You will not be allowed to request to withdraw, transfer your Gift from your Eligible Card to any other accounts.

3 General

The General Terms and Conditions Governing Promotions set out in Appendix 1 will apply to this Promotion and form an integral part of these Terms.

Appendix 1

General Terms and Conditions Governing Promotions

- 1. The following persons shall not be eligible to participate in the Promotion:
 - (a) individuals whose UOB account(s) is/are voluntarily or involuntarily suspended, cancelled, closed or terminated at any time;
 - (b) individuals whose UOB account(s) is/are not active, valid, subsisting or in good standing or delinquent or unsatisfactorily conducted as may be determined by UOB at its sole discretion;
 - (c) individuals who are mentally unsound, facing legal incapacity or are incapable of handling their affairs, deceased, insolvent, bankrupt or have any legal proceedings (or any threat) of any nature instituted against them; or
 - (d) anyone whom UOB may decide to exclude, at its sole discretion, without any reason or prior notice at any time.
- 2. UOB will not be liable or responsible for any injury, loss or damage whatsoever or for any charge, cost or expense of any kind whatsoever suffered or incurred as a result of or in connection with the redemption or usage of the Gift or participation in this Promotion. Without limiting the foregoing, UOB will not be liable or responsible for any undelivered, misdirected, corrupted, lost or delayed text, transmission or transaction or any delay or failure in posting any transaction, howsoever caused.
- 3. UOB has the absolute right and unfettered discretion to make decisions on all matters relating to or in connection with the Promotion, including but not limited to the determination of whether you have met all the requirements of the Promotion. UOB's decisions shall be final, conclusive and binding and no payment or compensation will be given. UOB shall not be obliged to give any reason or prior notice or enter into any correspondence with any person on any matter or decision relating to the Promotion.
- 4. If UOB determines that you are ineligible to participate in this Promotion or to receive the Gift, UOB may in its sole discretion forfeit the Gift, reclaim the Gift or charge to and debit an amount equal to the value of the Gift from any of your accounts with UOB without prior notice to you. If the monies standing to the credit of your accounts are insufficient to reimburse UOB, you shall immediately reimburse UOB for the value of the Gift through such means as UOB may determine in its sole discretion.
- 5. The Terms shall be read in conjunction with the prevailing UOB Cardmember Agreement and any other terms that may be relevant in connection with this Promotion (collectively the "**Standard Terms**"). In the event of any inconsistency between (i) the Terms and the Standard Terms, the Terms shall prevail to the extent of such inconsistency; and (ii) the Terms and any advertising, promotional, publicity, brochure, marketing or other materials relating to or in connection with the Promotion, the Terms shall prevail to the extent that such discrepancy relates to this Promotion.
- 6. UOB may, at any time and at its discretion terminate the Promotion and/or amend any of the Terms, and all persons shall be bound by such amendments.
- 7. Unless otherwise stated, this Promotion is not valid with other offers, privileges or promotions.
- 8. By participating in this Promotion and in addition to any other consent you have already provided to UOB and any right of UOB under applicable laws, you consent to UOB and the necessary third parties collecting, using and disclosing your personal data for the purposes of this Promotion and to contact you, including by voice call or text message.
- 9. A person who is not a party to the Terms shall have no rights under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce the Terms.
- 10. The Terms shall be governed by the laws of the Republic of Singapore and you shall be deemed to have agreed to submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
