

TERMS AND CONDITIONS GOVERNING UNITED OVERSEAS BANK LIMITED ("UOB") CREDIT AND DEBIT CARDS S\$2 OFF PER BILL – OHM ELECTRICITY BILL PAYMENT PROMOTION ("PROMOTION") (1 OCTOBER TO 31 DECEMBER 2021) ("PROMOTION PERIOD") ("TERMS")

- 1. To participate in the Promotion, you must:
 - a. sign up for a new Fixed Ohm Price Plan or Ohm Discount Price Plan (each, a "**Plan**") for the minimum contract period(s) set out in Clause 2 below with Ohm Energy Pte Ltd ("**Ohm**") as the applicant with the **Promo Code: UOB2OHM** during the Promotion Period;
 - b. hold a personal banking Visa, Mastercard or American Express credit card or debit card (that is issued by UOB in Singapore and in good standing) ("**Card**"); and
 - c. make a Transaction on the Card.

For the purposes of this Promotion, "**Transaction**" refers to an electricity bill payment transaction made with Ohm for the Plan that is successfully charged and posted to your Card.

2. For the applicable contract period(s) for each Plan, you will receive a discount of S\$2 off your electricity bill with Ohm ("**Discount**") per Transaction in accordance with the table below:

- 3. The Discount is on a first-come-first served basis, whilst stocks last and subject to availability. The Discount is not transferable or exchangeable for cash, credit or kind (in full or in part). UOB and Ohm may substitute the Discount with any item or equivalent or similar value, without prior notice or reason or being liable to any person. UOB and Ohm shall not be required to notify or update you if the Discount is fully redeemed.
- 4. For the avoidance of doubt, you can only receive the Discount once per Transaction (up to the applicable number of Ohm electricity bills specified in Clause 2 above) for each Plan held with Ohm, regardless of the number of Cards held by you or the number of Ohm electricity bills paid by you with a Card.
- 5. The Discount will automatically apply to and be set-off against your Ohm electricity bill and only applies to charges in respect of the electricity services provided by Ohm under the applicable section of your SP Group electricity bill. The Discount is only open to you so long as Ohm has not received a notification of your transfer to another electricity retailer or to the SP Group at the time of issuance of the electricity bill by Ohm.
- 6. Ohm may recover the full or a pro-rated amount of the Discount if the contract in respect to the Plan is terminated prematurely or if you change your price plan within the trial period. The Discount will only apply to your first Plan with Ohm and will not apply to existing Plans which are subsequently renewed.

The prevailing UOB Cardmember Agreement or UOB Debit Cardmember Agreement (as applicable), the applicable terms governing your electricity bill payment and any other terms that may be relevant in connection with this Promotion (collectively, the "**Standard Terms**") continue to apply to your Card account(s). In the event of any inconsistency between these Terms and the Standard Terms, these Terms shall to, the extent of such inconsistency, prevail in respect of matters relating to this Promotion.
- 13. These Terms shall be governed by the laws of the Republic of Singapore, and you agree to submit to the exclusive jurisdiction of the Singapore courts. A person not a party to these Terms has no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B) of Singapore to enforce these Terms.
