

## **Terms and Conditions Governing UOB Travel Insurance Exclusive KF/PRVI Offer 2019 Promotion (“Promotion”)**

### **1. DEFINITIONS**

“**Customer**” means a customer who purchased a UOI Insure & Travel Policy from [www.uob.com.sg/insuretravel](http://www.uob.com.sg/insuretravel) by entering “**Flyer60**” as Promo Code.

“**Eligible Policy**” means a Single Trip UOI Insure & Travel Essential and/or Preferred Policy (Individual and/or Family plan).

“**Premium**” in respect of an Eligible Policy, refers to the total insurance premium payable for that Applicable Plan as stated at [www.uob.com.sg/insuretravel](http://www.uob.com.sg/insuretravel).

“**Promotion**” means this UOB Travel Insurance Exclusive KF/PRVI Offer 2019 Promotion.

“**Promotional Period**” means the period from 25 April 2019 to 31 December 2019, both dates inclusive.

“**Eligible UOB Card**” refers to KrisFlyer UOB Credit/Debit and/or UOB PRVI Miles Card.

“**UOB Card**” refers to a MasterCard/Visa credit or debit card which is issued by UOB in Singapore and which card is valid, subsisting, in good standing and satisfactorily conducted as determined by UOB in its sole and absolute discretion.

“**Third Party Card**” refers to any MasterCard/Visa credit or debit card maintained with another bank or financial institution (apart from UOB) and which card is valid, subsisting, in good standing and satisfactorily conducted; and from which funds may be applied for the payment of Premium(s) for any Applicable Plan(s).

“**Card**” refers to each or any UOB Card and Third Party Card.

“**UOB**” means United Overseas Bank Limited.

“**UOI**” means United Overseas Insurance Limited.

### **2. PROMOTION AND ELIGIBILITY**

#### **A. Premium Discounts**

2.1 Under this Promotion, only Premiums successfully charged to an Eligible UOB Card shall be entitled to the following discounts:

- 60% discount on the Premium if the Premium charged is in respect of the Eligible Policy.

### **3. Participation and Personal Data**

- 3.1 By participating in this Promotion, Customers/ applicants / policy holders:
  - 3.1.1 agree to be bound by the rules, regulations and decisions of UOB and/or UOI, and by the terms contained herein. Failure to comply with any of the foregoing will result in a disqualification from the Promotion; and,
  - 3.1.2 are deemed to have consented to the collection, use and disclosure of his/her personal data by UOB and/or UOI, sponsors, promoters and/or their respective contractors for verifying the eligibility of the participants and contacting the participant regarding the foregoing, for post-travel insurance claim(s) (if any), and for all purposes incidental to this Promotion.

### **4. GENERAL**

Notwithstanding anything herein to the contrary, UOB has the sole and absolute discretion at any time and from time to time to determine the eligibility of any Customer for the Promotion and shall not be obliged to give any reason therefor and shall not be obliged to make any payment or compensation whatsoever.
- 4.4 UOB reserves the right, at its sole and absolute discretion and at any time and without giving prior notice or any reason, to vary, amend, add or delete any of these Terms and Conditions herein (including but not limited to the Promotional Period, Gift, or any other eligibility terms and criteria, and the timing of any act to be done) without giving any reason, prior notice and/or without assuming any liability to any person, and the Customer shall be deemed to have consented to such variations, amendments, additions or deletions.
