

**UOB Credit Card – Transit Mobile Payment Draw (“Draw”)
Terms and Conditions (“Terms and Conditions”)**

1. Eligibility

- 1.1 This Draw is only open to all principal holders of an Eligible Card (as hereinafter defined). For the purposes of these Terms and Conditions, “**UOB Card**” refers to any personal Visa, and Mastercard credit and debit card issued by UOB in Singapore, but does not include any UOB Reserve Card, UOB Privilege Banking Card, UOB Visa Infinite Card, UOB Visa Infinite Metal Card, UOB Travel Account cards, UOB Corporate cards, UOB Purchasing cards, UOB Business cards, UOB multicurrency corporate and Private Label cards.
- 1.2 By participating in this Draw, you are deemed to have agreed to be bound by these Terms and Conditions.

2. Lucky Draw Mechanics

- 2.1 To participate in the Draw:
- (a) you must be an existing or new registered user of SimplyGo; and
 - (b) you must tap and pay for your public bus or train rides with SimplyGo via mobile payment wallets such as Apple Pay, Fitbit Pay, Google Pay, UOB Mighty Pay or Samsung Pay (or such other mobile payment wallet that UOB may determine in its sole discretion) (the “**Qualifying Transaction**”) during the period commencing from 25 January 2021 to 30 April 2021 (both dates inclusive) (the “**Qualifying Period**”).
- 2.2 If you meet all the requirements in these Terms and Conditions, you will be awarded with one chance in the Draw for every S\$10 worth of Qualifying Transactions successfully charged to your UOB Card during the Qualifying Period. The S\$10 per chance requirement will be calculated based on Qualifying Transactions charged to your same UOB Card using your same mobile wallet during the Qualifying Period.
- 2.3 Only Qualifying Transactions which are posted on UOB’s systems as “BUS/MRT” transaction will qualify for the Draw.
- 2.4 There is no cap on the number of chances that you may be awarded in the Draw for each calendar day of the Qualifying Period.
- 2.5 Upon the awarding of a chance in the Draw to you, your name will be submitted to the Draw pool and you will be enrolled into the Draw automatically without any registration required.

3. Draw

- 3.1 The Draw will be conducted using an electronic system on 25 June 2021 (the “**Draw Date**”) at 480 Toa Payoh Lorong 6, #25-01, HDB Hub East Wing, Singapore 310480 (or such other date, time or location as UOB may determine at its own discretion without prior notice). The Draw will be witnessed by an external auditor appointed by UOB at its sole discretion.
- 3.2 A total of 10 winners will be selected at random on the Draw Date (the “**Winners**”). UOB reserves the right to draw reserve winners to replace any winner who is or may be subsequently found to be ineligible or disqualified from the Draw.
- 3.3 You can only be selected as a Winner once in this Draw.

4. Prize

- 4.1 All Winners will each be eligible to receive a Fitbit Charge 4 (storm blue) worth S\$248 (the “**Prize**”).
- 4.2 If you are selected as a Winner, your Prize redemption details will be sent to you via SMS to the Singapore mobile number on UOB’s records by 31 July 2021 (or such later date as UOB may determine in its sole discretion) (the “**Redemption Notice**”).
- 4.3 The Prize must be redeemed during the redemption period stated in the Redemption Notice. UOB will not extend the redemption period for any reason whatsoever. Any Prize that is not redeemed within the redemption period will be forfeited and you shall not be entitled to any compensation or replacement.
- 4.4 The Prize is not transferable or exchangeable for cash, credit, goods and services, products or privileges or other kind in full or in part and is not refundable or replaceable. No reservation, refund or exchange of any Prize is allowed.
- 4.5 UOB reserves the right to replace the Prize with another item of similar value without giving any reason or prior notice or assuming any liability to any person.
- 4.6 The Prizes are supplied by third party merchants and UOB is not an agent of the merchant and/or supplier of the Prizes. Accordingly, UOB makes no warranty or representation as to the quality, value, merchantability or fitness for purpose of the Prizes and UOB assumes no liability or responsibility for the acts or omissions of the merchants or any non-performance or defects in the Prizes. Any dispute regarding any Prize is to be resolved directly with the merchant and/or supplier of the Prize. UOB shall not be required to assist or act on your behalf in communicating with the merchant and/or supplier of the Prize.

5. General

- 5.1 The following persons shall not be eligible to participate in the Draw:
- (a) directors or employees of UOB;
 - (b) employees of UOB’s partners including advertising and promotion agencies and any other persons involved in organizing, promoting and/or conducting the Draw;
 - (c) individuals whose UOB account(s) is/are voluntarily or involuntarily suspended, cancelled, closed or terminated at any time;
 - (d) individuals whose UOB account(s) is/are not active, valid, subsisting or in good standing or delinquent or unsatisfactorily conducted as may be determined by UOB at its sole discretion;
 - (e) any individual who has not complied with any provision of these Terms and Conditions;
 - (f) individuals who are mentally unsound, facing legal incapacity or are incapable of handling their affairs, deceased, insolvent, bankrupt or have any legal proceedings (or any threat) of any nature instituted against them; or
 - (g) anyone whom UOB may decide to exclude, at its sole discretion, without any reason or prior notice at any time.
- 5.2 UOB will not be liable or responsible for any injury, loss or damage whatsoever or for any charge, cost or expense of any kind whatsoever suffered or incurred as a result of or in connection with your participation in this Draw. Without limiting the foregoing, UOB will not be liable or

responsible for any undelivered, misdirected, corrupted, lost or delayed text, transmission or transaction or any delay or failure in posting any transaction or accessing any of UOB's online banking services or mobile banking services or third party applications, howsoever caused.

- 5.3 UOB has the absolute right and unfettered discretion to make decisions on all matters relating to or in connection with the Draw, including but not limited to the determination of whether you qualify for the Draw. UOB's decisions shall be final, conclusive and binding and no payment or compensation will be given. UOB shall not be obliged to give any reason or prior notice or enter into any correspondence with any person on any matter or decision relating to the Draw, including the reasons for any disqualification from the Draw.
- 5.4 If UOB determines that you are ineligible to participate in the Draw or to receive the Prize, UOB may in its sole discretion forfeit the Prize, reclaim the Prize or charge to and debit an amount equal to the value of the Prize from any of your accounts with UOB without prior notice to you. If the monies standing to the credit of your accounts are insufficient to reimburse UOB, you shall immediately reimburse UOB for the value of the Prize through such means as UOB may determine in its sole discretion. A participant whose Prize has been forfeited shall not be entitled to any payment or compensation whatsoever from the Bank.
- 5.5 The Terms and Conditions shall be read in conjunction with the prevailing UOB Cardmembers Agreement and any other terms that may be relevant in connection with this Draw (collectively the "**Standard Terms**"). In the event of any inconsistency between (i) the Terms and Conditions and the Standard Terms, the Terms and Conditions shall prevail to the extent of such inconsistency; and (ii) the Terms and Conditions and any advertising, promotional, publicity, brochure, marketing or other materials relating to or in connection with the Draw, the Terms and Conditions shall prevail to the extent that such discrepancy relates to this Draw.
- 5.6 UOB may, at any time and at its discretion terminate or suspend the Draw and/or amend any of the Terms and Conditions, and all persons shall be bound by such amendments.
- 5.7 Unless otherwise stated, this Draw is not valid with other offers, privileges or promotions.
- 5.8 By participating in this Draw and in addition to any other consent you have already provided to UOB and any right of UOB under applicable laws, you consent to UOB and the necessary third parties collecting, using and disclosing your information (including your name and contact information) for all purposes in connection with this Draw (including for all legal purposes, identifying you as a Winner and announcing the Winners on UOB's website) and to contact you, including by voice call or text message. The Winners shall, if required by UOB, attend any prize presentation and participate in any advertising, promotional and publicity activities relating to or in connection with this Draw at his/her own costs.
- 5.9 A person who is not a party to these Terms and Conditions shall have no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B) of Singapore to enforce any term herein.
- 5.10 The Terms and Conditions shall be governed by the laws of the Republic of Singapore and you shall be deemed to have agreed to submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
