UOB PRVI Miles Card – Up to 4.4 miles per S\$1 Online Spend On Recurring Bill Campaign (the "Promotion") Terms and Conditions (the "Terms and Conditions")

## 1. Eligibility

- 1.1 This Promotion is valid from 8 October 2020 to 31 December 2020, both dates inclusive (the "**Promotion Period**"). By participating in this Promotion, you agree to be bound by these Terms and Conditions.
- 1.2 This Promotion is open to all principal holders of a UOB PRVI Miles World Mastercard or Visa Card ("Card") that is issued by United Overseas Bank Limited ("UOB") in Singapore.
- 1.3 To participate in this Promotion, you as a principal holder must successfully register to participate in this Promotion by sending in an SMS to 77862 using your mobile number registered with UOB during the Promotion Period in the following format (the "SMS Registration"):

## PRB<space>Last 4 alphanumeric digits of your NRIC or Passport Number

Example: If your NRIC is S1234567A, you will need to send "PRB 567A" to 77862.

- 1.4 All SMS Registrations for this Promotion which are not in the format prescribed in these Terms and Conditions, sent to an incorrect number, sent from a mobile number which is not registered with UOB, sent by the supplementary holder, or sent outside of the Promotion Period will be null and void.
- 1.5 For the avoidance of doubt, you will only need to register once for this Promotion within the Promotion Period to participate in the Promotion.

## 2. Recurring Bill Promotion

- 2.1 During the Promotion Period, you shall be eligible to earn up to UNI\$11 per S\$5 spend on Eligible Online Recurring Bill Transactions (equivalent to 4.4 miles per S\$1 spend) using your Card. This is based on:
  - (a) the existing rate of UNI\$3.5 per S\$5 local spend on Online Recurring Bill Transactions (equivalent to 1.4 miles per S\$1 spend) (the "Base Local Award"); and
  - (b) a bonus rate of UNI\$7.5 per S\$5 local spend on Online Recurring Bill Transactions (equivalent to 3 miles per S\$1 spend) (the "Bonus Local Award").

Or

(a) the existing rate of UNI\$6 per S\$5 overseas spend on Online Recurring Bill Transactions (equivalent to 2.4 miles per S\$1 spend) (the "Base Overseas Award"); and



- (b) a bonus rate of UNI\$5 per S\$5 overseas spend on Online Recurring Bill Transactions (equivalent to 2 miles per S\$1 spend) (the "Bonus Overseas Award").
- 2.2 The maximum Bonus Local Award and Bonus Overseas Award that you may earn for each calendar month is capped at UNI\$150 (equivalent to 300 miles). For the avoidance of doubt, there is no cap on the Base Local Award or Base Overseas Award that you may be eligible to earn on your Online Recurring Bill Transactions during the Promotion Period.
- 2.3 For the purposes of the Promotion:
  - (a) "Online Recurring Bill Transactions" refers to Transactions successfully posted to your Card from any of the Participating Merchants, excluding the Excluded Transactions and are processed by the respective merchants as online transactions via a payment gateway;

  - i. transactions which do not fall under the list of Participating Merchants set out below;



- ii. cash advance, late payment, personal loan, balance and/or funds transfer, SmartPay, funds to pre-paid cards or mobile wallets, fees, chargebacks, interests, reversals, interest charges and any finance charges;
- iii. balances owing on your Card account(s) accruing from months that do not fall within the Spend Period;
- iv. any transaction that was subsequently cancelled, voided, disputed or reversed for any reason; and/or
- v. such other categories of transactions which UOB may exclude from time to time without notice or giving reasons.

- 2.4 If you are eligible to earn the Bonus Award, the Bonus Award will be credited to your Card account by 31 March 2021 and reflected in your monthly UOB Credit Card statement. No advance crediting of any UNI\$ will be entertained.

## 3. General

- 3.1 Sending and receiving SMS is dependent on an SMS vendor, an independent telecommunication authority or service provider or such other third party which is engaged by UOB for the Promotion and UOB shall not be responsible or liable for any undelivered, lost or delayed SMS sent to and/or received by any person. You shall pay and be solely responsible for all fees and charges imposed by your service providers for the sending and/or receipt of any SMS in connection with the Promotion. The SMS vendor, independent telecommunication authority or service provider or such other third party is a third party and is independent and beyond the control of UOB. UOB shall not be responsible or liable in any manner whatsoever for the delay in the transmission or receipt of any SMS or for any lost SMS.
- In the event the UNI\$ awarded is in decimal points, the final UNI\$ awarded for each transaction will be rounded down to the nearest whole figure.
- 3.3 You shall only be eligible to earn the Bonus Award for the Overseas Spend Promotion once during the entire Promotion Period and the Bonus Transit Award for the Bus or Train Rides via Mobile Contactless Payment Promotion once per month during the Promotion Period, regardless on the number of Cards you hold.
- 3.4 UOB may substitute the awards under the Promotion with any item of equivalent or similar value, without prior notice of reason or being liable to any person.
- 3.5 UOB will not be liable or responsible for any injury, loss or damage whatsoever or for any charge, cost or expense of any kind whatsoever suffered or incurred as a result of or in connection with this Promotion.
