UOB PRVI Miles Card – Up to 4.4 miles per S\$1 Spend Campaign (the "Promotion") Terms and Conditions (the "Terms and Conditions")

1. Eligibility

- 1.1 This Promotion is valid from 18 October 2019 to 31 December 2019, both dates inclusive (the "**Promotion Period**"). By participating in this Promotion, you agree to be bound by these Terms and Conditions.
- 1.2 This Promotion consists of
 - (a) the Overseas Spend Promotion; and
 - (b) the Bus or Train Rides via Mobile Contactless Payment Promotion; and

is open to all principal holders of a UOB PRVI Miles American Express®, World Mastercard or Visa Card ("Card") that is issued by United Overseas Bank Limited ("UOB") in Singapore.

1.3 To participate in this Promotion, you must successfully register to participate in this Promotion by sending in an SMS to 77862 using your mobile number registered with UOB during the Promotion Period in the following format (the "SMS Registration"):

PRVI<space>Last 4 alphanumeric digits of your NRIC or Passport Number

Example: If your NRIC is S1234567A, you will need to send "PRVI 567A" to 77862.

- 1.4 All SMS Registrations for this Promotion which are not in the format prescribed in these Terms and Conditions, sent to an incorrect number, sent from a mobile number which is not registered with UOB, or sent outside of the Promotion Period will be null and void.
- 1.5 For the avoidance of doubt, you will only need to register once for this Promotion within the Promotion Period to participate in both the Overseas Spend Promotion and the Bus or Train Rides via Mobile Contactless Payment Promotion. Separate registrations are not required.

2. Overseas Spend Promotion

- 2.1 During the Promotion Period, you shall be eligible to earn up to UNI\$11 per S\$5 spend on Eligible Overseas Transactions (equivalent to 4.4 miles per S\$1 spend) using your Card. This is based on:
 - the existing rate of UNI\$6 per S\$5 spend on Eligible Overseas Transactions (equivalent to 2.4 miles per S\$1 spend) (the "Base Award"); and
 - (b) a bonus rate of UNI\$5 per S\$5 spend on Eligible Overseas Transactions (equivalent to 2 miles per S\$1 spend) (the "Bonus Award").

2.2 The maximum Bonus Award that you may earn for the entire duration of the Promotion Period is capped at UNI\$3,000 (which is equivalent to S\$3,000 worth of Eligible Overseas Transactions). For the avoidance of doubt, there is no cap on the Base Award that you may be eligible to earn on your Eligible Overseas Transactions during the Promotion Period.

2.3 For the purposes of the Promotion:

(a) "Eligible Overseas Transactions" refers to Dining Transactions, Shopping Transactions (including online Shopping Transactions) and Accommodation Transactions which are processed out of Singapore and successfully charged to your Card in a foreign currency, and posted on UOB's system but shall exclude the Excluded Transactions.

For the avoidance of doubt, transactions which are processed out of Singapore but which are charged or effected in Singapore dollars at the time of the transaction will not constitute an Eligible Overseas Transaction. All Eligible Overseas Transactions effected in foreign currencies will be converted into Singapore dollars based on UOB's prevailing exchange rate and the Singapore dollar amount posted on UOB's system will be used for the purposes of computing the minimum spend amount under this Promotion.

(b) "Excluded Transactions" shall mean:-

- i. transactions in dynamic currency conversion (Singapore dollar transactions processed outside Singapore);
- ii. overseas transactions made in foreign currency which do not fall under the list of Dining Transactions, Shopping Transactions and Accommodation Transactions set out below;
- iii. cash advance, late payment, personal loan, balance and/or funds transfer, SmartPay, funds to pre-paid cards or mobile wallets, fees, chargebacks, interests, reversals, interest charges and any finance charges;
- iv. balances owing on your Card account(s) accruing from months that do not fall within the Spend Period;
- v. any transaction that was subsequently cancelled, voided, disputed or reversed for any reason; and/or
- vi. such other categories of transactions which UOB may exclude from time to time without notice or giving reasons.
- (c) Eligible Overseas Transactions incurred by the supplementary holder of your Card under this Promotion shall accrue to your Card for the purposes of this Promotion.



(d) "Dining Transactions" refers to food and beverage transactions, excluding all food and beverage transactions within hotels and country clubs and grocery stores and supermarkets, which fall under any one of the following Merchant Category Codes ("MCC"):

(f) "Accommodation Transactions" refers to hotels or lodging transactions (either online or offline and where the payment gateway is outside of Singapore, paid directly to the hotel or lodging) which falls under any one of the following MCC:

For the avoidance of doubt, hotels or lodging transactions made via and paid directly to online travel agencies or travel services agencies/companies do not qualify as Eligible Overseas Transactions.

- (g) UOB reserves the right, at any time and at its discretion, to amend or vary the list above without any reasons, prior notification and/or assuming any liability to any party and shall not be liable to pay any compensation or enter into any correspondence in connection with the same.
- 2.4 If you are eligible to earn the Bonus Award, the Bonus Award will be credited to your Card account by 31 March 2020 and reflected in your monthly UOB Credit Card statement. No advance crediting of any UNI\$ will be entertained.

3. Bus or Train Rides via Mobile Contactless Payment Promotion

- 3.1 During the Promotion Period, you shall be eligible to earn up to UNI\$11 per S\$5 spend on Eligible Transit Transactions (equivalent to up to 4.4 miles per S\$1 spend) using your UOB PRVI Miles World Mastercard or Visa Card ("Transit Card"). This is based on:
 - (a) the existing rate of UNI\$3.5 per S\$5 spend locally (equivalent to 1.4 miles per S\$1 spend) (the "Base Transit Award"); and
 - (b) a bonus rate of UNI\$7.5 per S\$5 spend on Eligible Transit Transactions (equivalent to 3 miles per S\$1 spend) ("Bonus Transit Award").

- 3.2 The maximum Bonus Transit Award which you may earn under the Bus or Train Rides via Mobile Contactless Payment Promotion during the Promotion Period is capped at UNI\$120 per month (which is equivalent to S\$80 worth of Eligible Transit Transactions per month).
- 3.3 For the purposes of the Promotion:
 - (a) "Eligible Transit Transactions" shall mean all SimplyGo (ABT) mobile contactless transactions for payment of local public train and bus rides in Singapore which is successfully charged to your Transit Card via Apple Pay, Fitbit Pay, Google Pay and/or Samsung Pay, and posted on UOB's systems. For the avoidance of doubt, payment made by tapping your physical Transit Card at the reader does not constitute an Eligible Transit Transaction.
 - (b) "Excluded Transactions" shall mean:
 - balances owing on the Transit Card accounts accruing from months that do not fall within the Promotion Period:
 - ii. any transaction that was subsequently cancelled, voided, disputed or reversed for any reason; and/or
 - iii. such other categories of transactions which UOB may exclude from time to time without notice or giving reasons.
 - (c) UOB reserves the right, at any time and at its discretion, to amend or vary the above list without any reasons, prior notification and/or assuming any liability to any party and shall not be liable to pay any compensation or enter into any correspondence in connection with the same.
 - (d) Eligible Transit Transactions incurred by the supplementary holder of your Transit Card under this Promotion shall accrue to your Transit Card for the purposes of this Promotion.
- 3.4 If you are eligible to earn the Transit Award, the Transit Award will be credited to your Transit Card account by 31 March 2020 and reflected in your monthly UOB Credit Card statement. No advance crediting of any UNI\$ will be entertained.

4. General

4.1 Sending and receiving SMS is dependent on an SMS vendor, an independent telecommunication authority or service provider or such other third party which is engaged by UOB for the Promotion and UOB shall not be responsible or liable for any undelivered, lost or delayed SMS sent to and/or received by any person. You shall pay and be solely responsible for all fees and charges imposed by your service providers for the sending and/or receipt of any SMS in connection with the Promotion. The SMS vendor, independent telecommunication authority or service provider or such other third party is a third party and is independent and beyond the control of UOB. UOB

shall not be responsible or liable in any manner whatsoever for the delay in the transmission or receipt of any SMS or for any lost SMS.

- In the event the UNI\$ awarded is in decimal points, the final UNI\$ awarded for each transaction will be rounded down to the nearest whole figure.
- 4.3 You shall only be eligible to earn the Bonus Award for the Overseas Spend Promotion once during the entire Promotion Period and the Bonus Transit Award for the Bus or Train Rides via Mobile Contactless Payment Promotion once per month during the Promotion Period, regardless on the number of Cards you hold.
- 4.4 UOB may substitute the awards under the Promotion with any item of equivalent or similar value, without prior notice of reason or being liable to any person.
- 4.5 UOB will not be liable or responsible for any injury, loss or damage whatsoever or for any charge, cost or expense of any kind whatsoever suffered or incurred as a result of or in connection with this Promotion. UOB shall not be responsible for any failure or delay in the transmission of the transactions by any party including but not limited to any card association, any telecommunication provider or any other service provider.
- 4.6 If your Card account is not validly subsisting and in good standing, is closed, terminated and/or suspended for any reason whatsoever during the Promotion Period or before any award under this Promotion is credited, you will not be entitled to receive any such award.
- 4.7 UOB has the absolute right and unfettered discretion to make decisions on all matters relating to or in connection with the Promotion, including but not limited to the determination of whether you have met all the requirements of the Promotion, determination as to whether a transaction qualifies to be eligible and determination of the UNI\$ to be awarded to you under this Promotion. UOB's decisions shall be final, conclusive and binding on all parties concerned and no payment or compensation will be given. The Bank shall not be obliged to give any reason or prior notice or enter into any correspondence with any person on any matter relating to the Promotion or its decision or to assume any liability to any person and no appeal, correspondence or claims will be entertained.
- 4.8 If you are discovered to be ineligible to participate in this Promotion or to receive the any award under this Promotion, UOB may at its sole discretion forfeit the award, reverse or cancel any UNI\$ already credited to your Card account.
- 4.9 These Terms and Conditions shall be read in conjunction with the prevailing UOB Cardmember Agreement and any other terms that may be relevant in connection with this Promotion (collectively the "Standard Terms"). In the event of any inconsistency between (i) the Terms and Conditions and the Standard Terms, the Terms and Conditions shall prevail to the extent of such inconsistency; and (ii) the Terms and Conditions and any advertising, promotional, publicity, brochure, marketing or other materials relating to or in connection with the Promotion, the Terms and Conditions shall prevail to the extent that such discrepancy relates to this Promotion.

- 4.12 While all the information provided herein is believed to be reliable at the time and date of printing, the Bank makes no representation or warranty whether express or implied, and accepts no responsibility or liability for its completeness or accuracy.
- 4.13 These Terms and Conditions shall be governed by the laws of the Republic of Singapore and you hereby agree to submit to the exclusive jurisdiction of the courts of Singapore.
- 4.14 A person who is not a party to the terms and conditions herein and/or any agreement governed by the terms and conditions herein shall have no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any term of such agreement or any of the terms and conditions herein.
