The UOB Business World Debit Card can be used to make retail purchases with either Point-of-Sale (PIN/Signature) or Card-Not-Present (Online, Mail, Telephone Order) payment. The funds are directly debited from the bank account that is linked to your card. Please ensure that your card is kept safely to prevent unauthorised usage.
