

**UOB Business Banking Q3 2023 Trade Utilisation Promotion**  
**Terms and Conditions**

1. The UOB Business Banking Q3 2023 Trade Utilisation Promotion (“**Promotion**”) is applicable to all Trade Customers of the Business Banking segment of United Overseas Bank Limited (“**UOB**”) (“**Eligible Customers**”). Promotion will be valid for the period of 1<sup>st</sup> July 2023 to 30<sup>th</sup> September 2023 (“**Promotion Period**”).

For the purposes of this paragraph and these Terms and Conditions:-

“**Trade Customers**” refer to customers who have existing trade facilities with UOB Business Banking during the Promotion Period.

2. During the Promotion Period, Eligible Customers whose aggregate amount of new Trade Bills (as defined below) transacted meet the respective Reward Tiers illustrated in clause 4.1 (“**Qualified Customers**”) will receive the corresponding shopping vouchers (“**Reward**”).

For the purposes of this paragraph and these Terms and Conditions:-

“**Trade Bills**” refer to bills transacted under any of the following trade facilities with UOB:

- (i) Trust Receipt;
- (ii) Trust Receipt – Invoice Financing;
- (iii) Trust Receipt – Documents against Acceptance/Documents against Payment;
- (iv) Trust Receipt – Pre-shipment Financing;
- (v) Bills of Exchange Purchased – Export Invoice Finance; or
- (vi) Bills of Exchange Purchased – Documents against Acceptance/Documents against Payment.

3. Without limiting the generality of the foregoing, the following Eligible Customers shall not be eligible for this Promotion:-

- (i) Eligible Customers who are a staff or employee of UOB;
- (ii) Eligible Customers who are or have become mentally incapacitated, deceased, insolvent, bankrupt, wound up or who faces legal incapacity or incapable of handling their affairs;
- (iii) Eligible Customers who have any legal proceedings (or any threat) of any nature instituted against them;
- (iv) Eligible Customers who UOB may decide to exclude at its discretion without prior notice and without furnishing any reason, at any time.

Notwithstanding anything herein to the contrary, UOB has the absolute discretion, at any time and from time to time and without having to give any notice or prior reason or being liable to any person, to determine on the eligibility of the Eligible Customers to participate in this Promotion and shall not be obliged to give any reasons for disqualifying such persons.

4. A redemption letter detailing the redemption process for the Reward (“**Redemption Letter**”) will be sent out within one (1) month from the end of the Promotion Period (or such later date as determined by UOB).

4.1 Reward Tiers

Aggregate New Trade Bill* Amount submitted to UOB within Promotion Period	Reward
$S\$250,000 \leq X < S\$500,000$	S\$100 shopping voucher + S\$100 UOB Trade Services Vouchers
$S\$500,000 \leq X < S\$750,000$	S\$200 shopping voucher + S\$200 UOB Trade Services Vouchers
$X \geq S\$750,000$	S\$300 shopping voucher + S\$300 UOB Trade Services Vouchers

\* **Trade Bills** – refers to bills transacted on the following facilities; TR, TR-IF, TR-DA/DP, TR-Pre-shipment, BEP-EIF (against corporate line) and BEP-DA/DP (against corporate line).

"X" referring to aggregated new trade bill amount submitted to UOB  
Each Qualified Customer is limited to one Reward only.

- 4.2 The Reward is available on a first come first served basis, whilst stocks last.
  - 4.3 The Reward must be redeemed within the time period set out in the Redemption Letter. Otherwise, the Reward will be forfeited without any compensation whatsoever.
  - 4.4 UOB will not be liable or responsible for any defects, deficiency, quality, merchantability, the fitness or any other aspect of the Reward.
  - 4.5 UOB will not be liable or responsible for any injury, loss or damage whatsoever or for any charge, cost or expense of any kind whatsoever suffered or incurred as a result of or in connection with the redemption or usage of the Reward or participation in this Promotion.
  - 4.6 Any Redemption Letter that has expired or which is lost, misplaced, defaced, stolen or tampered with, misdirected or damaged is strictly non-replaceable. No payment or compensation whether in cash, credit or kind or any replacement shall be made or issued for any Redemption Letter which has expired or which is lost, misplaced, defaced, stolen, been tampered with, misdirected or damaged.
- 5 The Reward offered under this Promotion are not transferable or exchangeable for credit, other products or privileges in full or in part and is not refundable or replaceable. UOB may, at any time without notice and without furnishing any reason and in its absolute discretion, withdraw or substitute the Reward with other items of similar value. UOB's determination of the substituted Reward shall be final, conclusive and binding.
  - 6 If a Qualified Customer or an Eligible Customer is subsequently found to be ineligible or disqualified for any reason, UOB reserves the right at its absolute discretion to subsequently withdraw/forfeit the Reward, and/or (if already awarded) reclaim the value of the Reward through such modes and methods as UOB may so decide at its absolute discretion, including, but not limited to, deducting from the Qualified Customer's accounts with UOB, sums equal to the value of the Reward. No party shall be entitled to any payment or other compensation in such an event.
  - 7 Notwithstanding anything to the contrary, UOB may, at its absolute discretion, change or add to any of the terms and conditions of this Promotion. UOB's determination of all matters in connection with this Promotion shall be final, binding and conclusive. No appeal, communication and/or correspondence will be entertained. The decisions of UOB on all matters relating to this Promotion are at its discretion and final, conclusive and binding. UOB shall not be obliged to give any reason, prior notice or enter into any correspondence with any person on any matter concerning this Promotion. No appeal, claims or payment of compensation will be entertained. UOB has the right and discretion to determine whether a Qualified Customer or an Eligible Customer has met all the requirements of this Promotion and/or to receive the Reward.
  - 8 In the event of any inconsistency between the terms and conditions of this Promotion herein and any advertising, publicity, brochure, marketing or promotional material or other materials relating to or in connection with this Promotion, the terms and conditions of this Promotion herein shall prevail.
  - 9 By participating in this Promotion and receipt of the Reward:-
    - (a) each Eligible Customer and each Qualified Customer have agreed to be bound by the rules, regulations and decisions of UOB, by the terms and conditions of this Promotion. Failure to comply with any of the foregoing will result in a disqualification to receive the Reward; **AND**
    - (b) each Eligible Customer and each Qualified Customer is also deemed to have obtained the consent of its shareholders, beneficial owners, directors, employees, guarantors and authorised representatives collectively referred to as ("**Relevant Individual**") to the collection, use and disclosure of such Relevant Individual's personal data by UOB, the organizers, sponsors, promoters and/or their respective contractors for verifying its eligibility to receive the Reward.
  - 10 This Promotion is not valid with other promotions, discounts or offers unless otherwise stated.
