

## Product Addendum BizGlobal Account Terms ("BizGlobal Terms")

### 1. General

- 1.1 Reference is made to our General Terms Governing Accounts and Services (Non-Individual Customers) (the "**General Terms**") and your Country Addendum thereto as may be applicable, each as may be amended, restated, supplemented or varied by us from time to time (the "**Customer Agreement**"). This is a "**Product Addendum**" referred to in the General Terms.
- 1.2 Capitalised terms used but not defined in this Product Addendum shall have the meaning given to them in the Customer Agreement.
- 1.3 In the event of any conflict or inconsistency between any of the provisions of these BizGlobal Terms and any of the provisions of the Customer Agreement, the provisions of these BizGlobal Terms shall prevail to the extent necessary to give effect to the BizGlobal Terms.
- 1.4 These BizGlobal Terms shall apply to your Corporate USD Current Account as approved by us as a BizGlobal Account ("**BizGlobal Account**").

### 2. Definitions

"**Business Internet Banking**" means the business internet banking system from time to time made available by us, enabling you to communicate and/or perform transactions with us through any Equipment;

"**eAlert Service**" means the service of sending specified information via email, SMS, and/or other media we deem appropriate;

"**Equipment**" means any electronic, wireless, communication, transmission, or telecommunications equipment, device (including mobile devices), or medium required to access and use the Business Internet Banking services.

### 3. Products

- 3.1 Subject to clause 3.4, your BizGlobal Account will have access to the following products ("**Products**") at the specified pricing, subject to the relevant Product Addenda or other terms and conditions as prescribed by us for these Products:

- 3.2 The debit amounts made against your BizGlobal Account for your usage of the Product(s) or account service charges (“**Charges**”) are available on our website and subject to change at our discretion. You will be notified of any changes to the pricing of the Product(s).
- 3.3 You must register for Business Internet Banking for your BizGlobal Account and link your BizGlobal Account to Business Internet Banking.
- 3.4 You also agree to designate your BizGlobal Account as the “Designated Account for Fees and Charges” for the eAlert Service. If you fail to do so, you will not receive the specified pricing which is a lower pricing than the pricing available if other forms of payment are used for fees and charges related to the eAlert Service.
- 3.5 Our decision on all matters in connection with your BizGlobal Account shall be final, conclusive and binding on all parties.

#### 4. Closure/Conversion of BizGlobal Account

- 4.1 Upon closure of your BizGlobal Account or conversion of your BizGlobal Account to another Account, our standard transaction and service fees will apply which shall be paid by you.

#### 5. Rights and Remedies

- 5.1 Our rights and remedies under these BizGlobal Terms are cumulative, and are without prejudice and in addition to, any other rights and remedies which we may have under the Customer Agreement, any other contract, at law or in equity. Our exercise of any one right or remedy, shall not operate to hinder or prevent the exercise of any other right or remedy by us.
