

**UOB Business Banking “Go For Gold” Promotion**  
**Terms and Conditions**

1. The UOB Business Banking “Go For Gold” promotion (“**Promotion**”) is applicable to all New Customers and Existing Customers of the Business Banking segment of United Overseas Bank Limited (“**UOB**”) (“**Eligible Customers**”). Promotion will be valid for the period of 1<sup>st</sup> July 2021 to 30<sup>th</sup> September 2021 (“**Promotion Period**”).

For the purposes of this paragraph and these Terms and Conditions:-

“**New Customers**” refer to customers that are:

- (a) New to the Business Banking segment of UOB; or
- (b) New to any of the trade facilities listed under clause 2 below from 1<sup>st</sup> June 2021 onwards

“**Existing Customers**” refer to customers with any of the trade facilities listed under clause 2 below prior to 1<sup>st</sup> June 2021

2. During the Promotion Period, Eligible Customers whose:

- (a) Aggregate amount of new Trade Bills transacted; or
- (b) Aggregate new Transaction Amount,

meet the respective Reward Tiers illustrated in clause 4.1 (“**Qualified Customers**”) will receive the corresponding 999 Pure Gold Bar in exclusive UOB limited edition design (“**Reward**”).

For the purposes of this paragraph and these Terms and Conditions:-

“**Trade Bills**” refer to bills transacted under any of the following facilities with UOB;

- (i) Import Letter of Credit
- (ii) Trust Receipt
- (iii) Trust Receipt – Invoice Financing
- (iv) Trust Receipt – Documents against Acceptance/Documents against Payment
- (v) Trust Receipt – Pre-shipment Financing
- (vi) Shipping Guarantee
- (vii) Bills of Exchange Purchased - EIF (against corporate line)
- (viii) Bills of Exchange Purchased - DA/DP (against corporate line).

“**Transaction Amount**” refers to the amount transacted under any of the following facilities with UOB;

- (i) Letter of Credit – Discounting
- (ii) Letter of Credit – Negotiation
- (iii) Transferrable Letter of Credit

3. Without limiting the generality of the foregoing, the following Eligible Customers shall not be eligible for this Promotion:-
- (i) Eligible Customers who are a staff or employee of UOB;
  - (ii) Eligible Customers who are or have become mentally incapacitated, deceased, insolvent, bankrupt, wound up or who faces legal incapacity or incapable of handling their affairs;
  - (iii) Eligible Customers who have any legal proceedings (or any threat) of any nature instituted against them;



(iv) Eligible Customers who UOB may decide to exclude at its discretion without prior notice and without furnishing any reason, at any time.

Notwithstanding anything herein to the contrary, UOB has the absolute discretion at any time and from time to time and without having to give any notice or prior reason or being liable to any person, to determine the eligibility of the Eligible Customers to participate in this Promotion and shall not be obliged to give any reason.

4. A redemption letter detailing the redemption process for the Reward (“Redemption Letter”) will be sent out within one (1) month from the end of the Promotion Period (or such later date as determined by UOB).

\* **Trade Bills** – refers to bills transacted on the following facilities; Import LC, TR, TR-IF, TR-DA/DP, TR-Pre-shipment, SG, BEP-EIF (against corporate line) and BEP-DA/DP (against corporate line).

\*\* **Transaction Amount** – refers to the amount transacted on the following facilities; LC Discounting, LC Negotiation and Transferrable LC.

Each Qualified Customer is limited to one Reward only. All prices quoted are based on indicative 999 gold prices as at June 2021 and are subjected to change according to fluctuations in gold prices without prior notice.

- 7 Notwithstanding anything to the contrary, UOB may, at its absolute discretion, change or add to any of the terms and conditions of this Promotion. UOB's determination of all matters in connection with this Promotion shall be final, binding and conclusive. No appeal, communication and/or correspondence will be entertained. The decisions of UOB on all matters relating to this Promotion are at its discretion and final, conclusive and binding. UOB shall not be obliged to give any reason, prior notice or enter into any correspondence with any person on any matter concerning this Promotion. No appeal, claims or payment of compensation will be entertained. UOB has the right and discretion to determine whether the Eligible Customer has met all the requirements of this Promotion and/or to receive the Rewards.

  - (b) each Eligible Customer is also deemed to have obtained the consent of its shareholders, beneficial owners, directors, employees, guarantors and authorised representatives collectively referred to as ("**Relevant Individual**") to the collection, use and disclosure of such Relevant Individual's personal data by UOB, the organizers, sponsors, promoters and/or their respective contractors for verifying the Eligible Customer's eligibility to receive the Reward.
