UOB Business Banking New to Trade Promotion Terms and Conditions

 The UOB Business Banking New to Trade Promotion ("Promotion") is applicable to New Trade Customers of the Business Banking segment of United Overseas Bank Limited ("UOB") ("Eligible Customers"). Promotion will be valid for the period of 1st March 2023 to 30th June 2023 ("Promotion Period").

For the purposes of this paragraph and these Terms and Conditions:-

"New Trade Customers" refer to customers that do not have any Trade Facilities (as defined in Clause 2 below) with UOB Business Baking from 1st January 2022 till 28th February 2023.

Eligible Customers who having newly accepted and implemented Trade Facilities listed below during
the Promotion Period and complied with all promotion terms and conditions ("Qualified Customers")
will receive the corresponding shopping vouchers and/or UOB Business Banking Trade Service
