

**TERMS & CONDITIONS FOR <WIN A MERCEDES-BENZ & \$80,000 WORTH OF SPC VOUCHERS >  
NETWORK PROMOTION**

The <**WIN A MERCEDES-BENZ & \$80,000 WORTH OF SPC VOUCHERS**> Network Promotion (“**Promotion**”) is jointly organised by Singapore Petroleum Company Limited (“**SPC**”) with DBS Bank Limited (“**DBS**”) and United Overseas Bank Limited (“**UOB**”).

Terms and Conditions applicable to this Promotion (“**Terms and Conditions**”) are:

- 1) This Promotion is open to all registered SPC&U and PDVL/TDVL Members (“**Participants**”).
- 2) If you are not a registered SPC&U or PDVL/TDVL member, please register your membership online at [www.spc.com.sg/member-portal](http://www.spc.com.sg/member-portal) or [www.spc.com.sg/pdvl](http://www.spc.com.sg/pdvl).
- 3) By using the SPC&U Card or PDVL/TDVL sticker during payment, you have agreed to participate in the Promotion and accept all the Terms and Conditions of the Promotion, including any decisions of SPC. Failure to comply with any of the Terms and Conditions will result in your ineligibility to participate in this Promotion. Corporate and SSPHBOA members are not eligible for this Promotion.
- 4) The Promotion is from 1 December 2023 to 29 February 2024 (both dates inclusive) (“**Promotion Period**”).
- 5) During the Promotion Period, every \$50.00 nett spent in a single receipt on fuel and/or purchases from Choices (except cigarettes, parking coupons & phone cards) at any SPC Service Station will entitle the Participant to one (1) chance to participate in an electronic lucky draw (“**Lucky Draw**”). Participant who uses POSB Everyday Card or UOB Card (Visa/Master/American Express®/UnionPay) for his/her payment will have an additional two (2) Lucky Draw chances for every \$50.00 nett spent in a single receipt. There is no limit to the number of entries but each Participant is eligible to win only one prize.
- 6) There will be a total of sixty (60) winners for the electronic Lucky Draw (“**Winner**”), the details for the Lucky Draw prizes (“**Prizes**”) are as follows:

- 7) SPC will conduct the Lucky Draw electronically on 14 March 2024 at 10am at One Temasek Avenue #28-01 Millenia Tower, Singapore 039192. All prizes cannot be exchanged for cash or other goods/services and are subject to prevailing terms and conditions of use. SPC, DBS, and UOB have the right to substitute any other prize with one of equivalent value, at its sole discretion.

- 8) The redemption for the Grand Prize is subject to the following terms:
- a) The First Prize is a Mercedes-Benz GLB 180 Progressive (**'Vehicle'**) which includes: (i) the Vehicle, (ii) the prevailing Goods and Services Tax (GST), (iii) Additional Registration Fee (ARF), (iv) Vehicles Emissions Scheme surcharge (VES), (v) standard equipment for the Vehicle prevailing at the time of import, and (vi) warranty for 3 years or 100,000km (whichever is earlier) but excludes all other items (including but not limited to road tax, insurance, Certificate of Entitlement (COE), private registration fee, number plate and other costs payable by the Winner for the registration of the Vehicle. The First Prize cannot be exchanged for cash or other models.
  - b) Notwithstanding paragraph 12, the Winner agrees that it is a pre-requisite condition to the redemption of the First Prize that he/she has to personally attend a prize presentation ceremony and allow photos and videos of him/her to be taken for marketing, publicity and promotional purposes.

The Vehicle is subject to the Mercedes-Benz's car manufacturer terms and conditions. Any quality performance, defects or mechanical failures are to be resolved directly with Cycle & Carriage Industries Pte Limited ("**CCI**") as Mercedes-Benz's authorised agent in Singapore.
  - d) **Collection and Registration of the Grand Prize:**
    - (i) After the prize presentation ceremony, Winner must arrange for the registration of the Vehicle with CCI and take delivery within one (1) month. Winner must produce the original redemption letter, NRIC, driving licence and any other documents as may be requested by CCI for verification to collect the Grand Prize.

Any request to register in another person's name is subject to CCI's consent, and receipt of such documents as CCI may require, including an irrevocable written authorisation.
