

Terms & Conditions for UOB EVOL Card Additional 2% Cashback Promotion

1. Promotion

- 1.1. This UOB EVOL Card Additional 2% Cashback ("**Promotion**") is valid from 1 April 2023 to 30 June 2023 (both dates inclusive) ("**Promotion Period**").
- 1.2. By participating in this Promotion, you agree to be bound by the terms and conditions of this Promotion (the "**Terms**").
- 1.3. This Promotion is only open to individuals who are existing holders of a UOB EVOL Credit Card issued by United Overseas Bank Limited ("**UOB**") in Singapore ("**UOB EVOL Card**").
- 1.4. "Eligible Transactions" shall mean a retail transaction which is successfully charged by the merchant as "GetGo*" or "SP DIGITAL PL-EV" to your UOB EVOL Card and posted on UOB's systems during the Promotion Period.
- 1.5. For the avoidance of doubt:
 - 1.5.1. UOB reserves the right at any time to amend the list of Eligible Transactions and the list of Excluded Transactions in its sole discretion and without any prior notice or giving any reasons.
 - 1.5.2. Eligible Transactions made in foreign currencies will be converted into Singapore dollars based on UOB's then prevailing exchange rate applicable at the time of exchange and the Singapore dollar amount posted on UOB's system will be used for the purposes of computing the Qualifying Spend under this Promotion.
 - 1.5.3. Any amount charged that is subsequently cancelled, voided or reversed for any reason will not be considered and consequently be disqualified.

2. Additional Cashback

- 2.1. In this Promotion, you shall be eligible to receive an additional 2% cashback ("Additional Cashback") on your Eligible Transactions.
- 2.2. Additional Cashback will be calculated based on the total amount of Eligible Transactions (in Singapore dollars) successfully charged and posted to your UOB EVOL Card Account in each statement month. The maximum Additional Cashback you may earn in this Promotion (for both principal and supplementary cardholders) is capped at S\$20 during the entire Promotion Period.
- 2.3. If you are eligible to receive any Additional Cashback, the applicable Additional Cashback amount will be credited into your UOB EVOL Card account by 30 September 2023 (or such other date as UOB may determine in its sole and absolute discretion) and reflected in your combined UOB Credit Card monthly card statement.
- 2.4. The Additional Cashback credited into your UOB EVOL Card account under this Promotion can only be used to offset against payments for future transactions on your UOB EVOL Card. It cannot be used to offset payments such as annual fees, late payment charges, bank fees or any other outstanding balances.
- 2.5. The Additional Cashback is strictly non-transferable and non-assignable. The Additional Cashback is not exchangeable for cash, credit or kind, in full or in part, and is not replaceable.
- 2.6. UOB may substitute any of the Additional Cashback with any item of equivalent or similar value, without prior notice or reason or being liable to any person.
- 2.7. For the avoidance of doubt, your UOB EVOL Card account must be active, valid, subsisting and/or in good standing at all times as determined by UOB in its sole discretion. In the event that your

UOB EVOL Card account is delinquent, voluntarily or involuntarily suspended, closed or terminated or suspended for any reason whatsoever before your redemption of the Additional Cashback, the Additional Cashback shall be forfeited and you shall not be entitled any compensation or payment whatsoever.

General

- 3.1. The following persons shall not be eligible to participate in the Promotion:
 - (a) individuals whose UOB account(s) is/are voluntarily or involuntarily suspended, cancelled, closed or terminated at any time;
 - individuals whose UOB account(s) is/are not active, valid, subsisting or in good standing or delinquent or unsatisfactorily conducted as may be determined by UOB at its sole discretion;
 - (c) individuals who are mentally unsound, facing legal incapacity or are incapable of handling their affairs, deceased, insolvent, bankrupt or have any legal proceedings (or any threat) of any nature instituted against them; or
 - (d) anyone whom UOB may decide to exclude, at its sole discretion, without any reason or prior notice at any time.
- 3.2. UOB will not be liable or responsible for any injury, loss or damage whatsoever or for any charge, cost or expense of any kind whatsoever suffered or incurred as a result of or in connection with the redemption or usage of any reward under this Promotion or participation in this Promotion. Without limiting the foregoing, UOB will not be liable or responsible for any undelivered, misdirected, corrupted, lost or delayed text, transmission or transaction or any delay or failure in posting any transaction or accessing any of UOB's online banking services or mobile banking services or third party applications, howsoever caused.
- 3.3. UOB makes no warranty or representation as to the quality, merchantability or fitness for purpose of the goods and services bought and accepts no liability for the services provided by any merchant or service provider. Any dispute about the same must be resolved directly with the merchant or service provider.
- 3.4. UOB has the absolute right and unfettered discretion to make decisions on all matters relating to or in connection with the Promotion, including but not limited to the determination of whether you have met all the requirements of the Promotion and the calculation of the cashback you receive under this Promotion. UOB's decisions shall be final, conclusive and binding and no payment or compensation will be given. UOB shall not be obliged to give any reason or prior notice or enter into any correspondence with any person on any matter or decision relating to the Promotion.
- 3.5. Without prejudice to any of the other provisions in these Terms, if UOB determines that you are ineligible to participate in this Promotion or to receive any reward under this Promotion, UOB may in its sole discretion forfeit the reward, reclaim the reward or charge to and debit an amount equal to the value of the reward from any of your accounts with UOB without prior notice to you. If the monies standing to the credit of your accounts are insufficient to reimburse UOB, you shall immediately reimburse UOB for the value of the reward through such means as UOB may determine in its sole discretion.
- 3.6. The Terms shall be read in conjunction with the prevailing UOB Cardmember Agreement and any other terms that may be relevant in connection with this Promotion (collectively the "**Standard Terms**"). In the event of any inconsistency between (i) the Terms and the Standard Terms, the Terms shall prevail to the extent of such inconsistency; and (ii) the Terms and any advertising, promotional, publicity, brochure, marketing or other materials relating to or in connection with the Promotion, the Terms shall prevail to the extent that such discrepancy relates to this Promotion.
- 3.7. UOB may, at any time and at its discretion terminate the Promotion and/or amend any of the Terms, and all persons shall be bound by such amendments.

- 3.11. The Terms shall be governed by the laws of the Republic of Singapore and you shall be deemed to have agreed to submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
