

**Terms and Conditions for
Metro Minimuse x UOB Cards 2025 Campaign**

1. Promotion

- 1.1 This Metro Minimuse x UOB Cards 2025 Campaign (the “**Promotion**”) is only valid from 27 November 2025 to 31 December 2025, both dates inclusive (the “**Promotion Period**”).
- 1.2 By participating in this Promotion, you are deemed to agree to be bound by the terms and conditions of this Promotion (the “**Terms**”).
- 1.3 This Promotion is open to any individual who is a cardmember of a UOB Card issued by United Overseas Bank Limited (“**UOB**”) in Singapore.
- 1.4 For the purposes of these Terms:
- (a) “**Metro-UOB Card**” refers to any personal Metro-UOB Card issued by UOB in Singapore.
- (b) “**UOB Lady’s Credit Card**” refers to any personal UOB Lady’s Classic Card, UOB Lady’s Platinum Card, UOB Lady’s World Mastercard, UOB Lady’s Solitaire Card or UOB Lady’s Solitaire Metal Card issued by UOB in Singapore.
- 1.5 Subject to these Terms, you shall be eligible to receive a one-time discount (the “**Discount**”) under this Promotion as set out in the table below if you are a cardmember of Metro-UOB Card or UOB Lady’s Credit Card, and you successfully make an in-store purchase of any listed tiers at Metro Paragon Level 2 during the Promotion Period as set out in the table below:

- 1.6 The Metro Minimuse is subject to terms and conditions imposed by Metro. Metro may, at any time and at its sole discretion, terminate the Metro Minimuse and/or amend any of the terms and conditions governing the Metro Minimuse, which shall be your sole responsibility to comply with.
- 1.7 Metro Treasured is a loyalty membership programme by Metro. UOB is not an agent of Metro and makes no warranty or representation as to Metro Treasured. Accordingly, UOB assumes no liability or responsibility with respect to, or in connection with, Metro Treasured.
- 1.8 For the avoidance of doubt:

- (a) This Promotion is exclusively available to a Metro-UOB Card or UOB Lady's Credit Cardmember.
- (b) The return voucher can be redeemed on any full-sized item across participating Minimuse brands.
- (c) Subject always to any terms and conditions as may be imposed by Metro.
- (d) This Promotion is not valid in conjunction with any other loyalty programmes.
- (e) This Promotion is not valid for transactions made online on metro.com.sg.
- (f) This Promotion may be subject to Metro's further terms and conditions (as determined by Metro) ("**Metro's Terms**"), which shall apply in addition to these Terms.

2. Discount

- 2.1 If you are eligible to receive the applicable Discount set out in the table in Clause 1.5 above, the Discount will be applied immediately to offset your bill directly at the time of your purchase.
- 2.2 The Discount is given on a first-come-first-served basis, whilst stocks last and subject to availability. UOB shall not be required to notify and/or update on the availability of the Discount.
- 2.3 The Discount is neither transferable nor exchangeable for cash, reward points, credit, goods and services, products or privileges or other kind, in full or in part, and is not refundable or replaceable.
- 2.4 UOB has the right, at any time in its discretion and without prior notice, to substitute or replace the Discount with another item of equivalent or similar value without giving any reason or assuming any liability or payment of compensation to any person. UOB's determination of such substitution or replacement shall be final, conclusive and binding.
- 2.5 UOB is not an agent of Metro. Accordingly, UOB makes no warranty or representation as to the Metro Minimuse and/or the quality, value, merchantability or fitness of the Discount and/or the goods and services provided by Metro in connection with this Promotion and the Metro Minimuse. UOB assumes no liability or responsibility for the acts or omissions of Metro or any non-performance or defects in the Discount and/or the goods and services provided by Metro in connection with this Promotion and the Metro Minimuse. Any dispute regarding the Discount, the Metro Minimuse and/or the goods and services provided by Metro in connection with this Promotion or the Metro Minimuse is to be resolved directly with Metro and UOB shall not be required to assist or act on your behalf in communicating Metro.

3. General

- 3.1 The following persons shall not be eligible to participate in the Promotion:
 - (a) individuals whose UOB account(s) is/are voluntarily or involuntarily suspended, cancelled, closed or terminated at any time;
 - (b) individuals whose UOB account(s) is/are not active, valid, subsisting or in good standing or delinquent or unsatisfactorily conducted as may be determined by UOB at its sole discretion;
 - (c) individuals who are mentally unsound, facing legal incapacity or are incapable of handling their affairs, deceased, insolvent, bankrupt or have any legal proceedings (or any threat) of any nature instituted against them; or

- (d) anyone whom UOB may decide to exclude, in its sole discretion, without any reason or prior notice at any time.
- 3.2 UOB will not be liable or responsible for any injury, loss or damage whatsoever or for any charge, cost or expense of any kind whatsoever suffered or incurred as a result of or in connection with the redemption or usage of the Discount or participation in this Promotion. Without limiting the foregoing, UOB will not be liable or responsible for any undelivered, misdirected, corrupted, lost or delayed text, transmission or transaction or any delay or failure in posting any transaction or accessing any of UOB's online banking services or mobile banking services or third-party applications, howsoever caused.
- 3.3 UOB has the absolute right and unfettered discretion to make decisions on all matters relating to or in connection with the Promotion, including but not limited to the determination of whether you have met all the requirements of the Promotion. UOB's decisions shall be final, conclusive and binding and no payment or compensation will be given. UOB shall not be obliged to give any reason or prior notice or enter into any correspondence with any person on any matter or decision relating to the Promotion.
- 3.4 If UOB determines that you are ineligible to participate in this Promotion or to receive the Discount, UOB may in its sole discretion forfeit the Discount, reclaim the Discount or charge to and debit an amount equal to the value of the Discount from any of your accounts with UOB without prior notice to you. If the monies standing to the credit of your accounts are insufficient to reimburse UOB, you shall immediately reimburse UOB for the value of the Discount through such means as UOB may determine in its sole discretion.
- 3.5 The Terms shall be read in conjunction with the prevailing UOB Cardmember Agreement and any other terms that may be relevant in connection with this Promotion (collectively the "**Standard Terms**"). In the event of any inconsistency between (i) the Terms and the Standard Terms, the Terms shall prevail to the extent of such inconsistency; and (ii) the Terms and any advertising, promotional, publicity, brochure, marketing or other materials relating to or in connection with the Promotion, the Terms shall prevail to the extent that such discrepancy relates to this Promotion.
- 3.6 UOB may, at any time and at its discretion terminate the Promotion and/or amend any of the Terms, and all persons shall be bound by such amendments.
- 3.7 Unless otherwise stated, this Promotion is not valid with other offers, privileges or promotions.
- 3.8 By participating in this Promotion and in addition to any other consent you have already provided to UOB and any right of UOB under applicable laws, you consent to UOB and the necessary third parties collecting, using and disclosing your information (including your personal data) for the purposes of this Promotion and to contact you, including by voice call or text message.
- 3.9 A person who is not a party to the Terms shall have no rights under the Contracts (Rights of Third Parties) Act 2001 of Singapore to enforce the Terms.
- 3.10 The Terms shall be governed by the laws of the Republic of Singapore and you shall be deemed to have agreed to submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
