

TERMS AND CONDITIONS FOR UOB ONE DEBIT VISA CARD APPLE AIRTAG PROMOTION

1. Promotion

- 1.1. This UOB One Debit Visa Card Apple AirTag Promotion (the "**Promotion**") is only valid between 1 October 2025 to 31 October 2025, both dates inclusive (the "**Promotion Period**").
- 1.2. By participating in this Promotion, you agree to be bound by the terms and conditions of this Promotion (the "**Terms**").
- 1.3. This Promotion is only open to selected cardholders of the UOB One Debit Visa Card ("**Eligible Card**") issued by United Overseas Bank Limited ("**UOB**") in Singapore who have received a SMS or electronic direct mail invitation from UOB to participate in this Promotion.
- 1.4. To participate in this Promotion, you must satisfy all of the following conditions:
 - you must receive a SMS or electronic direct mail invitation from UOB during the Promotion Period inviting you to participate in this Promotion (the "**Invitation**");
 - (b) you must successfully charge at least five (5) Transactions to your Eligible Card during the Promotion Period.
- 1.5. For the purposes of this Promotion:
 - (a) "Transaction" shall mean all transactions that all successfully charged and posted to your Card account and posted on UOB system and excludes the Excluded Transactions (as defined below).
 - (b) "Excluded Transactions" refers to the following:
 - (i) Any instalment payment plans;
 - (ii) Any charges and fees imposed by UOB
 - (iii) Fund transfers to or from a Card account;
 - (iv) Unposted/voided/disputed/reversed transactions;
 - (v) any payment made with the following Merchant Category Code ("MCC");

- (vii) The asterisk symbol ("*") used in transaction descriptions signifies that any number of characters may follow the specified word or phrase. For example, "AXS*" encompasses variations such as "AXS12345", "AXS PAYMENT", and other transaction descriptors that begin with "AXS".
- 1.6. UOB reserves the right, at any time at its discretion, to amend or vary the list of Transactions and/or the list of Excluded Transactions without any reason or prior notification and without assuming any liability to any party and shall not be liable to pay any compensation to, or enter into any correspondence with, any person in connection with the same.
- 1.7. A merchant's registered MCC may not always correspond with its nature of business. The MCCs are assigned by the merchant's acquiring bank. UOB does not determine the merchants' MCC. UOB shall not be liable in any way whatsoever relating to the categorisation of a merchant's MCC.

2. Gift

- 2.1. If you are the first 100 cardholders to satisfy all of the conditions in Clause 1.4 above, you shall be eligible to receive an Apple AirTag (the "**Gift**").
- 2.2. If you are eligible to receive the Gift, you will be notified via a SMS or an electronic direct mail setting out the details on the redemption of the Gift (the "Notification"). The Notification will be sent to your registered mobile number of email address in UOB's records by 31 December 2025 (or such other date as UOB may determine in its sole discretion). UOB reserves the right to decline any redemption of the Gift if any one of the requirements set out in the Notification is not met at the time of redemption. No replacement will be issued for a lost, stolen or destroyed Notification Email.
- 2.3. You are required to follow the instructions set out in the Notification in order to redeem the Gift. UOB shall not be responsible or liable in any way to any person arising from your inability to redeem your Gift from the designated redemption centre ("Redemption Centre") specified in the Notification.
- 2.4. The redemption period for the Gift will be stated in your Notification (the "Redemption Period"). Strictly no extension of the Redemption Period is allowed. If you do not redeem your Gift during the Redemption Period, your entitlement to the Gift will be forfeited.
- 2.5. You are only entitled to receive one (1) Gift under this Promotion, regardless of the number of Eligible Cards that you may hold.
- 2.6. The Gift is neither transferable nor assignable. The Gift is not exchangeable for cash, credit or kind, in full or in part, and is not replaceable if lost or stolen. No reservation, refund or exchanges of the Gifts are allowed.
- 2.7. UOB may substitute the Gift with any item of equivalent or similar value, without prior notice or reason or being liable to any person.
- 2.8. The Gift is supplied by third party merchants and UOB is not an agent of the merchant and/or supplier of the Gift. Accordingly, UOB makes no warranty or representation as to the quality, value, merchantability or fitness for purpose of the Gift and UOB assumes no liability or responsibility for the acts or omissions of the merchants or any non-performance or defects in the Gift. Any dispute regarding the Gift is to be resolved directly with the merchant and/or supplier of the Gift. UOB shall not be required to assist or act on your behalf in communicating with the merchant and/or supplier of the Gift. For the purposes of this clause, "Gift" includes any products and/or services provided by third party merchants in connection with the use and/or redemption of the Gift.

- 2.9. Your Eligible Card account must be in good standing at all times as determine by UOB at its absolute discretion. In the event that your Eligible Card account is delinquent, voluntarily or involuntarily closed or terminated or suspended for any reasons whatsoever at the time of awarding of the Gift, the Gift shall be forfeited and you shall not be entitled any compensation or payment whatsoever.
- 2.10. Sending and receiving SMS is dependent on a SMS vendor, an independent telecommunication authority or service provider or such other third party which is engaged by UOB for the Promotion and UOB shall not be responsible for any undelivered, lost or delayed SMS sent to and/or received. You shall pay and be solely responsible for all fees and charges imposed by their service providers for the sending and/or receipt of any SMS in connection with the Promotion.

3. General

The General Terms and Conditions Governing Promotions set out in Appendix 1 will apply to this Promotion and form an integral part of these Terms:

Appendix 1

General Terms and Conditions Governing Promotions

- 1. The following persons shall not be eligible to participate in the Promotion:
 - (a) individuals whose UOB account(s) is/are voluntarily or involuntarily suspended, cancelled, closed or terminated at any time;
 - (b) individuals whose UOB account(s) is/are not active, valid, subsisting or in good standing or delinquent or unsatisfactorily conducted as may be determined by UOB at its sole discretion:
 - (c) individuals who are mentally unsound, facing legal incapacity or are incapable of handling their affairs, deceased, insolvent, bankrupt or have any legal proceedings (or any threat) of any nature instituted against them; or
 - (d) anyone whom UOB may decide to exclude, at its sole discretion, without any reason or prior notice at any time.
- 2. UOB will not be liable or responsible for any injury, loss or damage whatsoever or for any charge, cost or expense of any kind whatsoever suffered or incurred as a result of or in connection with the redemption or usage of any reward under this Promotion or participation in this Promotion. Without limiting the foregoing, UOB will not be liable or responsible for any undelivered, misdirected, corrupted, lost or delayed text, transmission or transaction or any delay or failure in posting any transaction or accessing any of UOB's online banking services or mobile banking services or third party applications, howsoever caused.
- 3. UOB has the absolute right and unfettered discretion to make decisions on all matters relating to or in connection with the Promotion, including but not limited to the determination of whether you have met all the requirements of the Promotion. UOB's decisions shall be final, conclusive and binding and no payment or compensation will be given. UOB shall not be obliged to give any reason or prior notice or enter into any correspondence with any person on any matter or decision relating to the Promotion.

- 4. If UOB determines that you are ineligible to participate in this Promotion or to receive any reward under this Promotion, UOB may in its sole discretion forfeit such reward, reclaim the reward or charge to and debit an amount equal to the value of the reward from any of your accounts with UOB without prior notice to you. If the monies standing to the credit of your accounts are insufficient to reimburse UOB, you shall immediately reimburse UOB for the value of the reward through such means as UOB may determine in its sole discretion.
- 5. The Terms shall be read in conjunction with the prevailing UOB Debit Cardmember Agreement and any other terms that may be relevant in connection with this Promotion (collectively the "**Standard Terms**"). In the event of any inconsistency between (i) the Terms and the Standard Terms, the Terms shall prevail to the extent of such inconsistency; and (ii) the Terms and any advertising, promotional, publicity, brochure, marketing or other materials relating to or in connection with the Promotion, the Terms shall prevail to the extent that such discrepancy relates to this Promotion.
- 6. UOB may, at any time and at its discretion terminate the Promotion and/or amend any of the Terms, and all persons shall be bound by such amendments.
- 7. Unless otherwise stated, this Promotion is not valid with other offers, privileges or promotions.
- 8. By participating in this Promotion and in addition to any other consent you have already provided to UOB and any right of UOB under applicable laws, you consent to UOB and the necessary third parties collecting, using and disclosing your information (including your personal data) for the purposes of this Promotion and to contact you, including by voice call or text message.
- 9. A person who is not a party to the Terms shall have no rights under the Contracts (Rights of Third Parties) Act 2001 to enforce the Terms.
- 10. The Terms shall be governed by the laws of the Republic of Singapore and you shall be deemed to have agreed to submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
