



TERMS AND CONDITIONS FOR UOB ONE DEBIT MASTERCARD TRANSPORT CASHBACK PROMOTION 2026

1. The terms and conditions governing UOB One Debit Mastercard Transport Cashback Promotion 2026 (the “**Promotion**”) applies to the UOB One Debit Mastercard (the “**Card**”) issued by United Overseas Bank Limited (“UOB”) in Singapore.
2. To qualify for the Promotion, the customer must satisfy the following conditions:
 - a. The customer must apply for a UOB One Debit Mastercard (“**Eligible Card**”) commencing on 1 May 2026 and ending on 31 July 2026, both dates inclusive (“**Application Period**”).
 - b. The application for the Eligible Card (“**Application**”) must be approved by UOB within the Application Period. Applications approved outside of the Application Period shall not be eligible for the Promotion.
 - c. The customer must not have held or cancelled any UOB debit card(s) in Singapore within the six (6) months immediately preceding the approval date of the Eligible Card.
3. The following persons shall not be eligible to participate in this Promotion:
 - a. individuals who have applied for a UOB One Debit Visa Card.
 - b. individuals who have cancelled any of their UOB debit card(s) within six (6) months prior to their approved Application;
 - c. individuals who are existing holders of UOB debit card(s) at the time when their Application is approved;
 - d. individuals whose UOB account(s) is/are voluntarily or involuntarily suspended, cancelled, closed or terminated at any time;
 - e. individuals whose UOB account(s) is/are not active, valid, subsisting or in good standing or delinquent or unsatisfactorily conducted as may be determined by UOB at its sole discretion;
 - f. individuals who are mentally unsound, facing legal incapacity or are incapable of handling their affairs, deceased, insolvent, bankrupt or have any legal proceedings (or any threat) of any nature instituted against them; or
 - g. anyone whom UOB may decide to exclude, at its sole discretion, without any reason or prior notice at any time.
4. If you satisfy the conditions in Clauses 2 and 3, the Cashback Reward Period shall commence on the first calendar day of the month following your Card approval date and shall run for the next three (3) consecutive full calendar months.

For illustration purposes only:

Card Approval Month	Cashback Reward Period
May 2026	June 2026, July 2026, August 2026
June 2026	July 2026, August 2026, September 2026
July 2026	August 2026, September 2026, October 2026

5. You are eligible to receive an additional promotional cashback of 6% (“**Promotional Cashback**”) on Eligible Transport Transactions during the Cashback Reward Period if, in each calendar month during the Cashback Reward Period:
 - a. A Monthly Qualifying Spend of at least S\$300 is met; and
 - b. your Card account is determined by UOB to be in good standing and satisfactorily conducted.

For the avoidance of doubt, all Promotional Cashback calculations shall be based on the transaction posting date reflected in UOB’s systems.

S\$300	2%	6%	8%
S\$600	4%	6%	10%

* Subject to the applicable caps and prevailing terms governing the UOB One Debit Card Cashback Programme.

6. Cashback Cap and Structure
 - a. The Promotional Cashback awarded under this Promotion shall be capped at S\$20 per Card per calendar month during the Cashback Reward Period.
 - b. Promotional Cashback earned under this Promotion is awarded in addition to, and separately from, the base cashback earned under the UOB One Debit Card Cashback Programme (“**Base Cashback**”).
 - c. Each of the Monthly Qualifying Spend, cashback earned and cashback cap is calculated on a per Card, per calendar month basis.
 - d. Eligible cardholders who meet the Monthly Qualifying Spend may earn:
 - i. Up to S\$20 per month in Promotional Cashback under this Promotion; and
 - ii. Up to S\$30 per month in Base Cashback, subject always to the applicable caps and prevailing terms governing the UOB One Debit Card Cashback Programme.

7. If you are eligible to receive the Cashback, the Cashback will be credited to your Card account maintained with UOB (“**Account**”) in the following calendar month, in accordance with UOB’s prevailing cashback crediting schedule. Eligible cardholders may see **separate cashback credit entries** for Base Cashback and Promotional Cashback.

8. For illustration purposes only:

Scenario 1: Monthly Qualifying Spend \geq S\$300

Customer A spends a total of S\$400 in May, comprising:

- Grab rides: S\$100
- SimplyGo transport transactions: S\$50
- Other eligible retail spend: S\$250

As Customer A meets the Monthly Qualifying Spend of at least S\$300 and the Card account is in good standing, Customer A is eligible for the following cashback on Eligible Transport Transactions:

- Base Cashback of 2%, and
- Promotional Cashback of 6%

Total cashback rate on Eligible Transport Transactions is 8%, calculated as follows:

Transaction	Base Cashback (capped at S\$30)	Promotional Cashback (capped at S\$20)	
Grab rides	S\$100 x 2% = S\$2	S\$100 x 6% = S\$6	
SimplyGo	S\$50 x 2% = S\$1	S\$50 x 6% = S\$3	
Total	S\$3	S\$9	Total cashback earned = S\$12

Total cashback earned is S\$12.

Scenario 2: Monthly Qualifying Spend \geq S\$600

Customer B spends a total of S\$1,000 in May, comprising:

- Grab rides: S\$200
- SimplyGo transport transactions: S\$100
- McDonald's transactions: S\$100
- Mobile Payments: S\$300
- Other eligible retail spend: S\$300

As Customer B meets the Monthly Qualifying Spend of at least S\$600 and the Card account is in good standing, Customer B is eligible for the following cashback on Eligible Transport Transactions:

- Base cashback of 4%, and
- Promotional Cashback of 6%

Total cashback rate on Eligible Transport Transactions: 10%, which is calculated as follows:

Transaction	Base Cashback (capped at S\$30)	Promotional Cashback (capped at S\$20)	
Grab rides	S\$200 x 4% = S\$8	S\$200 x 6% = S\$12	
SimplyGo	S\$100 x 4% = S\$4	S\$100 x 6% = S\$6	
Total	S\$12	S\$18	Total cashback earned = S\$30

Total cashback earned is S\$30.

9. For the purposes of these Terms:

- a. **“Eligible Transport Transactions”** shall refer to the following cashback eligible transactions successfully charged to your Card and which are posted on UOB’s systems, but excluding the Exclusions.
- i. **“Grab ride transactions”** shall mean all Grab ride only transactions made with Grab Taxi Holdings Pte Ltd and its affiliated companies with the description “GRAB*” and tagged under MCC code 4111, 4121 and 4789 but shall exclude any Grab wallet top-up transactions.
- ii. **“SimplyGo Transactions”** shall mean all transactions made with SimplyGo bus and train rides only, excluding all SimplyGo top-up transactions.
- b. **“Monthly Qualifying Spend”** shall refer to all retail transactions successfully charged and posted to your Card for that calendar month, but excluding the Exclusions.
- c. **“Exclusions”** shall refer to the following transactions that are excluded from cashback eligibility.
- i. any instalment payment plans;
 - ii. any charges and fees imposed by UOB;
 - iii. fund transfers to or from a Card account;
 - iv. unposted/voided/disputed/reversed transactions;
 - v. any payment made with the following Merchant Category Code (“MCC”);

vii. any other transactions as may be prescribed by UOB from time to time, and as may be amended by UOB from time to time without prior notice or being liable to any person.

d. The asterisk symbol (“*”) used in transaction descriptions signifies that any number of characters may follow the specified word or phrase. For example, “GRAB*” encompasses variations such as “GRAB12345”, “GRABFOOD123456”, and other transaction descriptors that begin with “GRAB”.

10. Transactions charged to the Card in foreign currencies will be converted into Singapore dollars based on UOB’s then prevailing exchange rate applicable at the time of exchange.

11. The Promotional Cashback is neither transferable nor exchangeable for cash, reward points, credit, goods and services, products or privileges or other kind in full or in part and is not refundable or replaceable.

12. By participating in this Promotion and in addition to any other consent you have already provided to UOB and any right of UOB under applicable laws, you consent to UOB and the necessary third parties collecting, using and disclosing your personal data for the purposes of this Promotion and to contact you.

13. UOB shall not be responsible for (i) any delay or failure in (a) communication relating to this Promotion; and/or (b) the posting of Transactions by any other party (including merchants); and (ii) any fees, costs, losses, damages, claims, expenses and/or injuries of any person howsoever incurred or suffered in relation with this Promotion or otherwise.
14. UOB reserves all rights to (i) substitute the Promotional Cashback; (ii) forfeit or reclaim the Promotional Cashback where participant is subsequently discovered to be ineligible; (iii) update these Terms without prior notification and participation in this Promotion shall be bound by any such update; and (v) make determinations and decisions on all matters relating to this Promotion which shall be final, conclusive and binding.
15. Prevailing UOB Debit Cardmember Agreement and the Terms and Conditions Governing Accounts and Services for Individual Customers (collectively, the "Standard Terms") shall continue to apply. In the event of any inconsistency between these Terms and the Standard Terms, these Terms shall to the extent of such inconsistency, prevail in respect of matters relating to this Promotion.
16. These Terms shall be governed by the laws of the Republic of Singapore, and you agree to submit to the exclusive jurisdiction of the Singapore courts. A person not a party to these Terms has no rights under the Contracts (Rights of Third Parties) Act 2001 of Singapore to enforce these Terms.
17. UOB is not an agent of any merchant or the service provider and as such, any dispute about the quality or service standard of the goods and services offered by the merchant or service provider must be resolved directly with them.
18. Unless otherwise stated, this Promotion is not valid with other offers, discounts, rebates, vouchers, privileges or promotions.
