

UOB PRVI Miles Card – Up to 5 miles per S\$1 Spend Campaign (the "Promotion") Terms and Conditions (the "Terms and Conditions")

# 1. Eligibility

- 1.1 This Promotion is valid from 19 May to 30 June 2025, both dates inclusive (the "**Promotion Period**"). By participating in this Promotion, you agree to be bound by these Terms and Conditions.
- 1.2 This Promotion is open to all principal cardholders of a UOB PRVI Miles American Express<sup>®</sup>, World Mastercard or Visa Card ("Card") that is issued by United Overseas Bank Limited ("UOB" or the "Bank") in Singapore.
- 1.3 To participate in this Promotion, you must successfully register to participate in this Promotion by sending in an SMS to 77862 using your Singapore mobile number registered with UOB during the Promotion Period in the following format (the "SMS Registration"):

## PMX<space>Last 4 alphanumeric characters of your NRIC or Passport Number

Example: If your NRIC is S1234567A, you will need to send "PMX 567A" to 77862.

- 1.4 All SMS Registrations for this Promotion which are not in the format prescribed in these Terms and Conditions, sent to an incorrect number, sent from a mobile number which is not registered with UOB, or sent outside of the Promotion Period will be automatically disqualified.
- 1.5 For the avoidance of doubt, you will only need to register once for this Promotion within the Promotion Period to participate the Promotion.
- 1.6 If you successfully charge a total of at least S\$1,500 in Eligible Overseas Transactions and/or Eligible Regional Transactions to your Card during the Promotion Period, you shall be eligible to earn up to UNI\$12.50 per S\$5 spend on the total value of your Eligible Overseas Transactions and/or Eligible Regional Transactions (equivalent to 5 miles per S\$1 spend¹) using your Card during the Promotion Period. This is based on:

## **EITHER**

- (a) the existing earn rate of UNI\$7.5 for every \$\$5 of Regional spend (which is equivalent to 3 miles per \$\$1 spend), whether effected in person or online, in accordance with the prevailing Terms and Conditions Governing UOB PRVI Miles Card (the "Card Terms"); and
- (b) a bonus earn rate of UNI\$5 for every S\$5 (which is equivalent to 2 miles per S\$1 spend) spent on Eligible Regional Transactions which constitute Regional spend, and which were made in person (the "Bonus Regional Award").

OR

- (c) the existing earn rate of UNI\$6 for every S\$5 of overseas spend but excluding Regional spend (which is equivalent to 2.4 miles per S\$1 spend), whether effected in person or online, in accordance with the Card Terms; and
- (d) a bonus earn rate of UNI\$6.5 for every S\$5 (which is equivalent to 2.6 miles per S\$1 spend) spent on Eligible Overseas Transactions which do not constitute Regional spend, and which were made in person (the "Bonus Overseas Award").
- 1.7 The maximum Bonus Regional Award and Bonus Overseas Award that you may earn for the entire duration of the Promotion Period is capped at UNI\$4,000.
- 1.8 For the purposes of the Promotion:
  - (a) "Regional" refers to transactions (whether made physically or via websites) that are effected overseas in Indonesian Rupiah (IDR), Malaysian Ringgit (MYR), Thai Baht (THB) and Vietnamese Dong (VMD) and which are processed through a payment gateway in Indonesia, Malaysia, Thailand and Vietnam respectively.
  - (b) "Eligible Regional Transactions" refers to Dining Transactions and Shopping Transactions which are successfully charged to your Card in a foreign currency that is IDR, MYR, THB or VMD and which are processed through a payment gateway in the country of the transaction currency (i.e. in Indonesia for IDR, Malaysia for MYR, Thailand for THB and Vietnam for VMD), and posted on UOB's system, but shall exclude the Excluded Transactions.
  - (c) "Eligible Overseas Transactions" refers to Dining Transactions and Shopping Transactions which successfully charged to your Card in a foreign currency other than IDR, MYR, THB or VMD and which are processed through a payment gateway outside of Singapore, and posted on UOB's system but shall exclude the Excluded Transactions.
  - (d) For the avoidance of doubt, transactions which are processed out of Singapore but which are charged or effected in Singapore dollars at the time of the transaction will not constitute an "Eligible Overseas Transaction", "Eligible Regional Transaction", "overseas spend" or "Regional spend". All transactions charged to your Card account effected in foreign currencies will be converted into Singapore dollars based on UOB's prevailing exchange rate and the Singapore dollar amount posted on UOB's system will be used for the purposes of this Promotion.



# (e) "Excluded Transactions" shall mean: -

- transactions in dynamic currency conversion (Singapore dollar transactions processed outside Singapore);
- ii. overseas transactions made in foreign currency which do not fall under the list of Dining Transactions and Shopping Transactions set out below;
- iii. cash advance, late payment, personal loan, balance and/or funds transfer, SmartPay, funds added to pre-paid cards or mobile wallets, fees, chargebacks, interests, reversals, interest charges and any finance charges;
- iv. balances owing on your Card account(s) accruing from months that do not fall within the Promotion Period;
- v. any transaction that was subsequently cancelled, voided, disputed or reversed for any reason; and/or
- vi. such other categories of transactions which UOB may exclude from time to time without notice or giving reasons.
- (f) Eligible Overseas Transactions or Eligible Regional Transactions incurred by the supplementary cardholder of your Card under this Promotion shall accrue to your Card for the purposes of this Promotion.
- (g) "Dining Transactions" refers to food and beverage transactions (which are not Online Transactions, and excluding all food and beverage transactions within hotels and country clubs and grocery stores and supermarkets) which fall under any one of the following Merchant Category Codes ("MCC"):

- (h) "Online Transactions" refers to transactions made via the internet and processed by the respective merchant / acquirers as an online transaction through Amex/Mastercard/Visa networks.
- (i) "**Shopping Transactions**" refers to shopping transactions which are not Online Transactions, and which fall under any one of the following MCC:

(j) UOB reserves the right, at any time and at its discretion, to amend or vary the scope of the various types of transactions above without any reasons, prior notification and/or assuming any liability to any party and shall not be liable to pay any compensation or enter into any correspondence in connection with the same.

- (k) A merchant's registered MCC may not always correspond with its nature of business. MCCs are assigned to a merchant/business by the merchant's acquiring bank. UOB as the issuing bank of the Card does not determine the merchant's MCC. UOB shall not be liable in any way whatsoever relating to the categorization of a merchant's MCC.
- 1.9 If you are eligible to earn the Bonus Overseas Award or Bonus Regional Award, the Bonus Overseas Award (or, as the case may be, the Bonus Regional Award) will be credited to your Card account within two (2) months after the Promotion Period (or such other date as may be determined by UOB in its sole discretion) and reflected in your monthly Card statement.
- 1.10 No advance crediting of any UNI\$ will be entertained.
- 1.11 The Bonus Overseas Award and the Bonus Regional Award are strictly non-transferrable.

#### 2. General

- 2.1 Sending and receiving SMS is dependent on an SMS vendor, an independent telecommunication authority or service provider or such other third party which is engaged by UOB for the Promotion and UOB shall not be responsible or liable for any undelivered, lost or delayed SMS sent to and/or received by any person. You shall pay and be solely responsible for all fees and charges imposed by such service providers for the sending and/or receipt of any SMS in connection with the Promotion. The SMS vendor, independent telecommunication authority or service provider or such other third party is a third party and is independent and beyond the control of UOB. UOB shall not be responsible or liable in any manner whatsoever for the delay in the transmission or receipt of any SMS or for any lost SMS.
- In the event the UNI\$ awarded is in decimal points, the final UNI\$ awarded for each transaction will be rounded down to the nearest whole figure.
- 2.3 You shall only be eligible to earn the Bonus Overseas Award and the Bonus Regional Award for this Promotion once across all Card accounts during the entire Promotion Period, regardless of the number of Cards you hold.
- 2.4 UOB may substitute the awards under the Promotion with any item of equivalent or similar value, without prior notice of reason or being liable to any person.
- 2.5 The following persons shall not be eligible to participate in the Promotion:
  - (a) individuals whose UOB account(s) is/are voluntarily or involuntarily suspended, cancelled, closed or terminated at any time;

- (b) individuals whose UOB account(s) is/are not active, valid, subsisting or in good standing or delinquent or unsatisfactorily conducted as may be determined by UOB at its sole discretion;
- (c) individuals who are mentally unsound, facing legal incapacity or are incapable of handling their affairs, deceased, insolvent, bankrupt or have any legal proceedings (or any threat) of any nature instituted against them; or
- (d) anyone whom UOB may decide to exclude, at its sole discretion, without any reason or prior notice at any time.
- 2.6 UOB will not be liable or responsible for any injury, loss or damage whatsoever or for any charge, cost or expense of any kind whatsoever suffered or incurred as a result of or in connection with the redemption or usage of the award under this Promotion or participation in this Promotion. Without limiting the foregoing, UOB will not be liable or responsible for any undelivered, misdirected, corrupted, lost or delayed text, transmission or transaction or any delay or failure in posting any transaction or accessing any of UOB's online banking services or mobile banking services or third-party applications, howsoever caused.
- 2.7 If your Card account is not validly subsisting and in good standing, is closed, terminated and/or suspended for any reason whatsoever during the Promotion Period or before any award under this Promotion is credited, you will not be entitled to receive any such award and you shall not be entitled to any compensation or payment whatsoever.
- UOB has the absolute right and unfettered discretion to make decisions on all matters relating to or in connection with the Promotion, including but not limited to the determination of whether you have met all the requirements of the Promotion, determination as to whether a transaction qualifies to be eligible under this Promotion and determination of the UNI\$ to be awarded to you under this Promotion. UOB's decisions shall be final, conclusive and binding on all parties concerned and no payment or compensation will be given. The Bank shall not be obliged to give any reason or prior notice or enter into any correspondence with any person on any matter or its decision or to assume any liability to any person, relating to the Promotion, and no appeal, correspondence or claims will be entertained.
- 2.9 If you are discovered to be or UOB determines that you are ineligible to participate in this Promotion or to receive the any award under this Promotion, UOB may at its sole discretion forfeit the award, reverse or cancel any UNI\$ already credited to your Card account without prior notice to you.
- 2.10 These Terms and Conditions shall be read in conjunction with the prevailing UOB Cardmember Agreement, the Card Terms and any other terms that may be relevant in connection with this Promotion (collectively the "Standard Terms"). In the event of any inconsistency between (i) the Terms and Conditions and the Standard Terms, the Terms and Conditions shall prevail to the extent of such inconsistency; and (ii) the Terms and Conditions and any advertising, promotional, publicity, brochure, marketing or other materials relating to or in connection with the Promotion, the Terms and Conditions shall prevail to the extent that such discrepancy relates to this Promotion.

- 2.12 By participating in this Promotion and in addition to any other consent you have already provided to UOB and any right of UOB under applicable laws, you consent to UOB and the necessary third parties collecting, using and disclosing your information (including your personal data) for the purposes of this Promotion and to contact you, including by voice call or text message.
- 2.13 These Terms and Conditions shall be governed by the laws of the Republic of Singapore and you hereby agree to submit to the exclusive jurisdiction of the courts of Singapore.
- 2.14 A person who is not a party to the Terms and Conditions and/or any agreement governed by the Terms and Conditions shall have no rights under the Contracts (Rights of Third Parties) Act 2001 of Singapore to enforce any term of such agreement or any of the Terms and Conditions.
- 2.15 This Promotion is not valid with other offers, privileges or promotions unless otherwise expressly stated.
