### TERMS AND CONDITIONS FOR THE UOB TMRW E-HONGBAO LUCKY DRAW 2024

#### 1. Eligibility

- 1.1. This UOB TMRW E-Hongbao Lucky Draw (the "**Draw**") is valid from 15 January 2024 to 29 February 2024, both dates inclusive (the "**Qualifying Period**").
- 1.2. By participating in this Draw, you are deemed to have agreed to be bound by these terms and conditions governing the Draw (the "**Terms**").
- 1.3. To participate in this Draw, you must satisfy all of the following conditions:
  - (a) you must be an existing United Overseas Bank Limited ("UOB") customer with a personal UOB savings account, current account or cheque account held by you as the primary account holder and in each case, such account must be valid and in good standing and conducted in a proper and satisfactory manner at all times (as determined by UOB in its sole and absolute discretion); and

- (a) you are an existing UOB PayNow user and have not de-registered your UOB PayNow within one (1) month before and after the Qualifying Period; and
- (b) your successful PayNow transaction with reference to Clause 1.3 above is with a PromptPay- or DuitNow-registered recipient; and
- (c) you have satisfied all of the conditions in Clause 1.3 above.
- 1.4.3. There is no cap on the number of chances in the Draw that you may earn during the Qualifying Period.
- 1.4.4. For the avoidance of doubt, if you subsequently cancel, terminate or reverse the relevant Qualifying Entry (as the case may be), such Qualifying Entry shall no longer be awarded any chance in the Draw.

#### 2. Draw

- 2.1. Upon the awarding of a chance in the Draw to you, your name will be submitted to the Draw pool. If you do not wish to participate in the Draw, you must notify UOB of the same via the UOB Call Centre Hotline 1800 222 2121 prior to the Draw Date (as defined below).
- 2.2. - 2.5. If you are selected as a Winner, you will be notified via SMS by the mobile number you provided based on UOB's records (the "**Prize Notification**"). The Prize Notification will be sent out within 7 calendar days from the Draw Date.
- 2.6. The details (full name and partially masked NRIC/FIN) of the Winners will also be announced on UOB's website at uob.com.sg/tmrw within 7 calendar days from the Draw Date.
- 2.7. UOB will credit the Cash Prize into each Winner's UOB account registered with PayNow from which the Qualifying Entry was made during the Qualifying Period by 23 April 2024 ("**Crediting Period**"). Each Winner is responsible for ensuring that the UOB account registered with PayNow is valid and existing, not blocked from use, in good standing and conducted in a proper and satisfactory manner (as determined by UOB its sole discretion) at the time of crediting. UOB shall not be responsible for any loss or damage suffered by any person if the Cash Prize is not credited or available for use, or if the Winner is unable to redeem or use the said prize.

- (b) individuals whose UOB account(s) is/are not active, valid, subsisting or in good standing or delinquent or unsatisfactorily conducted as may be determined by UOB at its sole discretion;
- (c) individuals who are mentally unsound, facing legal incapacity or are incapable of handling their affairs, deceased, insolvent, bankrupt or have any legal proceedings (or any threat) of any nature instituted against them;
- (d) any individual who has not complied with any provision of these Terms;
- (e) anyone whom UOB may decide to exclude, at its sole discretion, without any reason or prior notice at any time.
- 3.2. UOB will not be liable or responsible for any injury, loss or damage whatsoever or for any charge, cost or expense of any kind whatsoever suffered or incurred as a result of or in connection with the redemption or usage of any prize or participation in this Draw or the use of PayNow. Without limiting the foregoing, UOB will not be liable or responsible for any undelivered, misdirected, corrupted, lost or delayed text, transmission or transaction or any delay or failure in posting any transaction or accessing any of UOB's online banking services or mobile banking services, howsoever caused.

inconsistency between (i) the Terms and the Standard Terms, the Terms shall prevail to the extent of such inconsistency; and (ii) the Terms and any advertising, promotional, publicity, brochure, marketing or other materials relating to or in connection with the Draw, the Terms shall prevail to the extent that such discrepancy relates to this Draw.

- 3.6. UOB may, at any time and at its discretion terminate or suspend the Draw and/or amend any of the Terms, and all persons shall be bound by such amendments.
- 3.7. This Draw is valid in conjunction with the UOB TMRW PayNow Registration S\$8 Promotion. Unless otherwise stated, this Draw is not valid with other offers, privileges or promotions.
- 3.8. By participating in this Draw and in addition to any other consent you have already provided to UOB and any right of UOB under applicable laws, you consent to UOB and the necessary third parties collecting, using and disclosing your information (including your name and contact information) for all purposes in connection with this Draw (including for all legal purposes, identifying you as a Winner and announcing the Winners on UOB's website) and to contact you, including by voice call or text message.
- 3.9. A person who is not a party to the Terms shall have no rights under the Contracts (Rights of Third Parties) Act 2001 to enforce the Terms.
- 3.10. The Terms shall be governed by the laws of the Republic of Singapore and you shall be deemed to have agreed to submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
