

TERMS AND CONDITIONS FOR UOB TMRW Disney Adventure Game Campaign 2026

1. Definitions

- 1.1. **“Promotion”** means this **UOB TMRW Disney Adventure Game Campaign 2026**.
- 1.2. **“Campaign Period”** means the period from 31 March to 4 May 2026, both dates inclusive.
- 1.3. **“UOB”** or the **“Bank”** means United Overseas Bank Limited.
- 1.4. **“Account”** means a UOB Passbook Savings Account, UOB Uniplus Account, UOB Lady’s Savings Account, UOB One Account, UOB Stash Account and KrisFlyer UOB Account.
- 1.5. **“PayNow Transaction”** means a payment transfer made to a recipient identified by their mobile number, NRIC/FIN, UEN or Virtual Payment Address (excluding any such transfer made to Singapore Pools (Private) Limited) via the PayNow payment function on the UOB TMRW app.
- 1.6. **“Scan to Pay Transaction”** means a transaction made through NETS QR or PayNow UEN or DuitNow or PromptPay or QRIS (excluding all payments made to Singapore Pools (Private) Limited) via UOB TMRW app.
- 1.7. **“Bill Payment Transaction”** means a payment transaction including credit card payments via UOB TMRW app.
- 1.8. **“PayNow Registration”** means linking a valid UOB account with your NRIC or Singapore mobile number via UOB TMRW app.

2. Promotion

- 2.1. This Promotion is only open to existing UOB customers who are the primary accountholder of a personal Account and who have valid mobile banking access via the UOB TMRW app (an **“Eligible Customer”**).
- 2.2. By participating in the Promotion, you are deemed to have agreed to be bound by these terms and conditions governing the Promotion (the **“Terms”**).
- 2.3. The Promotion has two components, the Game and the Lucky Draw. The Promotion shall be valid during the Campaign Period.

- 2.4. To participate in the Game, you must
 - (a) be an Eligible Customer;
 - (b) successfully log in to your UOB TMRW app and access the UOB TMRW Disney Adventure-themed Bubble Quest through the Rewards+ main dashboard on the UOB TMRW app; and
 - (c) register to play the UOB TMRW Disney Adventure-themed Bubble Quest during the Campaign Period.
- 2.5. If you satisfy the requirements set out in clause 2.4 above, you will earn two chances to play the **UOB TMRW Disney Adventure-themed Bubble Quest** per day during the Campaign Period ("**Game**" and each chance to play in the Game, a "**Game Try**").
- 2.6. The Game is only accessible through the dedicated banner on the Rewards+ main dashboard in the UOB TMRW app (the "**Game Site**"). It is your responsibility to ensure that you access the Game only through the UOB TMRW app, and not through any other third party link, message, content or website.
- 2.7. In order to register for the Game ("**Registration**"), you must enter your Singapore mobile number registered with UOB and your month and year of birth ("**Participation Details**"). This Registration has to be completed again fourteen (14) days after your first Registration and then every fourteen (14) days thereafter during the Campaign Period.
- 2.8. If the mobile number you used for your Registration is different from your mobile number in UOB's records at the time UOB verifies your eligibility for the Game Cash Credit (defined below), the Game Cash Credit that you have redeemed will be forfeited. Each mobile number may only be linked to one (1) Registration or Eligible Customer. If two (2) different customers register for this Promotion using the same mobile number, only the customer who successfully completed their first valid Registration first will be eligible for this Promotion. You are solely responsible for ensuring that the Participation Details that you provide are correct, complete, up-to-date and true in all respects.
- 2.9. Once you have completed your Registration, you will be entitled to enter the Game Site and utilize the Game Tries which you have earned in accordance with Clause 2.5 above.
- 2.10. To play the Game, you are required to pop the bubbles and Disney medallions that are displayed on-screen in the Game Site during a specified time period. The popping of each bubble of a different colour and type of Disney medallion that appears on-screen during the specified time period will accrue positive or negative points as illustrated in the Game Site, which will then be added up at the end of the specified time period to generate a Game Score. The Game Score will automatically be converted into coins ("**Coins**") as per the following table:

2.11. If you obtain at least 1000 Coins during a campaign week of the Campaign Period (“**Campaign Week**”), you (“**Eligible Game Participant**”) will be eligible to redeem these Coins for S\$5 cash credit (“**Game Cash Credit**”). The campaign weeks are as follows:

- Week 1: 31 March to 04 April 2026
- Week 2: 05 April to 09 April 2026
- Week 3: 10 April to 14 April 2026
- Week 4: 15 April to 19 April 2026
- Week 5: 20 April to 24 April 2026
- Week 6: 25 April to 29 April 2026
- Week 7: 30 April to 04 May 2026

2.12. The Game Cash Credit is available for the first 150 redemptions by Eligible Game Participants during each Campaign Week on a first-come-first-served basis and while stocks last. Each participant in this Promotion may redeem multiple instances of the Game Cash Credit during each Campaign Week if they manage to obtain sufficient Coins to do so.

2.13. Coins will automatically expire and will reset at the end of each Campaign Week. Coins that are not redeemed before they expire, will be forfeited.

2.14. The Game Cash Credit may be redeemed by selecting redemption of Game Cash Credit on the Game Site, upon which you will receive a message in the Game Site stating that you have redeemed the Game Cash Credit. The Game Cash Credit will be credited to and reflected directly in your Account with the highest balance at the time of crediting (or such other account as may be determined by UOB in its sole discretion). The Game Cash Credit will be credited by UOB within six (6) weeks from the end of the Campaign Period (or such other date as may be determined by UOB in its sole discretion).

Lucky Draw

2.15. If you fulfilled the criteria under Clause 2.4 and played the Game during the Campaign Period and performed Eligible Transactions, you will earn chances (“**Lucky Draw Chances**”) in the lucky draw for this Promotion (“**Lucky Draw**”) for each Eligible Transaction (described in Clause 2.16 below) that you performed during the Campaign Period. The Eligible Transaction must be performed by 23:59 hours (Singapore time) on 4 May 2026. The Lucky Draw Chances earned from the

performance of Eligible Transactions is separate from and cannot be combined with the Coins earned from the Game for the redemption of any rewards under this Promotion.

- 2.16. The Eligible Transactions and the corresponding number of Lucky Draw Chances that you can earn from performing such transactions are as follows:

- 2.17. The number of Lucky Draw Chances that you earn from each Eligible Transaction performed during the Campaign Period computed within six (6) weeks from the end of the Campaign Period (or such other period as UOB may determine in its sole discretion). There is no cap on the number of Lucky Draw Chances that you may earn.
- 2.18. For the avoidance of doubt:
- (a) If you subsequently cancel, terminate or reverse the relevant Eligible Transaction (as the case may be), you will not be entitled to earn any Lucky Draw Chances from such Eligible Transaction and any Lucky Draw Chances which may have been earned in relation to such Eligible Transaction will be cancelled.
 - (b) If you satisfy all the conditions in Clause 2.15 above but are found to have closed your UOB Personal Internet Banking, PayNow, current/savings account within one (1) month after the Campaign Period, you will be disqualified from the Promotion.
- 2.19. The Lucky Draw will be conducted using an electronic system on 17 June 2026 (the “**Draw Date**”) at 3 PM (Singapore time) at 80 Raffles Place, UOB Plaza, Singapore 048624 (or such other date or location as UOB may determine at its own discretion). The Lucky Draw will be witnessed by an independent external auditor or public accountant appointed by UOB at its sole discretion.
- 2.20. There are a total of **163 prizes** available to be won under the Lucky Draw (“**Prizes**”) as follows:

- 2.21. A total of 163 winners (each a “**Winner**” and collectively, the “**Winners**”) will be randomly selected during the Lucky Draw. Winners will be awarded the Prizes according to the order that they were drawn as Winners in the Lucky Draw.
- 2.22. The Winners will be announced on UOB’s website within seven (7) calendar days from the Draw Date.
- 2.23. Each Winner shall be entitled to a maximum of one (1) Prize under this Promotion.
- 2.24. All Prizes won may be subject to verification of your eligibility and confirmation of your compliance with these Terms by UOB, based on UOB’s absolute discretion. For the avoidance of doubt, if UOB is unable to verify the validity of any one of the Eligible Transactions, any Prize you have won will be forfeited.



2.25. The Prizes may be redeemed as follows:

- (a) in the case where your Prize is the **3N Disney Cruise Line Deluxe Oceanview Stateroom with Verandah on the *Disney Adventure***, UOB will send an EDM (“**Redemption EDM**”) to your email address registered with the Bank within seven (7) calendar days from the Draw Date informing you of the Prize that you have won and providing details relating to the redemption of your Prize. The Disney Cruise Line Vacation Package Prizes are provided solely by The Walt Disney Company (Southeast Asia) Pte. Limited (“Disney”). The specifications of the Disney Cruise Line Vacation Package Prizes are fixed and any change to such Prizes is not permitted.

The Prize is strictly for use onboard the *Disney Adventure* and is scheduled to depart from Singapore on 7 December 2026 and returning to Singapore on 10 December 2026. The sail date is fixed and cannot be changed. If the Winner is unable to travel on the specified date for any reason, the Prize will be deemed forfeited and transfer to the next eligible winner.

This includes a **S\$60** (exclusive of GST) service charge which you are required to pay to UOB Travel Planners Pte Ltd as the designated travel agent for your redemption of your Prize.

UOB and The Walt Disney Company (Southeast Asia) Pte. Limited shall not be liable to compensate any Winner if they are unable to use the Prize, are unable/fail to make bookings via the appointed travel partner and/or agency, or in any event whatsoever.

The Disney Cruise Line Vacation Package Prizes are supplied by Disney and UOB is not an agent of Disney. Accordingly, UOB makes no warranty or representation as to the quality, value, merchantability or fitness for purpose of the Disney Cruise Line Vacation Package Prizes and UOB assumes no liability or responsibility for the



acts or omissions of Disney or any non-performance or defects in the Disney Cruise Line Vacation Package Prizes.

Any dispute regarding the Disney Cruise Line Vacation Package Prizes is to be resolved directly with Disney. UOB shall not be required to assist or act on your behalf in communicating with Disney.

For the purposes of this clause, "Disney Cruise Line Vacation Package Prizes" includes any products and/or services provided by Disney in connection with the use and/or redemption of the Disney Cruise Line Vacation Package Prizes.

The Prize is not exchangeable for cash, credit or kind, in full or in part, and is not replaceable if lost, damaged or stolen. No refund or exchange of the Prize is allowed.

UOB may substitute the Prize with any item of equivalent or similar value, without prior notice or reason or being liable to any person.

The giveaway is not sponsored, endorsed, or administered by The Walt Disney Company (Southeast Asia) Pte. Limited, or its parent, subsidiaries, related and/or affiliated companies.

- (b) in the case where your Prize is the 2nd to 163rd Prize, UOB will send an SMS ("**Redemption SMS**") to your Singapore mobile number registered with the Bank within seven (7) calendar days from the Draw Date informing you of the Prize that you have won and providing details relating to the redemption of your Prize. Redemption of your Prize from the redemption centre will commence from 23 June 2026 onwards (or such other date as may be determined by UOB in its sole discretion).

- 2.26. UOB reserves the right at any time to amend the list of Prizes and/or substitute the Game Cash Credit and/or the Prizes with any item of equivalent or similar value, in its sole discretion, without any prior notice or giving any reasons or being liable to any person. The images of any Prizes provided by UOB in connection with this Promotion, including but not limited to, in any marketing communications for this Promotion, are for illustrative and reference purposes only. The actual design, colour, size and other specifications of the Prizes may differ from their depiction in these images.
- 2.27. Details of how to redeem/claim the Prize will be set out in the Redemption EDM or Redemption SMS as applicable. UOB reserves the right to decline any redemption of the Prize if any one of the requirements set out in the applicable Redemption EDM or Redemption SMS is not met at the time of redemption. No replacement will be issued for a lost, stolen or destroyed Redemption EDM or Redemption SMS.
- 2.28. The Game Cash Credit and/or the Prizes are not transferable, exchangeable for cash, credit or kind, in full or in part, and is not replaceable if lost, damaged or stolen. No reservation, refund or exchange of any of the Game Cash Credit and/or the Prizes is allowed. Each Prize will only be transferred to the name of the respective Winner as confirmed by the Bank. The Bank is not obliged to transfer the Prize in the name of any other person.



- 2.29. Where the relevant Prize is supplied by a third-party merchant and/or supplier, then you agree that UOB is not an agent of the merchant and/or supplier of that Prize. Accordingly, UOB makes no warranty or representation as to the quality, value, merchantability or fitness for purpose of that Prize and UOB assumes no liability or responsibility for the acts or omissions of the merchants or any non-performance or defects in that Prize. Any dispute regarding that Prize is to be resolved directly with the merchant and/or supplier of that Prize. UOB shall not be required to assist or act on your behalf in communicating with the merchant and/or supplier of such Prize. For the purposes of this clause, "Prize" includes any products and/or services provided by third-party merchants in connection with the use and/or redemption of the Prize.
- 2.30. The utilisation and/or redemption of a Prize may be subject to terms and conditions and expiration dates, which shall be your sole responsibility to comply with. All Prizes which are not claimed by the stipulated redemption period (if any) will be forfeited without compensation.
- 2.31. UOB shall have the right to draw reserve Winners to replace any Winner drawn who is subsequently found to be ineligible or disqualified from this Promotion or becomes unable to collect the Prize or uncontactable.

3. General

3.1. The following persons shall not be eligible to participate in the Promotion:

- (a) individuals whose UOB account(s) is/are voluntarily or involuntarily suspended, cancelled, closed or terminated at any time;
- (b) individuals whose UOB account(s) is/are not active, valid, subsisting or in good standing or delinquent or unsatisfactorily conducted as may be determined by UOB at its sole discretion;
- (c) individuals who are mentally unsound, facing legal incapacity or are incapable of handling their affairs, deceased, insolvent, bankrupt or have any legal proceedings (or any threat) of any nature instituted against them; or
- (d) anyone whom UOB may decide to exclude, at its sole discretion, without any reason or prior notice at any time.

3.2. UOB shall not be responsible for any compatibility issues which may arise between the Game and the device/browser that you use to play the Game.

3.3. Without prejudice to any other provision in these Terms, UOB shall be entitled to disqualify you from this Promotion if you tamper or attempt to tamper with the Game,



the Game Tries, the Game results or the operation of the Game, Promotion or Game Site in any way.

- 3.4. If you are redeeming the Game Cash Credit, you are responsible for ensuring that your UOB accounts are valid and existing, not blocked from use, in good standing and conducted in a proper and satisfactory manner (as determined by UOB at its sole discretion) at the time of the crediting of the Game Cash Credit. UOB shall not be responsible for any loss or damage suffered by any person if the Game Cash Credit is not successfully credited or available for use, or if you are unable to redeem or use the Game Cash Credit. If your relevant UOB account is closed, suspended, terminated or blocked from use on or before the crediting of the Game Cash Credit to that UOB account, the Game Cash Credit will be deemed forfeited and no compensation shall be made for the forfeited Game Cash Credit.
- 3.5. If any Eligible Customer is subsequently found to be ineligible or disqualified or not entitled to participate in this Promotion or to redeem a reward under this Promotion ("**Reward**"), UOB reserves the right to, in its sole discretion, without prior notice or having to give any reason, forfeit/reclaim the Reward and award or dispose of the Reward in such manner and to such persons as UOB deems fit without any liability on the part of UOB to any persons. No payment or compensation whether in cash, credit or kind shall be made by UOB for the forfeited/reclaimed Reward. UOB shall also be entitled to, in its sole discretion and without prior notice, claim from any of the Eligible Customer's accounts a reimbursement for the value of the Reward through such modes and methods as shall be determined by UOB, including, without limitation, deducting/claiming back the same from any of the Eligible Customer's UOB accounts or otherwise. If the monies standing to the credit of the Eligible Customer's accounts are insufficient to reimburse UOB, the Eligible Customer shall immediately reimburse UOB for the value of the Reward through such means as UOB may determine in its sole discretion.
- 3.6. UOB will not be liable or responsible for any injury, loss or damage whatsoever or for any charge, cost or expense of any kind whatsoever suffered or incurred as a result of or in connection with your participation in this Promotion. Without limiting the foregoing, UOB will not be liable or responsible for any undelivered, misdirected, corrupted, lost or delayed text, transmission or transaction or any delay or failure in posting any transaction or accessing any of UOB's online banking services or mobile banking services or third-party applications, howsoever caused.
- 3.7. UOB may, at any time and at its discretion terminate the Promotion and/or amend any of the Terms, and all persons shall be bound by such amendments.
- 3.8. UOB has the absolute right and unfettered discretion to make decisions on all matters relating to or in connection with this Promotion, including but not limited to the determination of whether you have met all the requirements of the Promotion. UOB shall not be obliged to give any reason or prior notice or enter into any correspondence with any person on any matter or decision relating to this Promotion. UOB's decisions on all matters in connection with this Promotion are at its discretion and shall be final,





conclusive and binding on all parties concerned and no payment or compensation will be given or paid by UOB to any person.

- 3.9. The Terms shall be read in conjunction with the prevailing Terms and Conditions Governing Accounts and Services (Individual Customers) and any other terms that may be relevant in connection with this Promotion (collectively the “Standard Terms”). In the event of any inconsistency between (i) these Terms and the Standard Terms, these Terms shall prevail to the extent of such inconsistency; and (ii) these Terms and any advertising, promotional, publicity, brochure, marketing or other materials relating to or in connection with the Promotion, these Terms shall prevail to the extent that such discrepancy relates to this Promotion.
- 3.10. By participating in this Promotion and in addition to any other consent you have already provided to UOB and any right of UOB under applicable laws, you consent to UOB and the necessary third parties collecting, using and disclosing your information

(including your personal data) for all purposes in connection with this Promotion and to contact you, including by voice call or text message.

- 3.11. A person who is not a party to these Terms has no rights under the Contracts (Rights of Third Parties) Act 2001 of Singapore to enforce any term herein.
- 3.12. These Terms shall be governed by and construed in accordance with the laws of Singapore and the Singapore courts shall have exclusive jurisdiction over any dispute arising out of or in relation to the Promotion.

Annex A

Disney Cruise Line Vacation Package Prize Description

The Walt Disney Company (Southeast Asia) Pte. Limited (“Disney”) shall provide three (3) vacation packages (each a “Vacation Package” and collectively, the “Vacation Packages”) to United Overseas Bank. Each Vacation Package will be awarded to one (1) winner. The Vacation Packages shall consist of the following:

- One (1) three (3)-night Disney Cruise Line vacation for the winner and up to one (1) guest, to be taken aboard the Disney Adventure ship leaving on December 07, 2026, and returning on December 10, 2026. The Vacation Package is subject to the conditions set forth below.

All Vacation Packages include:

- All meals onboard the Disney Adventure (excluding specialty and fine dining);
- Pre-paid onboard gratuities for the stateroom host/hostess, dining room server, assistant server and head server; and
- Taxes, Fees, and Port Expenses (as defined on the Disney Cruise Line website).

All costs and expenses not expressly stated in the Vacation Package description above are excluded and solely the responsibility of winner or guest(s), including but not limited to:

- Travel insurance
- Laundry service
- Spa treatments
- Alcoholic and specialty non-alcoholic beverages (including specialty coffee)
- Individually charged snacks and treats (including but not limited to movie popcorn, packaged candy, ice cream, gelato, pastries, and bar snacks)
- Local and long distance telephone calls
- Ship to shore communications including internet
- Merchandise and souvenirs
- Tips and gratuities not specifically set forth above

The approximate retail value (“ARV”) of each Vacation Package is: US\$3,000 for the three (3)-night cruise on the *Disney Adventure* in one (1) **Deluxe Oceanview Stateroom with Verandah**; which includes Taxes, Fees, and Port Expenses (as defined on the *Disney Cruise Line* website). The actual value of the Vacation Package may vary depending on point of





departure and fluctuations of rates and airfares (if applicable). If the actual value of the Vacation Package is less than stated ARV, the difference will not be awarded.

Please Note Restrictions for the Vacation Package:

The Vacation Package must be booked by August 31, 2026. No changes will be made to travel details once any element(s) of the travel arrangements have been booked except in Disney's sole discretion. Accommodations are subject to availability; certain restrictions may apply. Disney reserves the right to change the travel dates, cruise ship or any other component of the Vacation Package, for any reason and in its sole discretion. No substitution of Vacation Package or any elements thereof is allowed, except at Disney's sole discretion. Ports of call, offerings and experiences onboard are subject to change, availability and cancellation without notice.
