

**TERMS AND CONDITIONS**  
**Celebrate the Arrival of the *Disney Adventure* with UOB**  
**at UOB Main Branch**  
**(26 February to 30 April 2026)**

## 1. Campaign

- 1.1 This **Celebrate the Arrival of the *Disney Adventure* with UOB at UOB Main Branch** (“**Campaign**”) is valid from 26 February to 30 April 2026, both dates inclusive (the “**Campaign Period**”). By participating in this Campaign, you agree to be bound by the terms and conditions of this Campaign (the “**Terms**”).
- 1.2 The Campaign will be held at UOB Main Branch (“**Participating Branch**”), which include:

## 2. Medallion Pin Redemption

- 2.1 The Medallion Pins Redemption is open to all UOB customers that have fulfilled the following requirements:
- a) **Step 1:** Grab a dedicated coupon from Rewards+ via UOB TMRW App (“**Medallion Pin Redemption**”). A minimum of 150 coupons will be issued every week (“**Release Week**”) on a Thursday, throughout the day and available on a first-come-first-served basis. Every UOB TMRW App user is only limited to grab one (1) coupon on every Thursday release week\_during the Campaign Period;
  - b) **Step 2:** Post an Instagram story with any of the photo points and tag **@UOBGroup** with hashtag **#UOBxDisneyCruiseAdventure**; and
  - c) **Step 3:** Walk into UOB Main Branch during branch operating hours AND request for the PIN code from the in-branch representative to successfully redeem the Medallion Pin Redemption Coupon, to receive a complimentary *Disney Adventure*-inspired medallion pin.
- 2.2 Each individual customer is only able to grab and redeem one (1) Medallion Pin Redemption Coupon.
- 2.3 Medallion Pin Redemption Coupon are available in limited quantities and will be grabbed on a first come first serve basis. Strictly no extension after expiry.

- 2.4 Each individual customer is only able to redeem one (1) *Disney Adventure*-inspired medallion pin ("**Gift**") per redeemed Medallion Pin Redemption Coupon.
- 2.5 The complimentary *Disney Adventure*-inspired medallion pin will be issued at the point of redemption only. No reservations, exchanges, or deferred collections are permitted.
- 2.6 The *Disney Adventure*-inspired medallion pin is non-transferable, non-exchangeable, and not redeemable for cash, credit, or any other item.
- 2.7 No replacement, exchange, or compensation will be provided for any lost, stolen, damaged, or defective *Disney Adventure*-inspired medallion pin.

### 3. General

- 3.1 The Bank will not be liable or responsible for any injury, loss or damage whatsoever or for any charge, cost or expense of any kind whatsoever suffered or incurred as a result of or in connection with the redemption or usage of the Gift or participation in the Campaign. Without limiting the foregoing, the Bank will not be liable or responsible for any undelivered, misdirected, corrupted, lost or delayed text, transmission or transaction or any delay or failure in posting any transaction or accessing any of the Bank's online banking services or mobile banking services or third party applications, howsoever caused.
- 3.2 The Bank has the absolute right and unfettered discretion to make decisions on all matters relating to or in connection with the Campaign. The Bank's decisions shall be final, conclusive and binding and no payment or compensation will be given. The Bank shall not be obliged to give any reason or prior notice or enter into any correspondence with any person on any matter or decision relating to the Campaign.
- 3.3 If the Bank determines that you are ineligible to participate in the Campaign or to receive the Gift under the Campaign, the Bank may in its sole discretion forfeit the Gift, reclaim the Gift or charge to and debit an amount equal to the value of the Gift from any of your accounts with the Bank without prior notice to you. If the monies standing to the credit of your accounts are insufficient to reimburse the Bank, you shall immediately reimburse the Bank for the value of the Gift through such means as the Bank may determine in its sole discretion.
- 3.4 Sending and receiving SMS is dependent on a SMS vendor, an independent telecommunication authority or service provider or such other third party which is engaged by the Bank for the Campaign and the Bank shall not be responsible for any undelivered, lost or delayed SMS sent and/or received. You shall pay and be solely responsible for all fees and charges imposed by such service providers for the sending and/or receipt of any SMS in connection with the Campaign.

- 3.5 The Terms shall be read in conjunction with the prevailing Terms and Conditions Governing Accounts and Services (Individual Customers), Terms and Conditions Governing Digital Services and any other terms that may be relevant in connection with the Campaign (collectively the "**Standard Terms**"). In the event of any inconsistency between (i) the Terms and the Standard Terms, the Terms shall prevail to the extent of such inconsistency; and (ii) the Terms and any advertising, campaign, publicity, brochure, marketing or other materials relating to or in connection with the Campaign, the Terms shall prevail to the extent that such discrepancy relates to the Campaign.
- 3.6 The Bank shall not be liable for any misinterpretation or misrepresentation of facts by any unauthorized third party in respect of the Campaign and/or the Gift offered which are published in any mass media, marketing or advertising materials.
- 3.7 To the fullest extent permitted by law, the Bank expressly excludes and disclaims any representations, warranties or endorsements express or implied, written or oral, without limitation to those published in any mass media, marketing or advertising materials in respect of the Campaign and the Gift under the Campaign including but not limited to any warranty of quality, merchantability or fitness of the Gift.
- 3.8 The Bank may, at any time and at its discretion terminate the Campaign and/or amend any of the Terms, and all persons shall be bound by such amendments.
- 3.9 Unless otherwise stated under these Terms, the Campaign are not valid with other offers, privileges or campaigns.
- 3.10 By participating in the Campaign and in addition to any other consent you have already provided to the Bank and any right of the Bank under applicable laws, you consent to the Bank and the necessary third parties collecting, using and disclosing your information (including your personal data) for the purposes of the Campaign and to contact you, including by voice call or text message.
- 3.11 The Gift is supplied by third party merchants and UOB is not an agent of the merchant and/or supplier of the Gift. Accordingly, UOB makes no warranty or representation as to the quality, value, merchantability or fitness for purpose of the Gift and assumes no liability or responsibility for the acts or omissions of the merchants or any non-performance or defects in the Gift. Any dispute regarding the Gift is to be resolved directly with the merchant and/or supplier of the Gift. UOB shall not be required to assist or act on your behalf in communicating with the merchant and/or supplier of the Gift. For the purposes of this clause, "**Gift**" includes any products and/or services provided by third party merchants in connection with the use and/or redemption of the Gifts.
- 3.12 A person who is not a party to the Terms shall have no rights under the Contracts (Rights of Third Parties) Act 2001 of Singapore to enforce the Terms.

3.13 The Terms shall be governed by the laws of the Republic of Singapore and you shall be deemed to have irrevocably agreed to submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
