Terms and Conditions for UOB FX+ Taste the World and Win Promotion

- 1.6 If you satisfy the conditions in Clause 1.4 above and answer the question about UOB FX+ referred to in Clause 1.4(b) correctly, you will be awarded with a snack of your choice, which you may select from the assortment of snacks in the SS Vending Machine ("Snack").
