TERMS AND CONDITIONS GOVERNING "SME DIGITAL LEAP AWARDS" BROUGHT TO YOU BY UNITED OVERSEAS BANK LIMITED ("UOB") AND NTUC U SME ("U SME")

1. Eligibility

- 1.1 The SME Digital Leap Awards brought to you by UOB and NTUC U SME ("Competition") is open to small-medium enterprise businesses registered and operating in Singapore which:

- 1.5 Notwithstanding anything herein to the contrary, UOB and U SME have the absolute discretion at any time and from time to time to determine the eligibility of any Participant and/or its nominated employee to take part in the Competition and shall not be obliged to give any reason.
