

Terms and Conditions Governing United Overseas Bank Limited (“UOB”) “UOB Commercial Mastercard Cards” – Rebates/UNI\$ (“Terms and Conditions”)

The Terms and Conditions herein governs the UOB Commercial Mastercard Cards (“Card”) issued by United Overseas Bank Limited (“UOB”) and are to be read together with and form an integral part of, the UOB Corporate Cardmember Agreement (Sole Corporate Liability / Joint & Several Liability) for Sole Corporate Liability or Joint & Several Liability programmes, and UOB Corporate Cardmember Agreement (Personal Liability) for Personal Liability programme.

UOB’s decision on all matters pertaining to the award or use of any or all of the benefits and privileges stated below shall be final and binding on the cardusers of UOB Commercial Mastercard Cards (“CardUsers”). The benefits and privileges described below may be amended, supplemented or revoked by UOB at any time in UOB’s sole and absolute discretion.

General – Rebates/UNI\$ Awarding

Rebates/UNI\$ will not be awarded for any bill (where applicable) or insurance payment; payment or donations to any charitable, religious, or social organizations; payment of funds to prepaid accounts, including top-ups for any pre-paid card; 0% Installment Payment Plans; UOB Business Payment Plans (if applicable); online money transfers; balance/funds transfers; cash advances; fees; interests; finance charges; late payment charges; annual fee charges; reversals; other financial charges; UOB\$ transactions and any other transactions that UOB may exclude from time to time without prior notice or giving any reason.

Without limiting the generality of the foregoing, the following transactions under bill payment and payment of funds to prepaid accounts will not be awarded with rebates/UNI\$:

UOB's decision on all matters relating to the CardUser's Card account shall be final, conclusive and binding on CardUsers.

UOB reserves the right, at its sole and absolute discretion and at any time and without giving prior notice or any reason, to vary, amend, add or delete any of the Terms and Conditions herein without assuming any liability to any person. CardUsers who continue to use the Card after the change takes effect shall be deemed to have accepted such variation, amendment, addition or deletion without reservation.

Full terms and conditions of the UOB Corporate Cardmember Agreement for Sole Corporate Liability or Joint & Several Liability programmes, and UOB Corporate Cardmember Agreement (Personal Liability) for Personal Liability

programme and any other terms and conditions for applicable privileges and/or benefits (if any) will apply and CardUsers agree to be bound by such terms and conditions upon receipt or acceptance of or signing on or use of the Cards.
