

Terms & Conditions for

UOB Lady's Credit Card Exquisite Dining Experience for Two at Michelin-starred Restaurants April – June 2024 Application Promotion

1. Promotion

- 1.1. This UOB Lady's Credit Card **Exquisite Dining Experience for Two at Michelin-starred Restaurants April – June 2024 Application Promotion** (the "**Promotion**") is valid from 1 April to 30 June 2024, both dates inclusive (the "**Promotion Period**").
- 1.2. By participating in this Promotion, you agree to be bound by the terms and conditions of this Promotion (the "**Terms**").
- 1.3. This Promotion is only open to individuals who are new to United Overseas Bank Limited ("**UOB**") credit cards.
- 1.4. To participate in this Promotion, you must satisfy all the following conditions:
- (a) you must not be an existing principal holder of any credit card issued by UOB in Singapore at the time when your Application (as defined below) is approved and you have not cancelled any UOB credit card(s) as a principal cardholder six (6) months prior to the commencement of the Promotion Period;
- (b) you must successfully submit an application for a new UOB Lady's Credit Card (as defined below) as a principal credit cardholder during the Promotion Period (the **"Application**");
- (c) your Application must be approved by UOB during the Promotion Period; and
- (d) you must accumulate a total of at least S\$1,500 worth of Eligible Transactions (as defined below) per month for 2 consecutive months on your new UOB Lady's Credit Card approved pursuant to your Application from your card approval date (the "**Qualifying Spend**").
- 1.5. UOB has the right at its discretion to approve or decline any Application and is neither obliged to give any reason or prior notice on any matter concerning the Application nor be liable to any party.
- 1.6. In these Terms, "**UOB Lady's Credit Card**" refers to any UOB Lady's World Mastercard, UOB Lady's Solitaire Card and UOB Lady's Solitaire Metal Card issued by UOB in Singapore.
- 1.7. For the purposes of this Promotion:
- (a) "Eligible Transactions" shall mean any retail transactions for the purchase of goods and/or services successfully charged to your UOB Lady's Credit Card and which are posted on UOB's systems but excluding the Excluded Transactions (as defined below).
- (b) **"Excluded Transactions**" shall mean:
 - (i) Any bill payment transactions to utilities or telecommunication providers;
 - (ii) Cash advances;

- (iii) Balance and/or funds transfers;
- (iv) Instalment payments;
- (v) Personal loans;
- (vi) SmartPay transactions;
- (vii) UOB\$ transactions;
- (viii) Any payment of fees and charges (including but not limited to annual fees, administrative fees, interest charges, finance charges and/or late payment fees);
- (ix) Any amount charged that is subsequently cancelled, voided or reversed for any reason;

- (xii) Any transactions that are subsequently cancelled, voided, disputed or reversed for any reason.
- 1.8. For the avoidance of doubt:
- (a) UOB reserves the right at any time to amend the list of Eligible Transactions and the list of Excluded Transactions in its sole discretion and without any prior notice or giving any reasons.
- (b) A merchant's registered MCC may not always correspond with its nature of business. The MCCs are assigned by the merchant's acquiring bank. UOB does not determine the merchants' MCC. UOB shall not be liable in any way whatsoever relating to the categorisation of a merchant's MCC.
- (c) Eligible Transactions made in foreign currencies will be converted into Singapore dollars based on UOB's then prevailing exchange rate applicable at the time of exchange. The transaction amount posted in your UOB Lady's Credit Card account will be used for the purposes of computing the Qualifying Spend amount for this Promotion.
- (d) Eligible Transactions charged by a supplementary holder of your UOB Lady's Credit Card will be considered for the purposes of computing the Qualifying Spend in this Promotion.

- 2.3. The Gift must be redeemed during the redemption period specified in the Redemption Notice. UOB will not extend the redemption period for any reason whatsoever.
- 2.4. Use of the Gift remains subject to the prevailing terms and conditions impose by the supplier of the Gift (or such other terms and conditions which such supplier may impose subsequently in its sole discretion), which shall be your sole responsibility to comply with.

- 2.10. For the avoidance of doubt, your new UOB Lady's Credit Card account must be in good standing at all times as determine by UOB in its absolute discretion. In the event that the your UOB Lady's Credit Card account is delinquent, voluntarily or involuntarily suspended, cancelled, closed or terminated for any reason whatsoever before you receive the Gift, the Gift shall be forfeited and you shall not be entitled any compensation or payment whatsoever.
- 2.11. UOB may at its discretion forfeit the Gift, or, if already awarded, reclaim the Gift at your expense (whether by deducting any of your UOB account(s) or otherwise) without payment, compensation, or having to give any reason whatsoever if your UOB Lady's Credit Card account approved under this Promotion is closed or terminated within nine (9) months from the date such account was opened.

3 General

- (a) individuals whose UOB account(s) is/are voluntarily or involuntarily suspended, cancelled, closed or terminated at any time;
- (b) individuals whose UOB account(s) is/are not active, valid, subsisting or in good standing or delinquent or unsatisfactorily conducted as may be determined by UOB at its sole discretion;
- (c) individuals who are mentally unsound, facing legal incapacity or are incapable of handling their affairs, deceased, insolvent, bankrupt or have any legal proceedings (or any threat) of any nature instituted against them; or
- (d) anyone whom UOB may decide to exclude, at its sole discretion, without any reason or prior notice at any time.
- 3.2 UOB will not be liable or responsible for any injury, loss or damage whatsoever or for any charge, cost or expense of any kind whatsoever suffered or incurred as a result of or in connection with the redemption or usage of any reward (including, for the avoidance of doubt, the Gift) under this Promotion or participation in this Promotion. Without limiting the foregoing, UOB will not be liable or responsible for any undelivered, misdirected, corrupted, lost or delayed text, transmission or transaction or any delay or failure in posting any transaction or accessing any of UOB's online banking services or mobile banking services or third party applications, howsoever caused.
- 3.3 UOB has the absolute right and unfettered discretion to make decisions on all matters relating to or in connection with the Promotion, including but not limited to the determination of whether you have met all the requirements of the Promotion. UOB's decisions shall be final, conclusive and binding and no payment or compensation will be given. UOB shall not be obliged to give any reason or prior notice or enter into any correspondence with any person on any matter or decision relating to the Promotion.

- 3.4 Without prejudice to any of the other provisions in these Terms, if UOB determines that you are ineligible to participate in this Promotion or to receive any reward under this Promotion, UOB may in its sole discretion forfeit such reward, reclaim the reward or charge to and debit an amount equal to the value of the reward from any of your accounts with UOB without prior notice to you. If the monies standing to the credit of your accounts are insufficient to reimburse UOB, you shall immediately reimburse UOB for the value of the reward through such means as UOB may determine in its sole discretion.
- 3.5 The Terms shall be read in conjunction with the prevailing UOB Lady's Credit Cardmember Agreement and any other terms that may be relevant in connection with this Promotion (collectively the "**Standard Terms**"). In the event of any inconsistency between (i) the Terms and the Standard Terms, the Terms shall prevail to the extent of such inconsistency; and (ii) the Terms and any advertising, promotional, publicity, brochure, marketing or other materials relating to or in connection with the Promotion, the Terms shall prevail to the extent that such discrepancy relates to this Promotion.
- 3.6 Sending and receiving SMS is dependent on a SMS vendor, an independent telecommunication authority or service provider or such other third party which is engaged by UOB for the Promotion and UOB shall not be responsible for any undelivered, lost or delayed SMS sent and/or received. You shall pay and be solely responsible for all fees and charges imposed by such service providers for the sending and/or receipt of any SMS in connection with this Promotion.
- 3.7 UOB may, at any time and at its discretion terminate the Promotion and/or amend any of the Terms, and all persons shall be bound by such amendments.
- 3.8 Unless otherwise stated, this Promotion is not valid with other offers, privileges or promotions.
- 3.9 By participating in this Promotion and in addition to any other consent you have already provided to UOB and any right of UOB under applicable laws, you consent to UOB and the necessary third parties collecting, using and disclosing your information (including your personal data) for all purposes in connection with this Promotion and to contact you, including by voice call or text message.
- 3.10 A person who is not a party to the Terms shall have no rights under the Contracts (Rights of Third Parties) Act 2001 to enforce the Terms.
- 3.11 The Terms shall be governed by the laws of the Republic of Singapore and you shall be deemed to have agreed to submit to the exclusive jurisdiction of the courts of the Republic of Singapore.

- 4.6 Reservations are subject to availability and visible on the dedicated booking page provided on your Redemption Notice. A confirmation email and SMS will be sent upon reservation confirmation.
- 4.7 Valid for dine-in only; takeaways are not applicable.
- 4.8 In the event of special occasions or blackout dates at the restaurants, alternative reservation dates will be offered.
- 4.9 Please inform the restaurant of any dietary restrictions or requirements when making your reservation.
- 4.10 Eligible Participants are responsible for any payments arising from food or drink orders outside the Bespoke Gourmet Menu.
- 4.11 Any balance payments must be made using a UOB Lady's Card.
- 4.12 The offer is valid for a minimum 9 months from the date of issue unless otherwise stated. For more information on the offer validity, please refer to the dedicated booking page.
- 4.13 Amendments and cancellations require a minimum 6-hour notice.
