1) Why is the Bank disabling your BIB access?	UOB has replaced BIB with BIBPlus, our new electronic banking platform for corporate customers.A letter has been sent to existing customers informing them to log in to BIBPlus.Customers who did not activate BIBPlus have been notified with a follow up letter on their BIB termination date.
 I still have accounts with UOB, what should I do if I still need UOB electronic banking services to operate these accounts (For e.g. transact, view statements) after 18-Jan-2018? Please ensure that you sign according your signature records with UOB. 2. Authorised Person's/Approved Person's signature is required for request for replacement of lost token and issuance of new token(s). 3. Please note each token issued is chargeable at \$20.
