Account Balance Below Threshold	 Notify me when account balance falls below the threshold amount. The threshold for notification is customisable and if not specified, will be defaulted to 8,500 units of the account currency.
Account Balance Above Threshold	 Notify me when account balance goes above the threshold amount. The threshold for notification is customisable and if not specified, will be defaulted to 100,000 units of the account currency.
ncoming Funds	 Notify me of incoming funds to account in real-time. The threshold for notification is customisable and if not specified, will be defaulted to 5,000 units of the account currency.
Debit Notification	 Notify me of funds debited from account in real-time. The threshold for notification is customisable and if not specified, will be defaulted to 5,000 units of the account currency.
