TERMS & CONDITIONS FOR UOB CASHPLUS ONLINE PREVAILING INTEREST RATE PROMOTION (1 JULY 2022 – 31 DECEMBER 2022) (THE "PROMOTION")

- 1. This Promotion is valid from 1 July 2022 to 31 December 2022, both dates inclusive (the "Promotion Period"). By participating in this Promotion, you are deemed to have agreed to be bound by the terms and conditions of this Promotion (the "Terms").
- 2. To participate in this Promotion, you must satisfy all of the following requirements:
 - i. you must not be an existing holder of a UOB CashPlus Account prior to the commencement of the Promotion Period or at the time of submission of your Application (as defined below);
 - ii. you must successfully submit your online application to open a new UOB CashPlus Account using UOB's designated online application form for this Promotion (accessible via www.uob.com.sg/cashplus (the "Application") during the Promotion Period; and
 - iii. your Application must be approved by United Overseas Bank Limited ("UOB" or "the Bank") within the Promotion Period.
- 3. UOB shall have the sole and absolute discretion to approve or reject any Application submitted in this Promotion and determine any credit limit to be accorded in connection with an Application, in each case, without liability and without the giving of any reason to any person.

 - v. any individual who is mentally unsound, facing legal incapacity or is incapable of handling his/her affairs, deceased, insolvent, bankrupt or has any legal proceedings (or any threat) of any nature instituted against him/her; or

- vi. anyone whom the Bank may decide to exclude, at its discretion, without any reason or prior notice at any time.
- 5. The Bank shall ordinarily require a minimum of five working days (excluding Saturdays, Sundays and public holidays) or such other period as the Bank may determine from time to time at its absolute and sole discretion, to process an Application. Notwithstanding the foregoing, the Bank shall not be liable for any loss or damage arising from any delay in processing any Application.
- 6. If you satisfy all of the requirements in this Promotion, you shall be eligible to enjoy the following promotional interest rate commencing from the date of the Bank's approval of your Application (the "Promotional Interest") based on your selected tenor applied for and approved by UOB in your Application submitted pursuant to Clause 2 above:
 - i. 0% interest rate for a period of 3 months with S\$50 nominal fee; or
 - ii. 0% interest rate for a period of 6 months with S\$120 nominal fee; or
 - iii. 0% interest rate for a period of 12 months with S\$200 nominal fee for approved credit limit of up to S\$10,000; or

- For the avoidance of doubt, upon expiry of the applicable Promotional Interest period referred to in Clause6 above, the prevailing UOB CashPlus interest rates shall apply.
- 8. For Applications submitted from 1 July 2022, if your Application is:
 - i. approved by UOB during the Promotion Period; and
 - ii. is not made in conjunction with UOB Balance Transfer or UOB Personal Loan,

then, subject to Clause 9 below, UOB will disburse 90% of your approved credit limit (rounded down to the nearest S\$100) in connection with your Application in cash and credit the same into your existing UOB Current Account / UOB Savings Account (as solely determined by UOB) in Singapore Dollars within approximately 10 working days from the date of approval of your Application (or such other date as may be determined by UOB from time to time).

If:

- i. you do not have an existing UOB Current Account or UOB Savings Account;

- iv. your UOB Current Account or UOB Savings Account is a joint account,

then, UOB will disburse 90% of your approved credit limit (rounded down to the nearest S\$100) in connection with your Application via the issuance of a cashier's order in Singapore Dollars to you in your name. The cashier's order will be mailed to you based on your mailing address stated in your Application within approximately 10 working days from the date of approval of your Application (or such other date as may be determined by UOB from time to time).

- 10. UOB may substitute the Promotional Interest with any item of equivalent or similar value, without prior notice or reason or being liable to any person.
- 11. UOB will not be liable or responsible for any injury, loss or damage whatsoever or for any charge, cost or expense of any kind whatsoever suffered or incurred as a result of or in connection with your participation in this Promotion. - 12. You are required to continue making the minimum monthly payments on your other bank/credit card/credit line account(s). You shall also at all times make the required minimum monthly payments on the transfer amount and all outstanding balances incurred on your UOB CashPlus Account.
