

UNITED OVERSEAS BANK LIMITED ("UOB") PERSONAL LOAN \$\$1,200 CASH CREDIT PROMOTION ("PROMOTION") TERMS AND CONDITIONS ("TERMS AND CONDITIONS")

- 1. This Promotion is valid from 1 April 2020 to 30 June 2020 both dates inclusive (the "**Promotion Period**"). By participating in this promotion, you agree to be bound by these Terms and Conditions.
- 2. To participate in this Promotion:
 - a) you must be an existing UOB Credit Card or UOB CashPlus account holder;
 - b) you must apply for a new UOB Personal Loan on your UOB Credit Card account or your UOB CashPlus account with UOB during the Promotion Period with below minimum approved loan amount (the "Minimum Loan Amount") and a loan tenor of either 36, 48 or 60-months (the "Application")

- c) if you apply for Personal Loan on both Credit Card and CashPlus account on the same day and the combined approved amount exceeds the Minimum Loan Amount, customer will be entitled to receive the Cash Credit ("Cash Credit").
- 3. If you satisfy all of the conditions in paragraph 2 above, you shall be eligible to receive a one-time Cash Credit.
- 4. The Cash Credit will be credited within 2 months from the date of approval of your Application into your CashPlus account or, as the case may be, your UOB Personal Loan account.
- 5. If you cancel your UOB Personal Loan approved under this Promotion within **12** months from the date of approval of your Application or make pre-mature repayments (whether partial or full) on your UOB Personal Loan approved under this Promotion, UOB shall be entitled to reclaim the full amount of the Cash Credit by debiting the Cash Credit from any of your accounts with UOB without prior notice or compensation.
