<u>Terms and Conditions Governing The "UOB X Shell Spend & Redeem LOQI Tote Bag or Collins</u> <u>Notebook 2019" Promotion</u>

- 1. Definitions
 - **1.1. "Bank**" or **"UOB**" means United Overseas Bank Limited.
 - **1.2. "Shell**" means Shell Eastern Petroleum (Pte) Ltd.
 - **1.3. "Promotion**" refers to this UOB X Shell Spend & Redeem LOQI Tote Bag or Collins Notebook 2019 Promotion.

1.8. "Gift" refers to the following:

2. Promotion

- **2.1.** The Promotion is open to all Eligible Cardmembers subject to the terms and conditions herein.

2.4. Qualifying Customers will be notified by UOB via SMS with redemption details of the Gift of the month by the 18th day of the following month.
