

# <u>Terms and Conditions Governing The "UOB X Shell Spend & Redeem A Free 780ml Stainless Steel</u> Double Wall Insulated Sports Bottle 2022" Promotion

#### 1. Definitions

- 1.1. "Bank" or "UOB" means United Overseas Bank Limited.
- **1.2.** "Shell" means Shell Eastern Petroleum (Pte) Ltd.
- **1.3.** "**Promotion**" refers to this UOB X Shell Spend & Redeem A Free 780ml Stainless Steel Double Wall Insulated Sports Bottle Promotion.
- **1.4.** "**Promotion Period**" means the period commencing from 0001hrs on 3 January 2022 to 2359hrs on 31 March 2022 (both dates inclusive).
- **1.5. "Gift Redemption Period"** means the period commencing from 0001hrs on 3 January 2022 to 2359hrs on 31 March 2022 (both dates inclusive) only while stocks last.
- 1.6. "Eligible Cardmembers" means customers who are valid and existing (i) Shell Escape Cardmembers or Shell Value Drive Cardmembers and (ii) Principal Cardmembers and Supplementary Cardmembers holding a personal UOB Credit or Debit Card issued in Singapore (collectively referred to as "UOB Cards" and each a "UOB Card") which is valid, subsisting, in good standing and satisfactorily conducted, as determined by UOB at its discretion. For avoidance of doubt, Shell Value Care Card, Corporate Shell Card and all commercial and business Credit and Debit cards are excluded from this Promotion.
- 1.7. "Eligible Transaction" means a retail transaction for the purchase of goods and/or services (except purchases of alcohol, tobacco and in-store service items as listed below\*) at Shell service stations in Singapore which is successfully carried out and charged in Singapore Dollars to Eligible Cardmember's UOB Card account during the Promotion Period and is successfully captured/posted in UOB's systems during the Promotion Period. Eligible Transactions exclude transactions for payments under all instalment payment plan, interests, late charges, annual fees, cash advance, balance transfers, fund transfers, instalment loans, fees and other financial charges imposed by UOB, transactions which were subsequently cancelled, voided or reversed for any reason and such other transactions as may be excluded from UOB time to time.
- **1.8.** "Shell Fuels" means Shell V-Power, Shell FuelSave 98, Shell FuelSave 95 and/or Shell FuelSave Diesel.
- **1.9.** "**Gift**" refers to the following:

#### 2. Promotion

- **2.1.** The Promotion is open to all Eligible Cardmembers subject to the terms and conditions herein (the "Terms and Conditions").
- 2.2. During the Promotion Period, one (1) sticker will be awarded to Eligible Cardmembers with every gross spend of Sixty Singapore Dollars (S\$60) on Shell Fuels and/or merchandise(s) at Shell Select convenience stores (excluding alcohol, tobacco and in-store service items as listed below\*) with a UOB Card in a single receipt (for illustration purposes, if Eligible Cardmember makes a gross spend of \$120, 2 stickers will be awarded). Issuance of stickers can only be done at the point of purchase.

## **2.3.** During the Promotion Period:

- (a) Eligible Cardmembers who collect and present all six (6) stickers on a Promotion redemption card (the "**Redemption Card**") at any Shell services stations in Singapore, will be entitled to redeem one (1) 780ml Stainless Steel Double Wall Insulated Sports bottle.
- **2.4.** Each Eligible Cardmember is limited to one redemption per Redemption Card.

## 3. Eligibility

- **3.1.** Eligible Cardmembers who made an Eligible Transaction with their UOB Cards at any Shell service stations are eligible to participate in the Promotion.
- **3.2.** The following persons are not eligible for the Promotion:
  - **a.** Eligible Cardmembers whose UOB Credit and/or Debit accounts is/are voluntarily or involuntarily cancelled, terminated, closed or suspended anytime during the Promotion Period;

- **b.** Persons who are or become mentally incapacitated, deceased, insolvent or have legal proceedings of any nature instituted against them; and/or
- c. Persons whose UOB Credit and/or Debit card accounts are not active, valid, subsisting or in good standing or which are otherwise determined by UOB in its absolute discretion as being delinquent or unsatisfactorily conducted for any reason as may be determined by UOB at its discretion.
- **3.3.** UOB and Shell reserves the right to determine at its discretion the eligibility of cardmembers and/or persons for this Promotion. The decisions of UOB and Shell on all such matters relating to the eligibility of any such cardmembers and/or persons are final, conclusive and binding, and UOB and Shell are not obliged to give any reason or prior notice.

## 4. Gift Redemption

- **4.1.** At the time of redemption of a Gift during the Promotion Period, presentation of a valid Redemption Card must be made to the cashier at Shell stations in Singapore and must be collected by the cashier at the Shell stations in Singapore upon the collection of the Gift.
- **4.2.** Shell and UOB shall be entitled to decline the redemption of a Gift if, in their opinion, the Redemption Card is or appears to be a counterfeit or altered, defaced, damaged, or tampered with (as the case may be).
- **4.3.** Gift redemption is available till 31 March 2022 or until fully redeemed, whichever comes first. Each Shell station in Singapore will have a limited quantity of Gifts. The Gifts are available on a first-come-first-served basis, while stocks last. No reservation of the Gifts is allowed.
- **4.4.** During the Gift Redemption Period, the Gifts may run out at any Shell stations in Singapore. UOB or Shell shall not be liable in any way to the Eligible Cardmembers under such circumstances and shall not be required to provide any other substitute products or be obliged to transfer stocks from one station to another.
- **4.5.** UOB and Shell reserve the right to vary or substitute the Gifts with other items at any time, without prior notice or reason or being liable to any person in any way.
- **4.6.** The Gift shown on any advertising materials is for illustration purposes only. The design and/or colour of the Gift may differ from the pictures shown on any advertising materials. The Gift is not exchangeable for cash, credit or kind, in full or in part, and is not replaceable if lost, damaged or stolen.
- 4.7. UOB and Shell make no warranty or representation (whether express or implied) on the quality, merchantability or suitability for use of the Gift. Neither UOB nor Shell shall be liable for the quality of the Gift and/or any loss, injury or damage that may be suffered or incurred by any person in connection with the Gift or the use of the Gift.

# 5. Year-long savings of up to 21.15%

5.1 Year-long savings of up to 21.15% savings for UOB One Credit Card is calculated based on 5% upfront Shell station discount, 5% upfront Shell Escape discount, 7% UOB One Card instant discount, and/or, if applicable, up to 5% UOB One Credit Card cashback.

#### 6. Participation and Personal Data

- **6.1.** Participation in the Promotion is subject to these Terms and Conditions. By participating in the Promotion, Eligible Cardmembers are deemed to have:
  - **a.** accepted these Terms and Conditions;
  - b. consented to the collection, processing, use, storage and disclosure of his/her personal data (which may include their names, mobile phone number, mailing address) by UOB, the organisers, promoters and/or their respective partners, affiliates and/or contractors for verifying the eligibility of the Eligible Cardmembers, contacting the Eligible Cardmembers regarding the foregoing, and all purposes and promotions incidental to the Promotion; and
  - c. consented to the collection, processing, use, storage and disclosure of personal data (which may include their names, mobile phone number, mailing address) by Shell, Shell's partners, respective affiliates and/or companies hired by Shell to process the data, acting strictly under the directions of Shell and in line with Shell's policy at <a href="https://www.shell.com.sg/privacy/b2c-notice.html">https://www.shell.com.sg/privacy/b2c-notice.html</a> (and as updated from time to time). #### 7. General

- 7.1. The prevailing terms and conditions under the prevailing UOB Credit Cardmember Agreement and UOB Debit Cardmember Agreement (the "Standard Terms") will continue to apply and be binding on the Eligible Cardmembers. In the event of any inconsistency between these Terms and Conditions and the Standard Terms, these Terms and Conditions shall prevail insofar as it relates to the Promotion.
- **7.2.** In the event of any inconsistency or discrepancies between these Terms and Conditions and any advertising, promotional, publicity, brochure, marketing or promotional material relating to or in connection with the Promotion, these Terms and Conditions will prevail.
- **7.3.** UOB and Shell shall not be responsible or liable for any loss whatsoever to any person in connection with this Promotion howsoever arising, including any error in calculation of the gross spend criteria for the Gift redemption.

- 7.4. UOB and Shell assume no liability or responsibility for the acts or defaults of the merchant or defects, quality, merchantability, the fitness or any other aspect of the Gifts, goods and services offered in the Promotion. UOB and Shell are not agents of the manufacturer, merchants and/or suppliers. Any dispute about the quality or service standard must be resolved directly with the respective manufacturer, merchants and/or suppliers. Any enquiries and redemptions regarding the Promotion should be directed to UOB or Shell.

UOB and Shell reserve the right at its and their reasonable discretion to unilaterally terminate the Promotion or vary, delete and/or add to any of these terms and conditions from time to time without prior notice, including but not limited to cancelling, terminating or suspending this Promotion, the eligibility terms and criteria, the redemption of the Gift, and the timing of any act to be done, and all Eligible Cardmembers shall be bound by these variations, deletions and/or additions.
- **7.8.** While all information provided herein is believed to be correct and reliable at the time of publishing or posting online, UOB and Shell make no representation or warranty whether express or implied, and accept no responsibility or reliability for its completeness or accuracy.
- **7.9.** The Terms and Conditions are governed by the laws of Singapore, and all participating Eligible Cardmembers shall be deemed to have irrevocably agreed to submit to the exclusive jurisdiction of the Singapore Courts.
- **7.10.** A person who is not a party to any agreement governed by these Terms and Conditions shall have no rights under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any terms of such agreement.
