- 1. Each Singtel Voucher will be valid for one (1) year from the date of award by Singtel. Singtel-UOB Cardmembers may make use of the Singtel Voucher by redeeming it in any Singtel Retail Shop and selected Singtel Exclusive Retailers within the Singtel Voucher validity period.
