

TERMS AND CONDITIONS GOVERNING THE UOB MIGHTY FRIDAY PROMOTION (“TERMS AND CONDITIONS”)

1. DEFINITIONS

“**Account**” means any one of the following UOB accounts which is used as a transaction account:

- (i) Checking Account
- (ii) Savings Account
- (iii) Privilege Account
- (iv) Wealth Premium Account
- (v) Credit Cards

“**Promotion**” means this UOB Mighty Friday Promotion.

“**UOB**” means United Overseas Bank Limited.

“**UOB Mighty**” means UOB Mighty mobile banking application.

2. ELIGIBILITY

- 2.1. This Promotion is open to new and existing users of UOB Mighty. By participating in this Promotion, you are deemed to have agreed to be bound by these terms and conditions.
- 2.2. Mighty Friday deals in this Promotion shall take place every Friday between 00:00 hours to 23:59 hours (Singapore time) starting from 1 January 2020 until 31 December 2020, both dates inclusive (the “**Promotion Period**”).
- 2.3. Mighty Friday deals are deals run with different merchants and shall be publicized on the particular Friday on UOB Mighty during the Promotion Period.
- 2.4. To be eligible for Mighty Friday deals, all payments or redemptions for the deal must be done via UOB Mighty (either through QR Pay or redemption through Mighty Coupons) unless otherwise stated.
- 2.5. All Mighty Friday deals are limited and quantity varies by participating merchants. Deals are further subject to such terms and conditions as may be imposed by the respective participating merchants (including but not limited to any minimum spending requirement) and you shall be solely responsible for complying with any such terms and conditions.

3. MIGHTY S\$1 QR PAY FRIDAY

- 3.1. Where the Mighty S\$1 QR Pay deal is featured as a Mighty Friday deal (the “**Mighty QR Pay Friday**”), to be eligible to participate in Mighty QR Pay Friday, you must use QR Pay by scanning the NETS QR code on your UOB Mighty App at the participating merchant’s payment terminal.

- 3.2. Mighty S\$1 QR Pay deals are awarded on a first-come-first-served basis and subject to availability. Limited to 1 redemption per customer.

4. MIGHTY PAYNOW FRIDAY

- 4.1. Where Mighty PayNow is featured as a Mighty Friday deal (“**Mighty PayNow Friday**”), if you are the first 200 participants to perform a PayNow transaction of at least S\$10 on UOB Mighty on Mighty PayNow Friday, you shall be eligible to receive a one-time S\$10 cash credit (regardless of the number of PayNow transactions made on Mighty PayNow Friday by you).
- 4.2. You will be notified if you are eligible to receive the S\$10 cash credit and the S\$10 cash credit will be credited in your UOB account registered with PayNow within 2 months from the date of Mighty PayNow Friday.

5. MIGHTY COUPONS

- 5.1. The Mighty “**Vouchers**” and “**Promo Codes**” will be made available on a first-come-first-served basis on Mighty Coupons. The Mighty Vouchers and Promo Codes must be redeemed within the redemption period stated therein and in accordance with the terms and conditions stated therein.
- 5.2. The redemption and usage of the Vouchers or Promo Codes are subject to such terms and conditions as may be imposed by the participating merchant at their sole and absolute discretion and you shall be solely responsible for complying with any such conditions.
- 5.3. The Mighty “**Vouchers**” and “**Promo Codes**” are strictly non-transferable, non-assignable and non-exchangeable.
- 5.4. The products and/or services supplied pursuant to the Vouchers or the Promo Codes are supplied by third party merchants and UOB is not an agent of the merchant and/or supplier of such products and/or services. Accordingly, UOB makes no warranty or representation as to the quality, value, merchantability or fitness for purpose of the products and/or services supplied by such merchants and assumes no liability or responsibility for the acts or omissions of the merchants or any non-performance or defects in the products and/or services. Any dispute regarding the use of the Voucher or Promo Code of the products and/or services supplied thereunder is to be resolved directly with the relevant merchant and/or supplier. UOB shall not be required to assist or act on your behalf in communicating with the merchant and/or supplier.

6. GENERAL

- 6.1. The following persons shall not be eligible to participate in the Promotion:
- 6.1.1. individuals whose UOB account(s) is/are voluntarily or involuntarily suspended, cancelled, closed or terminated at any time;
 - 6.1.2. individuals whose UOB account(s) is/are not active, valid, subsisting or in good standing or delinquent or unsatisfactorily conducted as may be determined by UOB at its sole discretion;
 - 6.1.3. individuals who are mentally unsound, facing legal incapacity or are incapable of handling their affairs, deceased, insolvent, bankrupt or have any legal proceedings (or any threat) of any nature instituted against them; or
 - 6.1.4. anyone whom UOB may decide to exclude, at its sole discretion, without any reason or prior notice at any time.
- 6.2. UOB will not be liable or responsible for any injury, loss or damage whatsoever or for any charge, cost or expense of any kind whatsoever suffered or incurred as a result of or in connection with your participation in this Promotion. Without limiting the foregoing, UOB will not be liable or responsible for any undelivered, misdirected, corrupted, lost or delayed text, transmission or transaction or any delay or failure in posting any transaction, howsoever caused.
- 6.3. UOB has the absolute right and unfettered discretion to make decisions on all matters relating to or in connection with the Promotion, including but not limited to the determination of whether you have met all the requirements of the Promotion. UOB's decisions shall be final, conclusive and binding and no payment or compensation will be given. UOB shall not be obliged to give any reason or prior notice or enter into any correspondence with any person on any matter or decision relating to the Promotion.
- 6.4. Cash credits will not be awarded to you if your relevant Account is terminated on or before the date on which the cash credit is to be made.
- 6.5. The cash credits are not exchangeable and not replaceable if lost, damaged or stolen. UOB reserves the right to replace the cash credit with another item of similar value without giving any reason or prior notice or assuming any liability to any person.
- 6.6. If UOB determines that you are ineligible to participate in this Promotion or to receive any award or benefit under this Promotion, UOB may in its sole discretion forfeit such award or benefit, reclaim the award or benefit or charge to and debit an amount equal to the value of the award or benefit from any of your accounts with UOB without prior notice to you. If the monies standing to the credit of your accounts are insufficient to reimburse UOB, you shall immediately

reimburse UOB for the value of the award or benefit through such means as UOB may determine in its sole discretion.

- 6.7. These terms and conditions shall be read in conjunction with any other terms that may be relevant in connection with this Promotion (collectively the “**Standard Terms**”). In the event of any inconsistency between (i) these term and conditions and the Standard Terms, these terms and conditions shall prevail to the extent of such inconsistency; and (ii) these terms and conditions and any advertising, promotional, publicity, brochure, marketing or other materials relating to or in connection with the Promotion, these terms and conditions shall prevail to the extent that such discrepancy relates to this Promotion.
- 6.8. UOB may, at any time and at its discretion terminate the Promotion and/or amend any of the terms and conditions of this Promotion, and all persons shall be bound by such amendments.
- 6.9. Unless otherwise stated, this Promotion is not valid with other offers, privileges or promotions.
- 6.10. By participating in this Promotion and in addition to any other consent you have already provided to UOB and any right of UOB under applicable laws, you consent to UOB and the necessary third parties collecting, using and disclosing your information (including your personal data) for the purposes of this Promotion and to contact you, including by voice call or text message.
- 6.11. A person who is not a party to these terms and conditions shall have no rights under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce these terms and conditions.
- 6.12. These terms and conditions shall be governed by the laws of the Republic of Singapore and you shall be deemed to have agreed to submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
