

## **Mighty Privileges General Terms and Conditions**

## A. Mighty Coupons

- Each UOB Cardmember can only redeem one coupon via their UOB Mighty App.
- Coupons must be redeemed within the stipulated expiry date; otherwise the coupon will be forfeited. Expired coupons cannot be replaced or renewed and no compensation or payment will be made for any such expired, forfeited or unredeemed. Coupons are strictly non-transferable, non-assignable and non-exchangeable.
- 3. Coupons are only valid for use with a valid UOB Credit and/or Debit Card issued in Singapore, except that the UOB UnionPay Card cannot be used for payment of online purchases.
- 4. Redemption and usage of coupons remain subject to the terms and conditions as may be imposed by the participating merchant at their sole discretion (including but not limited to their accepted payment mode and any minimum spending requirement).
- 5. The value of the coupons is in Singapore Dollars, unless otherwise stated.
- Coupons may be issued in the form of promo codes to be applied during checkout at the
  participating merchant's designated website. Promo codes cannot be utilised after the purchase
  is completed. Any unutilized amount of the coupon will be forfeited if not used.
- 7. Coupons are not valid with other promotions, offers, vouchers, loyalty programs and gift cards, unless otherwise stated.
- 8. Where minimum purchase amounts apply in connection with the use of the coupons, the minimum purchase amount does not take into account taxes and fees, including but not limited to shipping and handling, unless otherwise stated. The coupons cannot be used to offset any such taxes and fees, unless otherwise stated.
- 9. Complimentary items obtained using the coupons are not transferable or exchangeable in part or in kind for cash, credit or other goods and services.

## B. Mighty QR Pay

- 12. For deals involving the use of Mighty QR Pay, each UOB Cardmember must make payment using a valid UOB Credit and/or Debit Card issued in Singapore by scanning the relevant QR code on their UOB Mighty App at the participating merchant's payment terminal.
- 13. Mighty QR Pay deals are awarded on a first-come-first-served basis and subject to availability.



14. Mighty QR Pay deals remain subject to the terms and conditions as may be imposed by the participating merchant at their sole discretion (including but not limited to any minimum spending requirement).

Any dispute regarding the use of the coupon or the products and/or services supplied thereunder is to be resolved directly with the relevant merchant/supplier. UOB shall not be required to assist in communicating with the merchant/supplier.

UOB will not be liable or responsible for any injury, loss or damage whatsoever or for any charge, cost or expense of any kind whatsoever suffered or incurred as a result of or in connection with the redemption or usage of the coupons or participation in the promotion.
