We, Schroder Investment Management (Singapore) Ltd, as the manager of Schroder Active Strategies Portfolio (the "**Sub-Fund**"), a sub-fund of Schroder Alternative Investments (the "**Fund**"), are writing to inform you that the Sub-Fund will be terminated with effect from 31st December 2012.

Due to the lack of significant inflows and steady outflows, the Sub-Fund size has been falling and the total expense ratio of the Sub-Fund has been increasing over the past four years. After careful consideration, we have decided to terminate the Sub-Fund as we are of the view that the fixed costs associated with running the Sub-Fund may erode your returns in the long run.

Clause 26(B)(i) of the trust deed of the Fund dated 12 March 2004, as amended (the "**Deed**") enables us to terminate the Sub-Fund if at any time the net asset value ("**NAV**") of the Sub-Fund is less than S\$40,000,000 (or the equivalent in other currencies). In this connection, we wish to inform you that as of 31st July 2012, the NAV of the Sub-Fund was S\$11,813,802.

Following the termination of the Sub-Fund, you will be entitled to receive such amount of cash liquidation that would be proportionate to your interest in the Sub-Fund.

Should you wish to redeem your holdings of units in the Sub-Fund ("**Units**") prior to the termination, please take note of the following redemption deadlines:

If you do not wish to redeem your Units prior to the termination of the Sub-Fund, you will not have to submit a redemption request by any of the abovementioned redemption deadlines.
