## Important: Change of Name to Certain Share Classes of Fidelity Funds

We are writing to you to inform you that the Board of Directors of Fidelity Funds (the "Board") has decided to change the name of the following classes of Shares (the "Share Classes"). Our records show that you are a shareholder in one or more of the Share Classes (the "Shareholders" or "you").

On 7 March 2016 or such later date as may be decided by the Board (the "**Effective Date**"), the names of the Share Classes will change as follows:
